

Elephants Offer No Protest

Newly Named Southern Oregon Team Back in Klamath Falls Next Friday. Notre Dame System and Coaches Successful.

No word of acceptance nor protest has been heard from Southern Oregon Normal School of Ashland. Silence, apparently, gives consent, so the nickname still stands as "Elephant."

The Elephants return to Klamath Falls next Friday and Saturday to settle basketball differences with the collegiate quintet of the Multnomah club from Portland.

Their record includes two basketball victories of the now disbanded Klamath Cubs of 1933, a football triumph over the University of Oregon freshmen and another basketball win from Waldorf.

Ashland will be in the spotlight considerably this week. The high school has a two-game series with the Pelicans, and it may be that Klamath will go down to its first inter-scholastic defeat of the year.

Friday's contest will be the first away-from-home game of the year for Dwight French's boys.

The story of a crack-up in the Rockne system of football is purely a myth. The style is swinging through the country and champions, big and little, generally, in one way or another, find strength in patterning the Notre Dame attack.

If any one school in the country dominates the coaching profession, it is Notre Dame. The Rockne methods have won such outstanding applause, his pupils hold down the best jobs in the country.

There has been an abundance of changes among the coaches this year, and those chaps who came out on top were the ones who previously played for Notre Dame.

The four Horsemen of ten years ago are all in the coaching business with outstanding jobs. One, Elmer Layden, heads the lists as top man at South Bend.

It would be impossible to list all the men from Notre Dame who are leading football but just a casual survey is sufficient to show where the game gets its brains. Clipper Smith of Santa Clara, Slip Madigan of St. Mary's, Jimmy Phelan of Washington, and Gene Murphy of Columbia at Portland are all former Rockne players.

At least four of the major teams on the Pacific coast have Notre Dame coaches. Think of the great number that must be leading football teams in other sections.

The grappling profession, sprouting into a profitable occupation with the complete, though perhaps temporary, decline of the pugilism, has a peculiar effect on the public mind. It seems to cultivate "old fashioned primitive instincts" and spectators actually exert themselves as much as the athletes.

The Legion hall has built up its own list of characters. Louie Polin, merchant and sportsman, is one of the chief patrons of the wrestling game.

Louie is the appointed handler of Russian Lion Karsick in Klamath Falls, but Al or no Al, he is a front row spectator.

There is one spectator who usually takes a hand in the skirmishes that occasionally require the presence of an officer or two. He threatens the wrestlers with chairs and once dashed to the ringside to administer to or attack—his mission was a little confused—an athlete who had been thrown from the arena.

Spectators usually demand the same seats they had the week before, and it requires a diplomatic ticket seller to keep them satisfied.

The wrestlers get the blame for temperament and showmanship, but actually they can't compete with the audience.

KLAMATH DOWNS MEDFORD TEAM

Pelicans Defeat Rivals From Valley Friday, 23 To 13.

Clicking for the first time since its star player, Howard Scroggin left the line-up because of illness, the Klamath high school Pelicans downed a much touted Medford quintet 23 to 13 last night in the local high school gymnasium.

Harris of Medford scored the first field goal for the Tigers late in the third quarter and again sank a set-up shot in the final period. These were the only field goals chalked up for the visitors during the game.

Make Two Baskets
The Tigers ran up three points on free throws and Klamath scored two floor shots for the only counters in the first quarter.

The Frenchmen played defensive ball throughout and were leading 12 to 7 as the half ended. The seven points for the Tigers were made on free throws.

With both teams breaking fast the game was played at top pitch throughout. Scroggin, high point for the Pelicans, opened the last half with a dribble shot and Perry followed within a few seconds on a pass from Miller. Harris sunk the first floor shot for the Tigers during the last two minutes of play in the third quarter and Klamath led 16 to 9.

Ed Wakeman started the final period in place of Carl Egglehoff. Egglehoff made seven points in quick succession before going out and Wakeman tallied four points soon after entering.

Scroggin furnished a bright spot toward the end when he went in for Miller who was put out on fouls.

In defeating the strongly rated Medford team, Klamath stepped up from a dark horse position to a strong contender for state championship honors.

Max Schmeling Seeks New Match With Dancing Baer

NEW YORK, Jan. 20, (AP)—A refreshing young man from Germany, Max Schmeling, rolled into New York today and picked up the heavyweight business just where he left off last June.

Just turned 29 years old, a former heavyweight champion, knocked out by Max Baer in one of the greatest fistic upsets of 1933, Schmeling returned to the ring wars seeking but one thing—a chance to get another shot at Baer.

Baer Comes First
"I'd like to fight Primo Carnera and win back the heavyweight title—yes—I'd like that," he said. "But more I want to fight Baer. Then to fight Carnera—and beat him, too."

Instead of a match with Baer, the song and dance man of pugilism, Schmeling has been signed to fight Steve Hamas, former Penn State football star, in Philadelphia, Feb. 13. His manager, Joe Jacobs, is negotiating for a match with Baer in Los Angeles, outdoors, in April, and since Baer has broken off negotiations with Madison Square Garden for a title fight with Carnera, there is a chance of Schmeling getting the renewal of the Schmeling-Baer conflict.

Defeat Recalled
There's a chance, too, that Schmeling, long at war with the garden, may quash the argument and listen to overtures for a title match with Carnera in June here in New York. That would be acceptable, but nowhere near as welcome as another match with Baer.

"I was what you call—sluggish—yes, that is it, the night I fight Baer," Schmeling said. "I cannot lift my arms, everything is an effort. Nothing I do is right. But the next time, that is different."

Schmeling's return brought out a far greater turnout of the faithful than greeted Primo Carnera, heavyweight champion, when the huge Italian arrived a few days ago to start training for his title defense against Tommy Loughran in Miami Feb. 22. As Schmeling came in on the storm tossed liner Bremen last night, Carnera left for Florida to seek a training camp.

To Return to Germany
"This Loughran," said Schmeling, apparently in perfect condition and scaling his usual weight, 190 pounds, "he yumps around—sticks out lefts—he is very smart—he may beat Carnera. I see Carnera fight Paulino Uzcudun in Rome. He is still the same Carnera. He is big, he is fast for so big, but that is all. He cannot hit."

If a return bout with Baer, or a match with Carnera, fails to develop this spring, Schmeling intends to return to Europe to fight Uzcudun in Barcelona in April.

DE VORA, WOLFE WRESTLE DRAW

Bunny Martin, Substitute For Myeres, Defeats Leo Jensen

The question of supremacy between Dr. Nap DeVora of Klamath Falls and Leslie Wolfe of Texas remained unsettled last night as these two professional wrestling stars struggled through an hour of action to a draw.

DeVora, defending his championship for Klamath county, successfully stopped the young Texan's attack. Wolfe's famous rolling body scissors, the hold bringing him a majority of victories in the Legion hall arena, was useless against the European trained doctor who has set up his headquarters in Klamath Falls.

Both wrestlers were aggressive through the long match. DeVora, usually using his tantalizing "nerve tickling" methods, dropped his customary habits and stopped everything Wolfe offered. Wolfe, although unable to subdue his opponent with leg scissors, managed to hold off headlocks and hammerlocks through the vicious period of wrestling.

Three Claim Title
The match left Wolfe, recently returned to Klamath Falls from the south west, equal with Al Karasick and DeVora in the claims to the local heavyweight title.

Bunny Martin, Cherokee Indian, proved his ability in the heavyweight class by crushing Leo Jensen of Seattle in the semi-windup. Martin took the first and third falls of a three-fall match.

The first fall came in 14 minutes with a body press. Jensen, however, evaded the count with a series of whip wristlocks and a body press in eight minutes to take the second fall.

Martin a Substitute
The third fall went to Martin in six minutes following a Sonnenberg attack that sent Jensen from the ring in a groggy condition.

Martin substituted in the preliminary for Bob Myeres who was injured in a match at Medford earlier in the week.

Garden Blamed For Injuring Boxing Sport

OKLAHOMA CITY, Jan. 20 (UP)—Jack Dempsey, former world heavyweight champion, blamed Madison Square Garden of New York for "squeezing" the life out of the boxing game.

His criticism followed an announcement by Garden officials that King Levinsky of Chicago had been substituted as an opponent to meet the winner of the Carnera-Loughran fight. The Chicago fighter, according to the Garden's announcement, will appear in two "build-up" fights before being matched against the world champion.

Malin Defeats Merrill Team Friday Night

Malin high school continued its unbroken string of victories Friday night by trouncing the Merrill high school five 37-10 in a torrid game played before a capacity crowd at the Merrill gymnasium.

To make the evening unanimous the Malin "B" squad, led by Elho Reber and Clifford Rensyon, trounced the Merrill "B's" 18-4, holding them to one field goal the entire game. The Malin girls also won by a 31-9 score.

The Malin regulars clicked in clocklike fashion scoring almost at will. Coach Roland Parks used 16 boys in the two games.

BEAVERS DROP OREGON, 16-9

Basketball Rivals Even Series in Contest At Corvallis.

CORVALLIS, Ore., Jan. 20, (AP)—The Oregon State Beavers nosed out Oregon here last night, 16 to 9, in one of the lowest-scoring, tightest-guarding games in the northern division, Pacific coast conference, in years and moved into a second place tie with Oregon.

The University of Washington, league leaders with six wins and no defeats, play a non-conference game tonight with College of Puget Sound, at Seattle, while the University of Idaho Vandals invade Pullman for a conference clash with Washington State College.

McNary Sends Land Offer to Interior

PORTLAND, Jan. 20, (UP)—Senator McNary sent an offer from Eugene of land for the proposed psycho-neurotic hospital for Alaska and Indian insane to the interior department, a dispatch to the Journal from its Washington correspondent said tonight.

McNary said a similar offer from St. Helena will be submitted in a day or so.

The government is asking a site of 750 acres or more to be donated, the article said. Funds will come from PWA, involving a primary allotment of \$1,000,000 and ultimate cost exceeding \$2,000,000.
