WASHINGTON, Jan. 20.—The angry young democratic congressmen who have been ranting against the Roosevelt patronage methods are not really angry any more.
 In fact their rebellion has taken on such a tone of amiability that it can hardly be recognized any longer as a first class revolt.
 They forced the house democratic leaders to call a caucus on patronage and they were belligerent about it then. But when the doors were locked and the secret caucus discussion began, it was evident they wanted to be good fellows after all.
 Old timers swear it was the tamest party pow-wow held in a long time.

WHEELS
 Those who know how the house wheels go around say the metamorphosis wrought by the new members is more than Joe Byrns, experienced floor leader.
 He noted that many of the new members elected in the Roosevelt sweep, a good many from normally republican districts in the north, middle west and Pacific region. The southern and experienced party men generally kept their shirts on.

Mr. Byrns is supposed to have gone to each of the newcomers and said, in a fatherly tone, approximately this:
 "Do you think you are sitting in the house today because you are a great man? No! You were elected in 1932 because Mr. Roosevelt was a great man.

Yes, We Have Politics

AFTER the comparatively quiet political situation of 1933, this year with its primary and general elections promises plenty of smoke and noise. By the end of another month, attention of the community will be pretty well centered on the May primaries, and from that time on the harassed voters will be given the works.

This year's political situation will stay pretty well within state limits, as compared with that of 1932 when Herbert Hoover and Franklin D. Roosevelt were fighting it out on the national front. This year, the governorship will be the burning outside issue that claims the interest of Klamath voters. There will be no U. S. senatorial election, but here in the second district there is promise of fireworks on the congressional front, a fight which may be affected by popular attitude toward the national administration.

Here at home, city campaigns are deferred until November, and primary election interest centers on the selection of men for state representative and for county offices. The sales tax is potentially the most controversial measure scheduled for the ballot, and this angle may have some influence on the legislature race, both incumbents having given the sales tax their vote at the special session.

Not much attention thus far has been given to the fact there is to be an opening in the county court, the importance of which should not be overlooked. From the members of the local bar must be drawn recruits for the district attorney and circuit judge races, and willingness to run for these offices seems to be quite general. The assessorship is the other county job that the voters are to fill.

Without mentioning any names, that is a view of the political vista now opening before us. Beyond the next fall lies the fall general election, when there will be a runoff between the winners of the primary vote as well as municipal campaigns, and the bare possibility of a ballot on the district senatorship.

Discrimination and caution will be, as always, the prime requisites of the responsible voter in the coming elections. Nineteen thirty-two offered unusual opportunity for second-raters and upstarts everywhere. In some cases, selections that looked pretty bad just after that mad scramble, haven't turned out that way, and in others the fruits of hit-or-miss protest voting are quite apparent.

Battle Of The Giants

THE asinine trivialities that have a part in the controversy between the two highest Oregon state officers are indicated in the most recent flare-up over dim typing on some bonds.

Governor Meier, says this important bit of news, sent the bonds back to Treasurer Holman's department for retyping. Holman, offended at this piece of brazen effrontery, refused to have the job done. Breathlessly, we await the outcome of this struggle of the giants.

Still, no telling what may be the consequences. H. G. Wells, in his recent book on things that haven't happened yet, has a defective dental plate owned by a Polish Jew causing the next great war. The Jew's facial contortions are misconstrued by a Nazi soldier, and things begin to happen.

The adolescent bickering down at Salem may portend something serious, at that. Let's hope it's nothing more serious than, for instance, a fight between the governor and treasurer for the same political office, which would have some entertaining features.
