A Wholesome Aspect

THE civil works program, beneficial as it has been to this community, has carried with it disappointment for many people who need work and want a chance. Within the limits of appropriation, it was of course not possible to supply jobs to every man out of employment, and government restrictions have prohibited spreading the work to any great extent through rotation.

This has led to a certain amount of misunderstanding and resentment. A jobless man sees his neighbors get steady work from the government, and he wonders why he is not permitted to share some of the wages handed out. The unemployed man has no idea of the rules and regulations handed down from Portland and from Washington, and his inclination may be to blame local officials for things over which they have no control.

It should be noted, however, that what clamoring there is of this sort has a definite wholesome aspect. It indicates that men want a chance to work. It shows they would rather work for wages than accept a straight dole from the relief agency. That is mighty important.

It appears probable the civil works program will be extended, at least to May 1. Season employment, and the starting of public works projects, such as the Klamath armory here, may improve the employment situation materially by that time.

Eyeing the Governorship

SAM BROWN, Gervais sausage maker, is on his way as a gubernatorial candidate on the republican side. Governor Meier himself heads a long list of possible republican candidates who haven't announced as yet.

Time was when most of the interest in any kind of an election in Oregon centered chiefly on the republicans. Not so today. While the democrats swept to power in the 1932 elections the country over, their victory was not quite complete in Oregon, and 1934 offers them opportunity to capture several important offices if they have the strength. What they do in the primaries, when the fight must be within the ranks of the party, will give some indication of what they may be able to accomplish in the fall.

Chances are increasingly strong that Mayor W. E. Mahoney will seek the democratic nomination for governor. The news is he is to announce in mid-February. Reports are going the rounds that both political and financial support for Mahoney are being built up. The possibility that the mayor will run for second district congressman can be eliminated. If he runs for an outside office, it will be for governor.

Some observers have it that political technique requires that Mahoney run for a higher office this year. They say that when a man is on the make, politically, he must keep going. Sentiment that rolls up in his behalf may flatten out permanently when he drops into the background for a couple of years. Take that theory for what it may be worth, add to it the facts that this is supposedly a democratic year, that conditions are such as to offer special opportunity to the Mahoney type of campaign, and that the mayor has bid for statewide attention through such activities as the Knox bill fight, and you have the makings of pretty strong talk that Mahoney will be in the race.

MINISTERS FAVOR CLOSING STORES

At a meeting of the Ministerial Association on Monday the following resolution relative to the local NRA schedule of hours for the grocers of the city was adopted.

"This association is informed of the proposed action by the retail grocers of the community, under the NRA regulations, concerning the adoption of a six-day week schedule which would make possible the closing of all grocery establishments on Sundays. We are heartily in favor of this proposal as in keeping with the shorter hour plan of the national recovery act, and at the same time making possible the one day a week rest for all concerned. We urge favorable action upon this proposal by all the managements involved in this community."

The same proposal was presented in the Men's Monday club in which churchmen of the community meet at luncheon each week in the First Presbyterian church. The favorable action of this group of laymen on the resolution was unanimous. A 75 per cent favorable vote of all grocers of the community is necessary under the code in order to put the maximum labor hour schedule into operation.

is short this year. So buyers are bidding up.

In addition, a little money is beginning to be available for speculation, and a few speculators are getting into the market in a small way.

Some storage is reported to be going on in San Francisco, thus preventing offerings from being thrown indiscriminately on the retail markets.

It is probable that as the season goes on the shortness of

the potato supply will be more and more apparent, and a few well-informed persons see the possibility of a runaway market by late spring, with prices going exceedingly high.

This, of course, depends on the rate at which potatoes go into consumption—that is to say, on whether or not people continue to buy freely with prices advancing.

If they do, the price will undoubtedly go rather high.

THIS writer, for one, hopes there will NOT be a runaway market with prices sky-rocketing.

That would start everybody in the country to planting potatoes next year, and it would take us three or four years to work out of the over-production that would ensue.

For districts such as this, where potatoes are an important commercial crop, a FAIR price is far better in the long run than an occasional EXCESSIVE price that stimulates heavy planting all over the country.

The Inside Story From The Capital

WASHINGTON, Jan. 23.—No one actually believes Mr. Roosevelt is going on that semi-world cruise this spring—except Mr. Roosevelt.

Even the inside crowd thought he was spoofing when he talked rather indefinitely about it recently. They refuse to believe the president really intends to go off gallivanting on the sea for six weeks or two months in times like these.

The newsmen thought the idea so preposterous they played the story weekly. Some gave it only a few paragraphs.

The story behind it is of more importance and significance than the headlined gold bill.

PLANS

Preposterous or not, he is going. The navy already is laying plans. He intends to leave within a week or two after congress adjourns. He will certainly visit Puerto Rico, the Panama canal, Hawaii, Los Angeles, San Francisco and Seattle. He has an idea that he will also go to the Philippines, but he probably will be talked out of that.

That is why the \$20,000 traveling allowance of the president was boosted to \$25,000 in the budget without explanation.

HINTS

This news means a lot to sharp eyed business men and Wall Streeters.

It confirms the idea that Mr. Roosevelt is scheming to get rid of congress sooner than congress now suspects. To do that he will need congress very few legislative ideas to chew on. He will try to hold the program of the session to emergency essentials and appropriations. Further, general reform legislation will wait until next year.

The president has an idea that by recommending only a few things he can induce congress to adjourn around April 1. The congressional leaders say June 1, but the president probably knows more about that than they do. It would be too hot to make the southern cruise in June.

SAILING

The plan also confirms the growing suspicion that Mr. Roosevelt is going to let his new deal drift along in its present tack. No important new post-congress developments can be in his mind or he would not be planning such an extensive ocean joy-ride.

The deduction up with the fact that he is going to feed congress very little before it adjourns and you can not get the general outlines of his course for at least the next six months.

The inside crowd believes the business improvement tide will carry along until summer. They are confident the economic situation will not need any more presidential hypodermics until then.

FINANCING

Expectations of spring crisis in government financing are fading out already.

Mr. Roosevelt has been much more worried about that question than he has let on. It was supposed to have been the main subject discussed (Saturday) when federal reserve bank governors met here.

At that meeting the governors decided to go along with the government financing program in a cooperative manner, inasmuch as Mr. Roosevelt is giving them 50 per cent stabilization of the dollar.

They will be the sales agents for the new billions of government securities.

If they cooperate, we will not have much of a crisis.

discerned also in the Eastman railroad report to congress.

That report hardly said anything except that Coordinator Eastman and Mr. Roosevelt had nothing to say now.

The rail situation will be permitted to drift as is, with the cutting salaries. It violates the spirit of the new deal, but apparently the big thinkers of Washington figure it is best to get workers out of that industry into others and put the railroads on a stable basis.

General reorganization legislation will wait until next year.

SMARTNESS

Every time Treasury Secretary Morgenthau's name was mentioned in the senate gold hearing, Senator Glass interposed with, "and he is not a banker."

The main objection brought out in the house gold debate was that Morgenthau should not be entrusted with such powers because he is a novice in international finance.

Senator Glass and the house objectors are all correct. Morgenthau knows little about banking, government finance and foreign exchange. But, he is smart enough to know he is no expert and he hires men who are.

For instance, Earl Baillie is supposed to have gone back to New York. His resignation as assistant secretary took effect legally on January 15. Actually he has not given up his job at all. He knows how to handle government financing and Morgenthau is secretly keeping him around for that purpose.

Baillie sat in at the reserve board governors meeting on that subject although he was legally a private citizen.

The exchange phengaling also will be done in Morgenthau's name but some expert on the subject (probably Kent) will handle the job.

LAKEVIEW HOPES FOR AIRPORT WORK

LAKEVIEW, Ore.—It is likely that the federal government will improve the local airport at the Round-Up grounds. A map of the property was forwarded this week to the CWA headquarters in Portland. The land is owned by the Lakeview Round-Up Inc. The present airport has accommodated as many as 25 planes at a time. The government is anxious to have an improved airport here. The local field was free from fog two weeks ago when a blanket of fog covered the coast and Klamath Basin.

A short time ago the community was requested to furnish a site one mile square a short distance west of the city. An investigation of the title revealed that the county owned one half of the premises while the balance is owned by several hundred persons scattered throughout the United States who purchased small lots during the land boom of 1908 and who have paid their taxes ever since in hopes that the property would some day be of value. It would take several years to clear the title to that property.

After losing five of the first ten men because of sickness and grades, Lakeview's first team, made up of sophomores and juniors, took Silver Lake 31-4. Carter Fetsch, a sophomore, was the point man with 16 points to his credit. The team of Silver Lake won 12-10. Next week Lakeview plays New Pine Creek and Paisley.

The first sale of wool announced to date in this locality was the State of 4,000 pieces by Low McCulley of Surprise Valley to Draper and Co., at 25 cents per pound.

Jess Valley Road Work Progresses

LIKELY, Calif.—A force of local men employed by the U. S. forest service under CWA are working under the supervision of Road Foreman Ben L. Johnson in reconstructing the road from this place to Jess Valley, following the South Fork of Pit river for a distance of 15 miles. This road which is the main county thoroughfare for stockmen of the Jess Valley section and has become popular in recent years with tourists and fishermen, "just grown" in the past couple of decades from a saddle-horse path but government surveyors say that the original grade is an ideal one. The route is one of the most scenic in Modoc county.

A rich strike of cinnamon ore was discovered this week on the Currier ranch about 40 miles north of Lakeview. Assays made revealed that the ore will run about \$400 to the ton. The ledge was encountered about 70 feet from the tunnel entrance. It is expected that a second ledge comparable to the first in richness will be found following the removal of this ledge. The first ledge lies in a vein of chalk rock which is hard enough that no timbering is required yet soft enough that the cinnamon can easily be removed.

A large retort from the Willow Ranch quicksilver mine has been removed to this mine to speed up operations.
