

KING ALBERT OF BELGIUM DIES IN FALL

Brussels immediately, arriving here early today.

Throng Mourns

The crown prince and princess, the former Princess Astrid of Sweden, 28 years old, hurried to the royal castle at Suburban Laeken.

Like Queen Elizabeth, prostrated by grief, the prince and princess remained hidden today in the castle behind the guarded, grilled fence, while a throng milled soberly about outside.

The first important ceremony during the period of mourning, which will continue until after the funeral, will be the removal of the body to the royal palace in Brussels tonight.

Funeral Thursday. The body will be borne on a caisson between solid walls of war veterans along the route through the city—war veterans who remember the great figure of a man six feet two inches tall who risked his life almost daily to be close to his soldiers during the trying days of the World war.

The body will lie in state at the palace until Thursday when it will be taken to the Saint Gudule cathedral. Interment will be in the Royal Crypt at Laeken.

How the widowed, 58-year-old Queen Elizabeth was holding up under the sudden sorrow could not be learned today. Since the first outburst of passionate distress in the death chamber where she knelt weeping beside the body she has passed the time in privacy.

Son With Queen. Only the second son, Prince Charles, was with the queen until last midnight when Prince Leopold and his wife arrived from Switzerland. Their sorrowful meeting took place in the queen's private apartments in the palace at Laeken.

For the next three days, the crown prince and princess are expected to maintain privacy as far as possible—the princess particularly. It is unlikely that she will appear in public.

Prince Leopold will take the oath of fidelity to the constitution before a joint meeting of the chamber and the senate Friday. Afterward, he will be proclaimed king and, with completion of that act, Princess Astrid automatically will become queen.

In the castle awaiting removal to Brussels, the body of the king lay today in a bed of rosewood, strewn with white lilies, a heavy bandage around the head.

The face was unmarked, except two cuts over the right eye.

CHURCHES PREPARE FOR IRISH TRIO

C. R. Williams Answers Recall

recall was "Malfeasance in Office," which Mr. Irwin defined as "the doing of acts which he ought not do at all."

"The law says that a person is guilty of malfeasance in office if he shall willfully neglect or refuse to perform any duty or service to which he is legally entitled, or shall willfully neglect or refuse to perform such duty or service to the injury of any one or the manifest hindrance or obstruction of public justice or business."

The law states that punishment shall be imprisonment in the penitentiary, or in the county jail, or a fine, or dismissal from office.

"This is a crime subject to indictment by the grand jury, if it can be proven by evidence acceptable to court of law, instead of by the whippers of an irresponsible and disgruntled minority. I personally would welcome the fullest and most searching investigation by the grand jury of this county of any charges which Mr. Irwin has sufficient legal knowledge and evidence to lay before them, and I ask Mr. Irwin to lay his charges if he has any, before the grand jury in this fashion."

My object in making this request is two-fold:

"First, if I belong in jail, I want to go there as soon as possible and get it over with."

"Second, a substantial saving to the taxpayers of this county would be made if the salaries of employees of the county clerk's office, who have been so thoroughly occupied searching the records for evidence of malfeasance would divert their attention to bringing the monthly statements of public expenditures up to date, thus enabling the county court to determine which departments had exceeded their budget allowance. This information was not presented to the court during the months of November and December, resulting in some departments exceeding their budget allowance. The taxpayers are paying for this service and should receive it."

"If the three members of the county court are guilty of malfeasance, a grand jury indictment will promptly dispose of the case without the expense of a recall election. If they are not guilty of malfeasance in office, Mr. Irwin should no longer neglect his law practice in an effort to save the voters and taxpayers from themselves."

"Mr. Irwin and his twelve disciples, by attempting the recall of Judge Grizzle and Commissioner Chase, are admitting that they were mistaken in their men in the election of 1932 and that they cannot make good on their promises to the voters of this county."

"The voters should seriously consider:

"First, whether or not Mr. Irwin and his disciples were wrong in 1932."

"Second, whether or not Mr. Irwin and his disciples were wrong in 1934."

"And third, whether or not Mr. Irwin and his disciples were wrong both times."

and 86 agencies. Licenses for sale of beer and wines under 14 per cent alcoholic content, must secure permission from the city council or county court, and these authorities may collect \$5 each for official permission, the speaker declared.

Sammis said he represented the "most sorely tried group of men in the state—the three commissioners." He urged forbearance of the public until operation has been in progress during which time many problems could be worked out. One of the chief problems, he said, was to stamp out the bootlegger by holding prices down, and yet at the same time provide a profit to all the people, which they have a right to expect.

ments were for. Brown said he could not remember exactly.

Claim Allowed He added, however, he put up the collateral in the 1928 account, but did not recall the amount. If this was sold the next year, he said, Bagley "sold it and gave me the money."

Brown testified Bagley and a man named Withersford had "gone around the country" looking up desirable postoffice sites.

He agreed that a claim of \$1,000 for expenses had been partially allowed Withersford against the Bagley estate, of which Brown is residuary legatee.

Asked if he knew a man named Walter Ballard, Brown said he did, that he had some claims on the Bagley estate as a result of a mutual interest with Bagley in a chemically treated wood that would resist fire.

He said he believed some of the wood was used by the New York Shipbuilding company on the steamship Manhattan.

He added he knew nothing about a contract for \$500,000 which Black said was made between Ballard for the Henry Klein company, which produced the wood, and the ship building company.

LUMBER RULING PROTESTED HERE

Reports that restrictions are contemplated for inclusion in the NRA lumber code which would prohibit the establishment of new mills or increasing machinery in present plants, without approval of the code authority, resulted in protesting telegrams going to Washington from here Monday.

Richard H. Hovey, Klamath timberman, in a wire to General Hugh S. Johnson, NRA chief, declared the ruling would tend to confiscate large timber holdings that must be liquidated on account of carrying charges and beetle infestation.

"There is no justification for this move which would put all large owners with small or no mill connections at the mercy of mills without timber connections," Hovey declared in his message to Johnson.

It is understood here that the action has not actually been taken at this time.

A city stamp tax on beer and wines under 14 per cent alcoholic content will be continued in Klamath Falls according to a decision made at a conference held by Mayor W. E. Mahoney and local wholesalers Monday morning.

The tax will be slightly lower than heretofore, according to Mahoney, who announced the new schedule as follows: on a quarter barrel of beer, or less, the tax will be 25 cents; on a half barrel, 50 cents, and on a 31 gallon barrel, \$1.00. On bottled beer the tax will be one cent for a quart and 1-2 cent for a pint.

For light wines the city tax will be 6 cents a gallon.

This tax schedule will be presented to the city council tonight in the form of an ordinance, Mahoney stated.
