Why Not Build It?

WE devote a lot of scheming and effort to get the federal government to do this and that to promote employment in Klamath Falls. Why not go to work on private businesses which could well be interested in extending their physical facilities in this community?

For instance, there is the large and prosperous Pacific Telephone and Telegraph company, which is affiliated with the large and prosperous American Telephone and Telegraph company.

The telephone company in past years has flirted with the idea of constructing a new building here. It went so far at one time as to acquire a site and ship in some steel. But that was as far as the building program got.

If there was a question as to whether Klamath Falls was going to go up or down, it would seem that it has been answered in the past couple of years. The depression has been weathered and this city is on its way.

When the telephone company went so far as to acquire a site and ship in steel, it admitted the necessity or near-necessity of erecting a building here. Certainly similar conditions must exist today.

It is the custom of the telephone company in larger centers to erect a building to house its offices and operating facilities. Materials prices are rising at this time. The community would welcome the employment provided in a building construction program of this sort.

Seeing Through It

IT IS quite generally agreed that the coming elections have provided the motivating influence in recent congressional action on the bonus and the independent offices measure providing bigger veteran allowances. Senators and representatives up for election are believed by most observers to be playing for the veteran votes.

And yet there are evidences that the veterans are beginning to see through the old army game the politicians are playing. One active Klamath veteran said as much to this writer yesterday. He made some heated statements about Congressman Pierce and his recent vote on the bonus that don't look so good for Mr. Pierce if there are similar views held by very many of the ex-service men of this district.

The politicians, of course, work on the theory that a compact organization of voters the size of the veterans group is a prime importance at election time. It may be the minority, but the majority is unorganized. By pandering to the vote of the compact group, one can hope to get enough of the rest of the votes to win success.

Hence, we see congressmen, pledged to support the president, refusing to support him, even in the face of a sincere and common sense statement such as the independent offices veto message.

And yet, all this may not turn out as expected at election time if there are many veterans who, like our Klamath friend, point out that it is all right to depart from the president's support on the basis of conscientious conviction, but not on the basis of a selfish and insincere gesture designed to garner votes. The veterans, after all, represent a section of the finest American citizenry and, by proof of past performance, in the last analysis will go the limit for the common welfare.

Penalty and Poverty

ONE reads with a certain sardonic interest that Martin Insull, one-time Chicago utilities magnate, went on a hunger strike shortly after he had been locked in jail at Toronto, where he was being held for extradition to the United States.

The food, it seems, wasn't quite up to a utilities magnate's standards. For breakfast there was porridge, buttermilk bread and sugarless tea; for dinner there was stew and cold water; for supper, rice, bread and tea.

All this is rather plain fare, especially for a man used to the best food that money can buy. It is hard to blame a man for refusing to eat it; and doubtless it is only human perversity that reminds one that it might seem like a feast to some luckless old person who invested, and lost, all his life's savings in Insull securities.

The Inside Story From The Capital

WASHINGTON, March 29.—The secret of the automobile strike settlement lies in the weakness of the union.

Labor leaders talked big but they could not cover up their unfavorable inner condition. They did not have as many workers as they said, or any of the highly skilled workers. No one mentioned that fact but the employers knew it. So did President Roosevelt. The result was that labor got probably as good a settlement as it could expect, but it did not get what the A. F. of L. wanted.

Those who know the inside of that game say the A. F. of L. will never be able to organize the industry strongly under that settlement. They expect the ultimate outgrowth will be an entirely NEA labor union setup based on separate craft guilds (vertical unions) rather than blanket unionism under the A. F. of L. system.

That is what Mr. Roosevelt had in mind when he spoke about "a NEA course in social engineering" and "a new kind of works council in industry."

PERTURBATION
The A. F. of L. crowd caught the hidden implication. So did Senator Wagner. He was considerably perturbed, although he did not let the White House know about it.

The general interpretation was that Mr. Roosevelt was sending up a trial balloon for his guild council idea and that he would not press it if the reaction was bad. Immediately a rush was started backstage to guarantee that the reaction would be bad.

William Green issued a statement saying the automobile strike settlement made it absolutely necessary that the Wagner industrial disputes bill be passed. Indeed it did—from his standpoint. The Wagner bill would kill the guild idea. It would abolish the company union, strengthen the A. F. of L. system.

That is the game now—to force passage of the Wagner bill and squelch the guild idea.

PROSPECT
Those who have seen President Roosevelt work from the inside are sure he will consent. He did not go out far enough on the craft guild limb to be embarrassed, no matter which way the wind blows. Also he has publicly endorsed "the general theory" of the Wagner bill.

It is true his crowd has never played in very closely with the A. F. of L. boys. There has been some private grumbling among the higher-ups about the A. F. of L. leadership. They seem to be a little doubtful about each other under the surface, although they get along all right on top.

Stripped down to its roots, the automobile agreement appears to mean the president has settled the automobile strike, but nothing else.

The larger questions will have to be settled when the details are worked out.

LAWYERS
They are calling in the lawyers down at the NRA. That always means trouble.

Within the last week about 25 lawyers have been hired, so many that space in an outside building had to be rented for them. They are to serve in the trial section of the code compliance division.

Counsel Richberg has been in charge of setting up the new organization.

The implication is that the NRA is soon going to be hell-bent for enforcement of the codes.

MOULTING
Other evidence indicates the Blue Eagle is undergoing a general moulting and getting some new features.

Division Administrator White-side pulled out half the conservative plumage when he left. He was in charge of more of the

real inside business than anyone else. In recent months no love was lost between White-side and General Johnson, largely as a result of a personal matter.

Leo Wolman has been hovering half way in and half way out. Senator Wagner had pleaded with him to stay, but his position is mildly embarrassing since the justice department took the Wolman case to the courts.

Wolman was always doubtful about the government's legal grounds and he thought it would be safer to keep the matter out of the courts.

TAILFEATHER
The big Blue Eagle tail feather seems to be growing again. Everyone has been talking about General Johnson getting out for nearly a year now. He has denied it at least fifty times, the last time last week, and people are beginning to believe him.

The situation has worked around to where he cannot quit. No one knows enough about the job to take his place.

NOTES
Clarence Darrow's administration of the NRA review board is considerably duller than any of his previous appearances. The board has not developed anything new since it started. Darrow conducts it like a court, issuing quasi-subpoenas, excluding some evidence, etc.

Wise anti-administration sources declined to take up the Rand-Wirt charge about a brain trust plot, believing it would surely prove to be a dud.

Insiders say red tape has increased about 100 per cent in the NRA since the inner reorganization because the reorganized outfits are slow dovetailing their business.

The National Association of manufacturers put over a fast one on Senator Wagner. Arrangements were made for their James A. Emery to broadcast his testimony against the bill by radio. None of the advocates of the bill had their testimony broadcast, and Senator Wagner is growing.

The idea is that Thomas Jefferson Coolidge is to be made under-secretary of the treasury by degrees. Secretary Morgenthau was bitten once by senatorial objections to Earle Baillie, so he is not going to appoint a new under-secretary until senatorial objections to Coolidge have had a chance to develop.

On Good Friday the Mass of Presanctification will begin at 8:00 o'clock, preceded by the unrolling of the Cross at Sacred Heart church. The three hours of agony of our Savior will be commemorated in the church from 12 noon until 3:00 o'clock.

Rev. F. L. Gels will preside for the first hour, Rev. Fabian Reynolds, O. M. Cap., the second hour, and Rev. William Kennedy will preside for the third hour. The services will end with the Way of the Cross.

Chamber Delays
Action on Plan
Reducing Rates

At the weekly meeting of the chamber of commerce directors on Wednesday, a resolution was offered by R. C. Groesbeck favoring relief of the railroads from the long and short haul clause of the interstate commerce act and permitting the railroads to make a lower rate for a longer haul than for a shorter one, in order to compete with the boats for transcontinental traffic.

After considerable discussion, based on the probable effect of the change on the industries and prospects of the Klamath country, action on Mr. Groesbeck's resolution was postponed until the meeting of the directors next week, when it will be made a special order of business.

The directors adopted a report of the legislative committee favoring naval armament up to treaty strength and maintenance of a small army to serve as a nucleus in time of war. The report of the committee, of which Arthur Schupp is chairman, was on a referendum in the Chamber of Commerce of the United States.
