speed with which he is stumping the state for the democratic nomination.

Before the meeting the mayor said that everything is looking good, and he has been gratified by evidence of support in every city and community he has visited.

Campaign at Peak

There is considerable belief that the Mahoney campaign has reached the peak of its strength at this time, and while the mayor did not say so, he is probably hoping he can now hold what he has gained, and that that will be enough to nominate him. He Moore, of the Oregonian, in his Sunday political article, cited this opinion, and reported also that Martin headquarters have completed a survey indicating Multnomah county is going to back the general.

One of the hazards of the Mahoney campaign was that it would come to a peak too fast. Whether it has done that is hard to tell. There is plenty of wish-thinking in all campaign opinion. One thing, however, is quite certain and that is that in Klamath county there is almost no work going on for Mahoney, and the first flare of enthusiasm seems to have died out.

Apparent failure or the recall is a development in the political situation. Only 18 days remain before the primary election, and failure of the recall movement to file any sort of petitions except the original notification some time ago, is seen as an indication that this movement has dropped out of the political picture.

Almost to the man, the candidates speaking at the Veterans' Political League meeting Sunday told of their interest in veterans' welfare. Those who had war experience cited it, and most of those who had not told why.

Mayor Mahoney told the veterans he had made 23 speeches since Monday evening. He cited that in five out of six payroll appointments granted him as mayor, veterans got the jobs. He attacked the three large power companies operating in the Portland area, asserting they are controlled by the House of Morgan. The mayor gave his platform, and said he was going to get the money for such projects as a public works program from a distribution of wealth through capital levies, higher income taxes and a high inheritance tax. He asserted he kept his majority promises "implicitly."

Harry Bolvin, democratic candidate for the legislature, declared he had no personal ambitions about legislation except to serve the whole of Klamath county and the state. He said if elected he will try to come back during the session to learn the sentiment of Klamath people on proposed legislation.

George Christain, democratic candidate for district attorney, cited his previous experience in county offices. He emphasized his plans to give sound legal advice to all the county offices.

Edward B. Ashurst, candidate for circuit judge, read his campaign statement and discussed the veteran situation. He said veterans had not gotten a square deal, and that he, a veteran, could vouch for that from personal experience.

Judge W. M. Duncan said he was not a veteran, but an admirer of veterans and their organizations. He cited a case in which a veteran was convicted of second degree murder in his court, but that he made arrangements for sending the man to a veterans' home for the mentally infirm instead of the penitentiary. The judge said his past experience would be a valuable asset in another term.

D. E. Fletcher, running for circuit judge, told how war had affected his welfare through his father's injuries in the civil war. The speaker told how he had tried to enlist in the World War, and how he had served as a speaker during the home campaigns of war days. He promised a square deal if elected judge.

Reporting he had spent 22 months in the army, William Gannon, circuit judge candidate, said that war service could hardly be the criterion for election of a circuit judge. The office of circuit judge, he said, requires a real lawyer. He suggested that in deciding how to vote for circuit judge, the voter consider to what lawyer he would send a friend in need of competent legal assistance.

John Irwin, also running for circuit judge, said he was all for veterans. He said it had always been his opinion that anyone who tendered services to the country in time of need was deserving of every consideration. Irwin said it is the responsibility of the circuit judge to know the law, and promised to give the office his attention and hard work.

A. W. Schapp, urged that in selecting the circuit judge, the records of each man be examined for efficiency and competence as a lawyer. He said he had practiced law in Klamath county 23 years. He cited his legislative record, including that for veterans. He spoke with pride of the free text book measure he sponsored as a member of the legislature from Klamath county. J. H. Garban spoke briefly for Carlo Abrams, candidate for secretary of state. He said Abrams served in the Spanish American and World war and is a friend of veterans.

Another speaker read Jay Upton's record, and platform, and a telegram from Upton was reported.

Candidates for the legislature on the republican tickets were the next speakers. B. S. Grigsby, who said he lived in Klamath county 71

years, said he tried to enlist in the World War but was told to stay home and raise beef and wheat. He told of his purchases of liberty bonds.

W. A. Van Emon, republican candidate for the legislature, said the only way to reduce taxes is to reduce costs. He said he would support worthy veterans' legislation.

U. S. Balentine, running for the republican nomination for district attorney, declared that in the most important job to be filled at this year's election. He cited his record in public office. Balentine said on the day before the armistice was signed he rode a mule to the county seat in Arkansas to enlist and upon his arrival found the war was over.

Hardin Blackmer cited his two years experience as a deputy district attorney. He advised the employment of a district attorney already acquainted with the work. He cited his qualifications. He said Morris, also out for district attorney, said he would make no promises. He said the disposition of cases should be speeded up, saving the county money for board of prisoners.

J. C. O'Neill, for district attorney, told of his interest and help to veterans in their personal problems. He invited inquiry among his clients as to his success in the law business. He also stressed the importance of giving advice to all county officials.

County commissioner candidates were next on the list. Ed Dunham, republican, said he favors the installation of a purchasing and auditing department. There should be no deep, dark secrets in county business, he said. He told that he had the county business in a big job and requires a business man.

R. H. Anderson, republican, told of his versatile experience in Klamath county, and his many years in public office at Merrill. He said he would promise only to give the county the best he has in a sound, business administration.

Emil Dreher, democratic candidate for county commissioner, said that a business training is needed in the job, and cited his own. He said he knows the county. He emphasized the importance of promoting interest in the establishment of payrolls in Klamath Falls through the building of victrolas.

W. H. Hawkins said he would sign nothing until he knows what he is signing. He promised to be on the job as county commissioner at all times, and to be his own boss. He is a democrat.

George W. Offield, democrat, said he would promise to meet each situation as it arises. He invited examination of his record as a citizen and public servant.

Roy Taber, democrat, said he would advocate Klamath labor for Klamath county. He said the only way to meet the financial burdens of the coming few years is to protect the taxpayers' money.

Progress of the Veterans' Political League was told by Sam P. Miller, republican candidate for assessor. He told of his service in the league, but said he wanted to stand as a candidate and not as a member of the league.

L. Alva Lewis, republican candidate for assessor, recalled his terms as county treasurer and his service as western manager for the biological survey. He said he will devote all his time to the office.

W. T. Lee gave figures on the taxes levied in Klamath county, and urged the league to help him cut the taxes. He cited the five tax-paying bodies in the county. He is the incumbent assessor and democratic candidate for county assessor.

Charles H. Mack, the last speaker, is democratic candidate for assessor. He said that under him the small home owner will get equal treatment with the railroad and the mill. He said he will not employ his relatives nor the two heads of the same household in the office.

Melvin H. Purvis, chief of the Chicago office of the bureau of investigation, announced McLaughlin had made a full confession of his part in the disposition of portions of the \$200,000 ransom paid for Bremer's freedom after 23 days a captive of kidnapers.

Bill more was found in possession of Philip Delaney, whose arrest in McLaughlin's home at the same time the "boss" was seized became known only today.

3,000 mounted guards will be ready for action if mobs taken to the streets during a May day general strike against recent government economy decrees. Military unit near Paris and other cities will be held in readiness.

Red flags flew and red signs popped out in many parts of Havana, calling upon all classes to join in communist May day demonstrations in which 40,000 are expected to participate. There were rumors of radical anti-government plots. Soldiers built sand-bag barricades at all bridges around the capital, made ready with gas bombs and bullets to meet any uprising.

Many "reds" arrested

Austria began its precautionary moves by rounding up known agitators and consigning them to jail. Men suspected of plotting to dynamite government buildings were arrested Sunday in Vienna's underground sewer system. It was there that many socialist fighters held forth during the February civil war.

A "state of alarm" already had been declared in Spain. There was fear of violent disorders in connection with a general strike called by socialists and extremists in Madrid.

Fouring clashes between members of the Zionist revisionists and Histadruth—general federation of Jewish labor—authorities banned all demonstrations in Jerusalem.

Nine foreign communists and one Belgian were arrested at Brussels and Malines, charged with preparing revolutionary agitation for May day. Firearms and propaganda were seized.

The skirmish came as a rumor of Dillinger's death was gaining circulation. This report had it that the desperado may have been mortally wounded when he and his pals blazed their way out of the Little Bohemia resort country near Mercer, Wis., a week ago this morning.

Humor Heard Often

The rumor, heard several times since the greatest man-hunt of the decade began, received official notice last night. Melvin H. Purvis, chief of the Chicago office of the government's bureau of investigation, made the terse announcement that federal officers had been "unable to verify reports that Dillinger is dead in Wisconsin."

"We are still looking for him," he added.

"All poppycock," was the comment of Tim McGregor, sheriff of Vilas county, where last week's gunplay cost the lives of a federal officer and a private citizen.

Bandits Accounted for

"Everyone who was at the Little Bohemia resort when the shooting started has been accounted for," the sheriff said. "The gang didn't have time to bury anyone, and they were too busy getting away to take along any crumpies. If Dillinger is dead from bullet wounds, he was shot somewhere else—not at Little Bohemia."

He added that every inch of ground for several miles around the Little Bohemia resort had been combed for traces of the Dillinger mob, without yielding any clue that would substantiate the theory that the notorious outlaw was dead.

Federal investigators at St. Paul declined to discuss the report, but continued to push their investigation, begun eight weeks ago, after Dillinger, with his wooden gun, bluffed his way out of the Crown Point, Ind., jail.

Nine-Power treaty. (The treaty, signed by Japan, China, Great Britain, France, Holland, and other nations certifies the right of Hawaiian territories to carry on legitimate business in China and guarantees the integrity of that nation.)

In his definite statement, Sir John said:

"Hirota assured Ambassador Lindley that Japan would observe the provisions of the Nine-Power treaty and that the assumptions of the Japanese government and the British government with regard to the treaty coincided."

HULL STUDIES POLICY

WASHINGTON, April 30. (AP)—Secretary Hull has completed a study of Japan's statement of policy toward China and may issue a statement this afternoon explaining the United States' attitude.

Conciliatory in view of Japan's conciliatory attitude and assurances that she would maintain the "open door" policy of China, it may be decided to make no official comment.

It was assumed by some observers that, in view of the similar objectives, Hull's possible statement would be along the same general lines as Sir John Simon's explanation to the British House of Commons. There was no authoritative indication, however, of the manner in which Hull intended to outline official American reaction to the revised Hirota statement.
