Primary Nominations—II

ELECTION of a district attorney for Klamath county is a heavy responsibility of the voters this year. The term of T. R. Gillenwaters expires on January 1, 1935, and the new man will take office for a four-year term. The district attorney, although elected in each county, is really a state officer. As the public prosecutor of the county he represents the state in criminal proceedings and initiates proceedings in the violations of state laws. He may be required to represent the state in various actions when requested to do so by the attorney general or by a state department, and upon request advises with state officers and agencies upon matters within the county.

Hence the county's voters, when they elect a district attorney, discharge a responsibility not only to themselves but to the state government as well. They should see to it that the state is given the best legal representation available in the county.

An important function of the district attorney is to act as legal advisor and attorney for all county officials. He is most commonly called on for help by the county court. In making their decision on district attorney, the voters will do well to give thought to the importance of this function. There is a constant run of matters coming before county officials on which they need legal advice, and it is the duty of the voters to make that advice competent. It wouldn't be a bad idea to exact a pledge from the candidates to the effect that they will be available at all times to every county officer for such service.

Whether the district attorney should forego all private practice and devote his full time to his public office is a question on which there are divergent views. On the one hand, there are those who argue that as long as the county requires all of the time of a district attorney, first rate men will shy away from the office ought to be willing to give his full time to it. There seems to be no law on the subject, except that prohibiting criminal or divorce practice by a district attorney.

Voters will do well to devote a great deal of thought and investigation to the job of selecting a district attorney. At the primary election, the republicans will choose between four candidates—U. S. Balentine, Hardin Blackmer, J. C. O'Neill and Fay Morris, all of Klamath Falls. The democrats have only one candidate, George Chastain.

Get the Convention

THE Twenty-Third club is interested in learning what the community thinks of a fight for the 1935 national convention of that organization.

This newspaper sees no reason to think any but one way on that suggestion. Of course we want the 1935 convention if the local club can get it for us.

As we understand it, there would be little or no solicitation of funds from the business people to provide convention entertainment. Even if there was, it would probably be worth while, for there would be a large number of delegates here to spend their money in one big time. The Twenty-Third club convention would bring thousands of dollars into the city.

This year's convention is at Bakersfield, Calif. It will be held this summer, and the local club wants to be sure the community is behind it before it makes a determined fight for the 1935 meeting. Northern California and Southern Oregon clubs have indicated their willingness to lend support to the Klamath bid.

The Inside Story From The Capital

WASHINGTON, May 5.—The White House and the senate leaders turned so much inside heat on the boys in the senate that the passage of the administration tariff bill is now a matter of course.

Much of the shrewd backstage leading job was done by Vice-President Garner.

Vice presidents never attend secret party meetings of senators, but Garner attended the democratic tariff caucus, and what is more unusual, he made a speech. Garner knows how to handle congressmen from long experience in the house. He talked political turkey to the boys, and may have been the one who figured out the idea of using the war-within-two-years scare to bring them around. It sounds like him.

VIOLETS

Old-timers say they have barely seen such strong inner pressure from above, at least not since the new deal started.

As a result, the democratic leaders are asserting there will be no more than one democratic vote lost (Huey Long). Their estimate is too optimistic. They will lose five to eight votes, but that is not enough to make any difference. The bill is certain to pass and probably without major restrictions.

The restriction made in the caucus was purely a sop to the conscience of wardward senators. It requires only that the president have a hearing before he acts; he can have it open, or closed, perfunctory or real.

When President Roosevelt gets the bill passed, he should send a message to the senate floor leader Robinson, at least. He told him at first it could not be done.

FEUD

The flyweight champion of congress, Senator Carter Glass, is going to get a step-ladder and climb up on Huey Long one of these days.

Their rather long-range feud has been re-opened since the democratic caucus on the tariff bill.

While Huey is thoroughly disliked by many democratic senators, no one dislikes him more than Glass. It was something of a party sensation, therefore, when Huey appeared at the secret caucus and announced he had the proxy of Glass to vote against the administration tariff bill.

"Why that so-and-so," gasped Glass when he heard about it next day. "I never did anything of the kind. Huey just overheard me when I telephoned to Colonel Halsey (secretary of the senate) and said I was ill and would be unable to attend the caucus."

FROLIC

Sly Senator Glass figured out a way to get even.

He went out to the baseball game with Vice-President Garner and democratic floor leader Robinson. Next to Glass, Senator Robinson is the best long-hauler in all the world. The three—Glass, Robinson and Garner—were photographed in a group by a news photographer who edged up to Glass and asked him to identify the two gentlemen in the picture with him.

Glass gave Garner a proper identification, but told the news photographer that Robinson was Huey Long.

In the newspaper next morning, the picture appeared with Robinson identified as his worst political enemy.

Glass has told no one about his little joke and is still chuckling to himself as Huey and Robinson eye each other in passing.

BOOST

The White House has been working around on the inside for several days to amend the securities act strongly and swiftly. It is being spurred by the sagging commodities and stock markets. Also by the fact that some business men are beginning to hum the blues again.

Certain responsible people were called in to help plan the change. The changes will encourage expansion of financing operations, possibly even to the extent of moderating banking regulations. Opponents of the truth-in-securities bill are confident that this one thing will do more to make the pessimistic business men change their present tune than anything else which could be done now.

REPUBLICANS

Ex-Senator Jim Watson is not a candidate for the chairmanship of the republican national committee any more. He has passed that word to friends. That means the republican derby now has no horses entered. Several big republicans whose names have been mentioned in connection with the job have told party workers that they would not take it under any circumstances.

Insiders are beginning to believe that the name of the next chairman has not yet been publicly mentioned.

All Roads Lead Toward Roseburg Club Conclave

For Oregon clubwomen, all roads this week-end are leading to Roseburg, where the biennial convention of the Oregon Federation of Women's clubs will open Monday. Representatives of more than 500 affiliated organizations with a total membership that approaches the 18,000 mark, are expected to attend the session, coming from all parts of the state to enjoy the elaborate program and entertainment features planned by the Roseburg women's club, which will act as hostess. Mrs. Leslie Avitt, president of the Klamath Falls Library club, and Mrs. Jackson P. Kimball, of this city are planning to attend the convention.

Registration will be held all day Monday in the Roseburg Woman's club rooms, with the formal opening of the convention slated for Monday night at the Presbyterian church. Registration will be extended by Mayor J. E. McClintock of Roseburg. Mrs. Charles S. Heinline, president of the Roseburg club, and Mrs. Charles N. Hilyou of Dallas, president of the federation, will make the responses. A choral contest for music groups of the federated clubs will feature the opening session, and a reception at the Elks temple for delegates and visitors, arranged by the Roseburg women, will follow the program. As a special attraction, a midnight matinee at the Elks temple will be held at the conclusion of the reception, when the Women's Civic club of Marshfield will present a dramatical, directed by Mrs. William Horstall.

Business sessions will open Tuesday morning at the Presbyterian church, with reports of officers and departmental chairmen occupying the major portion of the day. The convention banquet will be held that night at the Methodist church, with Mrs. Sallie Orr Dunbar of Portland, Oregon's candidate for the first vice presidency of the General Federation of Women's clubs, as honor guest. The banquet speaker will be Dr. Victor Morris, professor of economics at the University of Oregon, who has chosen as his subject, "Problems of Economic Planning."

Nomination of officers is scheduled for Wednesday morning and because of the statewide interest in the choice of a board, this session is expected to prove one of the most interesting and exciting on the entire convention program. A tea at the Roseburg Country club, with the Business and Professional Women's club of Roseburg as hostess, is planned for that afternoon and a dinner for delegates and visitors will be held that night at the Presbyterian church. The president's night program, always one of the most interesting of the convention session, will follow the dinner, when presidents of the five districts in the state and of all member clubs who are present, will report on their past year's accomplishments.

Election will take place Thursday morning with the polls open from 8 to 10 o'clock in charge of Mrs. Henry E. Harris of Portland. The new officers will be installed as the closing feature of the program and invitations will be received for the 1935 biennial. The convention will close at noon to permit delegates to visit the new soldiers' home during the afternoon hours.

Among the many prominent speakers on the convention program are George S. Turnbull, professor of journalism at the University of Oregon, who will speak Tuesday afternoon on "Keeping the Women's Clubs Before the Public"; Carl C. Donagh, United States attorney for Oregon, who will speak Wednesday afternoon on "Law Enforcement," and Miss Florence Huttsinipillar of Washington, D. C., representing the United States Bureau, who will follow Mr. Donagh on the program. Her subject will be "Trends in Child Welfare." Dr. J. Earl Elise of Portland, chairman of the board of the Oregon branch of the American society for the control of cancer, will

talk on Thursday morning on "The Nature and Control of Cancer." Mrs. J. O. Holt of the Eugene Monday Book club has acted as program chairman for the convention, and arrangements were in charge of Mrs. Charles S. Heinline, president, and Mrs. C. L. Austin, vice president, of the Roseburg Woman's club.

The Portland Grade Teachers association, with 544 members, is the largest individual member group in the federation, while the Oregon State Graduate Nurses' association counts more than 600 members. The Eugene city federation, with 19 member clubs, the Portland federation, with about 113, the third district, with 46 and the Yamhill county federation with 17, also are sending some of the largest delegations. Among other large member clubs entitled to more than average representation are the Marshfield Woman's Civic club of which Mrs. W. S. Nicholson, presidential candidate, is a member; Dallas Woman's club, home group of Mrs. Charles N. Hilyou, retiring president; Minville Women's Civic improvement club; North Bend Woman's club; Portland Woman's club; Salem Woman's club; Port-Bonville; Newberg Civic improvement club; Coquille Woman's club; Eugene Fortnightly club; Fossil Women's Welfare club; Oregon City Woman's club; Forest Grove Woman's club and the Quast club of Portland.
