

MONOPOLISTS, PROFITEERS HELD AT WORK

isted in certain industries and that small enterprises were oppressed.

Two Leaders Assailed
These findings, said the statement, were not answered by Johnson and his officials.

"So far as these 'replies' that reply to nothing, are concerned, the world is still unenlightened, and will continue to be until someone is willing to question the conclusions of the board on these points, the personal resentments of General Johnson and Mr. Richberg are not important."

The board said that Johnson and Richberg, "apparently are under the impression that the National Recovery Act is their personal property, break into shrieks of rage at the suggestion that operations are not perfect or are susceptible of improvement."

Monopoly Charged
The board expressed the hope that when the next report is issued, it will not be held up for NRA men to answer and "pervert" but, that if that is done "we shall insist that at the same time opportunity be given to us to answer Mr. Richberg's misstatements, correct his errors and at least try to draw his attention to the realities of the issues involved."

"Finally, one question: Does the administration wish to be understood as supporting monopoly?"

The board suggested that the "explosions" from Johnson and Richberg "might be deemed to justify such a thought."

In issuing this statement, Chairman Darrow of the board declined to see newspapermen and answer questions. No comment was made on the information from the White House that the board was expected to complete its work and wind up within a few days.

Anti-Trust Laws Wanted
Efforts to ascertain the future hearings scheduled by the board were unavailing although information previously given out by the board was expected to be scheduled as far forward as the middle of June.

The giving out of the prepared statement constituted what previously had been announced as a "press conference."

Senator Horah, who has had a proposal pending for months to repeal that part of the recovery act which suspends operation of the Sherman act, dictated the following statement to newspapermen:

"I am interested in getting the anti-trust laws restored and I do not wish to be sidetracked by a controversy between Darrow and Johnson.

"I have an abundance of facts in my own files which leads me to believe there is no doubt whatever that small business is being destroyed and that monopoly is operating under these codes to the great disadvantage of the consumer."

WASHINGTON, May 21. (AP)—President Roosevelt apparently intends to let the Darrow board finish its task of investigating whether there have been monopolistic practices under NRA.

It submitted a partial report last night excoriating the NRA. Clarence Darrow, the chairman and another member, advocated government ownership and control of industry.

It was made known today at the White House that the president will permit the board to go out of existence when it finishes its work, expected in a few days.

Hugh S. Johnson, the NRA administrator, who issued a scolding reply to the report, has demanded the immediate abolition of the board.

members did not file for entrance in the primaries.

With all counties complete and unofficial, it appeared today that Judge G. P. Skipworth, Judge James T. Brand and Carl E. Wimberly had been nominated on the non-partisan ticket for circuit judge of the second judicial district, comprising Benton, Coos, Curry, Douglas, Lane and Lincoln counties.

The vote for the six counties gave Skipworth 22,281, Brand 21,739, Wimberly 14,981 and Circuit Judge B. L. Eddy, 14,950. Wimberly thus had only 31 more votes than did Eddy.

JUDICIAL RACE HOT

PORTLAND, May 21. (AP)—Intense in Oregon's primary election today centered on results of a rapidly shifting battle for one of the three circuit court judgeships in the second judicial district.

Reports trickling in from remote places reaffirmed previously announced fates of candidates and measures voted upon by the state at large.

New tabulation of returns showed today that H. D. Norton of Medford had a safe lead for reelection as circuit judge of the first judicial district comprised of Jackson and Josephine counties.

The judgeship in doubt found B. L. Eddy, incumbent, some 200 votes ahead of C. E. Wimberly on the basis of incomplete returns from the five counties of the second judicial district.

The count is complete in every county of the district but Curry, where some reports will come by horseback or other rustic mode.

Judges James T. Brand of Marshfield and G. P. Skipworth of Eugene easily won two of the three seats sought by the four candidates. Eddy, appointed governor, Meier to succeed the late Judge J. W. Hamilton, fell far behind in his own Douglas county, but picked up strength in the outlying districts.

In most districts incumbent circuit court judges won majorities, insuring certain election in the fall, as they will be unopposed on the November ballot.

SALEM, May 21. (AP)—State Senator Sam H. Brown of Marion county, who was runner-up to Joe E. Dunne in the republican gubernatorial nomination, today issued the following statement:

"Unpledged and without money, standing on my legislative record of 13 years, I made a fight to see if a man of the people could ever attain the office of governor. I feel that my effort was not entirely in vain with the support that rallied to my banner.

"To those many thousands throughout the state I express my deepest gratitude. Ours, though a losing battle, was a clean fight for the common man."

Rufus C. Holman, third in the race for the republican gubernatorial nomination, issued the following statement:

"I wish to thank those who supported my candidacy for the governorship in the hope that thereby the happiness and prosperity of the people could be promoted.

"Their steadfastness under a barrage of personal attacks upon me is deeply appreciated. I herewith pledge a continuance of my fidelity to the public welfare."

dozen policemen dropped to the pavement, and as many pickets, their heads streaming blood.

One tall picket drew a flashing knife from his belt and swung it viciously. It lashed the back of a policeman's neck, inflicting a deep gash. Police ran to their cars and unlimbered their riot guns, taking stations around the outskirts of the battle.

Guns Halt Strikers
The slugging lulled with the appearance of the shotguns and strikers fell back.

Congressman Francis H. Shoemaker (R., Minn.) was taken into custody at the city market place where he was mingling with the crowd of police and striking truck drivers.

Shoemaker, without tie and in shirt sleeves, was carrying a broom handle when officers took him into custody. No charges were lodged against him at police headquarters but he was "held," the police said.

STOCKYARDS AT CHICAGO HIT BY FIRE

of a brisk southwest wind, that Means was overtaken and burned to death before he could make his way out of the labyrinth of livestock corrals.

On Saturday's official estimates, the estimated receipts of hogs, put at 29,000 in advance, were reduced to 26,000; cattle receipts dropped from an estimate of 15,000 to 12,000 and sheep—their pens untouched by fire—dropped from 14,000 to 6,000.

The Red Cross said it had treated 1,100 persons for injuries during the feverish battle to check the spread of the flames, but less than a dozen were hurt seriously.

Cause Not Known
Chief officers were the cluster of buildings at the Halsted street entrance to the yards, including the old livestock inn, the exchange building, the great exposition hall where annual livestock shows have attracted thousands, the Drovers Daily Journal building, the two banks and a number of shops, homes and tenement houses lying out the fringe just east of Halsted street.

The cause of the blaze was undetermined. Some investigators, including O. T. Henkle, general manager of the stock yards, said they were convinced the conflagration had its origin in a carelessly tossed cigarette.

Henkle said he did not believe there was any truth to reports that the holocaust was the outgrowth of labor troubles.

Fire Fighters Hurt
Fire Chief Michael Corrigan, leader of an army of 2,200 fire fighters who succeeded in checking the flames only after scores of them had been injured, said that a spontaneous combustion might have been the cause. Another theory suggested a spark from a locomotive.

Chief Corrigan said he feared for a while that the flames would reach Lake Michigan.

"When I arrived at the yards the fire had gathered terrific force," he said. "It was coming towards us so fast and the air was so hot, no human could stand in its way."

"We tried to cut off the fire within the yards, but every few minutes I would have to give the order to uncouple and move back. I kept in communication with division marshals by messengers. Men were rushed to the roofs of buildings in the path of the flames to wet them down. Our job was to build a water curtain in front of the oncoming wall of fire and this is what we did."

Big Blaze Recalled
The prolonged dry weather added to the handicap of the fire fighters, leading Chief Corrigan to issue a warning against starting rubbish fires.

Among the buildings damaged was the P. Brennan Packing company plant, a big warehouse of the Omaha Packing company, the Independent Packing company, and the Levi Pfeizer Packing company.

The damage to the stock yards alone was estimated by General Manager Henkle at \$5,000,000 or \$6,000,000.

The fire was the largest since the great fire of 1871, which virtually wiped Chicago off the map.

Joe E. Kelly, 43, was killed yesterday when the truck in which he was riding collided with a car driven by R. L. Hays of Aloha, Ore., and overturned. Robert Willard of Clackamas, Ore., driver of the truck, was arrested on a reckless driving charge.

PORTLAND, May 21. (AP)—Lyle Kirkwood, 21, of (route 1), Salem, was injured about the head early today when the automobile in which he was riding figured in a collision with a freight truck here. Kirkwood, riding with Evan Errand of Salem, was taken to Emergency hospital. The truck driver was A. V. Dill of Portland.

SALEM, May 21. (AP)—Harry E. Beardsley, 61, Salem, died in a hospital here Sunday following a crash between a car in which he was riding as a passenger and a Southern Pacific work train at the Wallace crossing in West Salem.

Robert Ellsworth Jones, 16, of Salem, driver of the car was uninjured. The machine was badly damaged.

Witnesses told state police that the warning wip-wag and bell signals were operating at the time of the crash.
