SPIDERS FOUND AT PINE GROVE

Pine Grove is the latest point to report an infestation of black widow spiders, Charles Bennett, of that place, having discovered a large number of the insects this week. Egg clusters, he says, are found with nearly every spider, indicating a large hatch later. Most of them are found, he says, among rocks in dry and burned ground.

Bennett says the black widow spider is not at all new in the Klamath country, as he found and identified them as long as nine years ago.

Earl Wiggins, of 2335 Garden, who spent last year at Coacchilla, in southern California, where he suffered the usual stomach cramps and partial paralysis for a short time, but recovered fully and was none the worse for the experience. The spiders, he says, will not bite unless provoked.

One resident of the city has recommended a spray compounded from kerosene and cresoline.

NURSING PROJECT DISCUSSED HERE

A nursing project for Klamath county relief work was discussed at Wednesday's meeting of the relief committee, and an effort will be made to induce the state committee to change regulations which apparently will prevent operation of the plan in this county.

Four nurses, to do bedside nursing for families on relief, were asked for and authorized by the SERRA. However, the regulations require that any persons receiving SERRA work must be on relief. As there are no nurses on relief, it appears the nurses cannot be employed without liberalizing the requirements.

voirs has increased. This, coupled with the fact that there is no evaporation during the cool weather, has improved a condition which looked rather serious for some sections early in the season.

Although precipitation is still nearly three inches under normal, the additional showers in prospect during the next 24 hours may raise the mark nearer to average expectancy.

RAINS GENERAL
PORTLAND, Ore., June 6 (P)—light but general showers during the night, continued today, and the weather bureau here believed the east and south-eastern portions of the state, parts of which are extremely dry, might be dampened tonight. Cooler weather prevailed over the entire state.

In western Oregon there was some fear that the rain might damage cherries and hay crops, but the precipitation greatly relieved the worries of growers of larger crops.

Although no rain fell last night in the eastern Oregon wheat belt, skies were overcast today and there was promise of showers. Rain would be of considerable value to spring grain in some sections, although in others the dry season has too far progressed to be relieved.

Roseburg received more than half an inch; at Medford, 1.2 of an inch, and at Wolf creek .26 of an inch was registered.

There was a trace at Marshfield, Eugene and Albany. Salem escaped the night showers, and at Portland three-hundredths of an inch fell. Baker had .14 of an inch, and Grants Pass was showered by .29 of an inch.

TUG ATTACKED BY BOARDERS NEAR SEATTLE

The 60-foot Adolph J., composed of three men, his son, Capt. John Anderson, George Nelson and Charles Smith were beaten unconscious at 1 a. m. and left to drown as the boat started sinking, with its decks open and mooring lines cut, in Lake Union.

Capt. John Anderson recovered consciousness and used gunny sacks and the bilge pump to keep the craft from foundering, the elder Anderson said.

The efforts to sail the Brandywine was blocked by striking longshoremen.

It was the first serious violence reported on the Seattle waterfront during the present strike, although there have been fistfights.

BOAT LEAVES PORTLAND

PORTLAND, June 6 (P)—The first vessel to load cargo in the Portland harbor in four weeks, the steamer North King of the Pacific American Fisheries, reached Portland today from Seattle for supplies and men for Alaskan canneries.

The North King docked at the oceanic terminal which again assumed somewhat normal appearance. Elsewhere along the river, however, all docks were as quiet as they have been since the longshoremen went on strike four weeks ago today.

The North King is being loaded by arrangement with the International Longshoremen's association which has released canneries ships from the strike provisions.

Reports of loss of business to Portland and of general losses caused by the strike continued to mount today.

Roy Ward, manager of the Pacific Cooperative Wool Growers, said the organization is diverting wool from this port because of conditions here. He said that normally one million pounds of wool would be moved through Portland, consigned to Boston. This has been diverted to San Francisco.

"We are getting a ship a week out of San Francisco," Ward said, "and none out of here. All Klamath Falls wool, originating in Klamath and Lake counties, is being sent to the bay port. It costs more to ship that way because the rail vote favors Portland, but we cannot afford to have the wool strike-bound here."

SEATTLE, June 6, (P)—

Signing on a crew of non-union sailors and firemen, the General Petroleum Corporation tanker Lio headed south at 5 a. m. today for another load of oil—first ship to break the tieup of shipping in the port of Seattle.

The Lio was deserted by her crew when she arrived from Los Angeles and discharged her last load May 22.

Half Million Asked for Highway Work

PORTLAND, June 6, (AP)—The state highway commission needs \$500,000 "right away" so that work can start on the Oregon coast highway bridges.

Leslie M. Scott, chairman of the commission, has sent telegrams to the Oregon congressional delegation asking that this amount, out of the \$5,800,000 promised from PWA money, be made available immediately so routine work on the bridge program can be expedited.

SUPERINTENDENT INJURED

LA GRANDE, Ore., June 6, (AP)—A. L. Hoover, superintendent of the government emergency airfield here, was seriously injured last night when a motorbike he was riding spilled, throwing him onto the pavement. Hoover suffered a probable fractured skull and was only regaining consciousness slowly this afternoon.

Homemakers Learn Science of Foods

The girls modeling the suits for grown-ups were Elaine Irwin, Edith Reimer and Gladys Stevens. Julia Lee Wright, as national director of the Homemakers' Bureau and kitchen-in-chief in the planning of the program has, if one may be forgiven for the utmost simplicity of expressions, "done a swell job." And it was a man, which we sometimes wish that we were, we'd take off our belt in appreciation both of the dishes described and the manner of their description.

One can well imagine, for example, that men will be less dignified, though none the less enthusiastic, in their approval of an English beefsteak pie that was lifted bodily out of ancient English history by the Homemakers' Bureau, given a few deft touches of modernization, and offered from the stage here as a fascinating culmination to the explanation of a brand new way of mixing pastry.

And then there was a real, genuine, identifiable and flavorful graham cracker crust. Bane of many a housewife's existence, particularly when the children are denied the richer pastries, graham cracker crust was revealed by Miss Calkins as the subject of thousands of inquiries received by the bureau. "The beauty of this crust," she said, "is that it shouldn't ever fall if directions are followed, and the directions are certainly simple."

Those to whom a good meringue has been more of a miracle than a meringue, were given a real ray of light by Miss Calkins in her demonstration of ways and means to prevent the singing of the meringue's theme song, "Why I Fall for You." The elimination of watery meringues was accomplished at the same time.

Another revelation brought by the first day of "Kitchening" was the peculiar affinity of a standard and highly perfected biscuit recipe to a variety of delicacies, featured among them being dumplings glazed with maple syrup and served with a maple hard sauce.

Beans Bermuda proved to be an alliance of beans and onions, and one of the hits of the day it was a simple cabbage salad involving carrots, apples, raisins, pineapple and mayonnaise in addition to a husky head of cabbage.

The course introduced the first chapter in the making of peanut butter locomotion as a juvenile joy with an adult appeal, more about it being promised for chapter two which will be revealed Thursday.

To top off the program Miss Calkins demonstrated the preparation of a complete meal on a single broiler, interesting not only because of its simplicity of preparation, but because it does things in a major way for those housewives who don't mind washing broilers alone, but do dislike finding a used broiler forgotten on the stove after all of

tative and the maintenance of competition.

The statement added parenthetically that competition should be "checked by government regulation."

Ruin Predicted.
The committee's statement, drafted as a platform for its campaign to win back congressional seats in the fall, was issued as the party leaders went into the second day's session here.

A charge that a "small group in Washington" sought "complete government control of agricultural production and all business activity" was in the statement, along with one that the administration was guilty of reckless spending.

"The administration has committed the country to a program which unless checked will lead to the chaos of unlimited inflation," the G. O. P. leaders said.

They rapped the administration's gold policy and its attendant effect on the "gold contract" in bonds with the statement, "we insist that there shall be no further repudiation of solemn obligations of the government."

Emergency Laws Hoped.
The committee fired a broadside on the "present emergency laws," saying, "we believe that present emergency laws, vesting dictatorial powers in the president, must never be permitted to become a permanent part of our governmental system."

Declarations were included for freedom of the press, freedom of speech and for the radio.

"We believe in short," the committee concluded, "that American democracy working along American lines—is equal to the task of solving the problems of the world."

Why? Because Ford measures roominess in terms of usable body room. Not in terms of the distance between bumpers, which means nothing when you come to analyze it.

The Ford V-8's very engine construction gives you more body room, as the diagram explains. Cylinders are "doubled-up" saving space, not strung along in a line to waste it.
