was icy. Ten inches of new snow was reported on Greenup, with similar conditions existing on road surface.

The Klamath Falls-Lakeview road was receiving its heaviest snowfall of the season. The plows were at work, but the snow kept drifting into the road.

The mountain section was particularly slippery. Motorists were advised to have chains on their wheels in that vicinity.

Mr. Shasta Has Storm

In the Mt. Shasta country a heavy storm was in progress all night. South-end districts received a lighter fall than Klamath Falls and other sections of the county. Thursday afternoon the weather warmed up a bit and south-end country lanes were pretty soft.

Klamath Falls was without power service for several minutes shortly before 10 o'clock when wet snow piled up at the Pelican sub-station, blowing up the two insulators. A similar incident occurred Wednesday night when trouble developed at the Shipping-ton sub-station.

The heavy fall of snow changed to slush on city streets. Pedestrians were forced to wade when they crossed downtown intersections. It was impossible to negotiate steep streets by automobile without chains.

While men struggled with the drifts, Klamath country birds were hard put to find food. W. E. Stanton, Tulake, spread grain for quail near the west side road. About 200 quail were eating there.

Crater lake national park was again the scene of a blustering snowstorm Thursday morning. Total depth of snow at government camp was 14 inches. The plow was at work, and park officials hoped to have the roads open by Friday morning.

The sun shone intermittently at Grants Pass, in the Willamette valley, in the latter region bringing welcome relief from downpours of rain.

Governor Plans Conference

Hoffman did not disclose his own opinion, but said he would confer with Chancellor Luther A. Campbell, the state's highest judicial officer, also a member of the court.

Chancellor Campbell indicated the decision on hearing Hauptmann, whose execution is reported scheduled for Friday, January 17, was one for the entire court.

"I would like an opportunity to appear before the honorable board of pardons when they consider my case, and be given a chance to answer all questions the court may care to ask me," wrote Hauptmann, convicted slayer of the kidnapped Lindbergh baby.

No Stay Expected.

His message was taken to the governor yesterday by C. Lloyd Fleher of the defense counsel.

The governor said he had no intention now of granting Hauptmann a stay of execution.

"It is not my present intention to grant a reprieve," said Hoffman. "My present information is that I do not have the power."

He said he was advised last week that a constitutional provision limiting reprieves to 90 days after conviction meant 90 days after conviction in trial court.

Hoffman said he would announce the court's meeting place tomorrow. If the governor selects the state prison, it would indicate strongly that Hauptmann will be heard.

legislative formula will be drafted before the meeting here tomorrow of farm leaders called to discuss the situation.

Payments to Go On

Both Wallace and Davis were reported to favor continuance of cash payments to farmers in some form.

Rumors abroad that further dollar devaluation might be included in the new agriculture program brought no comment at the White House. But on this same subject, Morgenthau told newsmen:

"I would not worry too much about rumors right now, especially if they originate outside the United States."

The president also discussed the agriculture situation with John Jones, chairman of the reconstruction corporation which has put up more than \$200,000,000 in commodity loans.

Peek Enters Picture

Jones said afterward these loans were "well secured." He would give no indication of the farm situation.

The figure of George N. Peek, sworn enemy of some Roosevelt administration policies, entered the chaotic AAA picture today, leading new dealers to fear another storm of devaluation.

Administration men received word that Peek, former Roosevelt advisor who was stripped of high powers and resigned after clashing with Secretary Hull and others, planned to communicate his ideas to a conference of 70 leaders of farm organizations.

The meeting, opening tomorrow, was called by Secretary Wallace to discuss plans for a program to succeed AAA, scrapped by the supreme court. Peek, whose views on the tariff clash with those of Hull and Wallace, has unquestioned influence with farm groups such as the National Farmers Union.

Wallace was known to be uneasy on hearing that the man who proved a storm center as first AAA administrator and later as the president's foreign trade adviser, would put his ideas before the parley.

Peek will not be present in person, his views are expected to be communicated through an intermediary. It is believed he will insist that agricultural tariffs, instead of being lowered as in some instances in the new deal's trade treaty with Canada, should be increased, even to the exclusion of all foreign farm imports.

While there is hope that other money will be sent here, the relief agency was proceeding on the theory that it must stretch the \$1983 until the end of the month. On that basis, there will be only 10 cents per day per person.

WPA Rule Cited

There are approximately 200 on direct relief who can be classified as employables, and would be at work on WPA and no longer a direct relief agency burden, if it were not for WPA regulations, it was stated. These regulations disqualify for WPA any person who was not on relief some time between May and October. This rule has been vigorously protested here.

Before this brief romance he had been divorced successfully from Olivia Burwell, a Mississippian girl, Leatrice Joy and Ina Claire, both well known actresses.

Voice Ends Career

Gilbert went from one job to another in movies, scenario writer, assistant director and director, until finally he achieved his first starring picture in "The Big Parade."

After that he became known as the great lover of the screen, and lived up to this in real life, becoming one of the most married actors in the history of the screen.

Just before the talking pictures came in he was one of the highest paid actors of the screen. He was Greta Garbo's leading man at that time.

His high-pitched voice proved a drawback with the introduction of sound, but this later was overcome and he returned as a star in the talkies.

LIQUOR HEARING SET AT CHILOQUIN

The state liquor commission will hold a hearing at Chiloquin Friday morning on the question of beer licenses on the reservation.

This issue has reached the controversial stage before the commission. On the one hand, it has been urged that no beer permits be allowed on the reservation because it is unlawful for Indians to receive intoxicating beverages. Others, including Chiloquin business men, have opposed this movement, asserting that as long as beer and hard liquor is available near the reservation, Indians will get it, and legitimate business houses on the reservation should not be prohibited from selling beer to whites there.

The commissioners will hear both sides of this question on their stop at Chiloquin before coming to Klamath Falls later in the day.

KLAMATH LEADS IN CHECK CONVICTIONS

Klamath county leads the state for conviction and imprisonment of "bad check artists," according to District Attorney Hardin Blackmer, who on Thursday urged the cooperation of merchants in stopping the crime of crime.

Blackmer's statement follows, in full:

"A review of the charges filed by my office from January to December 1, 1935, disclose that out of the 127 felony cases, 55 were for 'bad checks.' Almost one-half of the business of this office, as regards felonies, has to do with bad checks. A great number of these offenders are apprehended and punished. In a recent conversation with Joe Murray, handwriting and ballistics expert, and in charge of identification at the penitentiary at Salem, I learned that Klamath county leads the state for conviction and imprisonment of 'check artists.'

"But the increasing number of worthless checks being cashed in and about Klamath Falls makes it imperative that more drastic steps be taken if we are to curb this type of lawlessness. For this reason I am appealing to the people of this county, particularly the merchants, to be even more alert and strict in the acceptance and cashing of checks.

"The most usual procedure for the 'check artist' to follow is to tender a \$5.00 or \$10.00 check in payment of a small purchase with 15 or 25 cents. Unless the merchant knows with whom he is dealing he would be wiser to forget the small profit he might make on the sale, and refuse to accept the check.
