The Inside Story From The Capital

WASHINGTON, May 23.—President Roosevelt has been again troubled by a personal one, of course, but official. It is no secret that he has the most motley collection of officials with high blood pressure ever assembled under one governmental roof. Playing parent to a crowd of radicals, liberals, progressives, conservatives and reactionaries actually takes up more of his time than any other phases of the presidential business. The wonder of it is that he has been able to keep all but a few hundred of the inner squabblers from being fully aired in public.

For instance, he spent recently a portion of about 14 consecutive days straightening out a hot inside scrap over the reappointment of David Lillenthal to the Tennessee valley authority. As a result, Mr. Lillenthal was appointed, considered and confirmed by the senate in about 14 minutes, a process which usually requires at least three weeks.

In the end, the president thought he had settled a matter with a minimum of publicity, but he still has his fingers crossed. He keeps them that way.

FIXING—

To show you how these things work on the inside: Mr. Lillenthal apparently meant nothing to Mr. Roosevelt, but Senator George Norris was the man backstage who was insisting on the reappointment. Lillenthal's term was to expire May 18. For three days prior thereto, Norris was a daily visitor at the White House.

Now, anything that Senator Norris wants from the new deal is ordinarily granted without question, but in this case his protégé was another member of the TVA, Arthur Morgan. It was well understood by all concerned that if Lillenthal was reappointed, Morgan would probably resign.

SOOTHER—

In this highly extraordinary manner, Mr. Lillenthal was put back in office for nine more years before any opposition had an opportunity to arise. But that settled only half the row. The other half was Mr. Morgan. His daily visits to the White House began the day of the senate coup and continued for three days thereafter.

What went on between the president and Mr. Morgan will probably forever remain a secret between them. There is no reason why Mr. Roosevelt should tell and Mr. Morgan is habitually speechless. As White House newsmen express it, Mr. Morgan "would not tell you whether today is Saturday."

However the president felt sufficiently confident of himself as a soother of ruffled brows to announce before the third visit that the published thoughts about Mr.

Offices For Sale

TAKING tribute from public job-holders to press political campaigns has become common practice, but that doesn't mean that it is good public policy. The Salem Capital-Journal comments editorially on this matter, and its opinion checks so closely with ours that we re-print it in full:

Reporting its primary campaign expenditures to the secretary of state as required by law the democratic state central committee lists disbursements of \$1932 and receipts of about \$100 more, most of which was contributed by state and county office and job holders.

Except that this has been a lean year for job seekers in the party the itemized statement of republican contributors would likely reveal the same sources of revenue, as it has in campaign years in the past. But the fact that democrats are this year only emulating their republican brothers does not glorify or sanctify the practice of shaking public servants down to defray the expenses of organized effort to continue them in jobs.

The effect of such a procedure is to put a price upon public service and establish a financial qualification for eligibility to public position contrary to the spirit if not the letter of qualifications stipulated by law. Collection of such contributions, even though they are not solicited, is of questionable legality under the provisions of the corrupt practices act.

In this practical application, as anyone experienced in politics knows, the practice is almost and out-and-out shake down, with officials and job holders being given to understand that unless they "kick through" they need look for no further favors at the hands of the party machine in power. The result is to create allegiance to the party rather than to state and to discourage competent men and women from seeking public service.

The practice is efficient principally in creating and perpetuating political rings and in encouraging government by professional politicians. Party organizations might as well hang out signs reading "Jobs for Sale."

Recently, the Klamath county democratic central committee undertook to obtain from Congressman Pierce and Governor Martin the names of all persons in this district who hold state or federal office, the purpose being to "contact" them for cash for party funds. Some time ago a democratic dinner was held and office-holders were notified they had better be on hand and pay the exorbitant admittance fee, part of which was to go to the national party campaign chest. As the Capital-Journal says, republicans might be doing the same thing if they were in power. Whoever does it, it's a practice that could well be abolished.

For Them, "Regardless"

IN another letter to the editor on this page, Dr. C. B. Cassel indicates that he will vote for Townsend candidates for that reason alone, regardless of what other qualifications or disqualifications they may have, or no matter how superior their opponents may be in ability, integrity and experience.

The doctor has said something like this twice since the primary election, a pretty good indication that he is a bit skeptical about the qualifications of certain so-called Townsend candidates, but is going to vote for them anyhow.

It was the belief that Townsends would blindly follow the course indicated by Dr. Cassel that attracted a motley crowd of demagogues and political adventurers to the Townsend camp. What an opportunity for them, if nobody cared about anything except that a candidate should get up and shout for the plan!

No need to earn the right to the office through years of training, hard work, and faithful public service. No need to worry about any questionable spots in your record. Just say you are for the Townsend plan 100 per cent, shed a few tears for the old people, and your qualifications are established.

That was one of the things that led to Townsend movement's losses in the recent primary election. It all looked so good to the demagogues and opportunists that there was a rush of too many of them to the wagon, and it broke down.

We are inclined to the belief that Dr. Cassel, (whose skepticism about certain Townsend candidates is evident in his repeated declarations that he will vote for them "regardless") and many another sincere and intelligent Townsendite, will be unable permanently to repress their good citizenship and will vote for qualified candidates, at the same time rejecting the unfit, the unprepared and the second-raters even if they do shout demagogically for the Townsend plan.
