Looks Like Landon

ALL indications today point to the nomination of Governor Landon of Kansas at the republican national convention. Landon's recent impressive victory in the New Jersey primaries, and his whole pre-convention experience, except that in California, has been favorable, in contrast to set-backs for his most dangerous opponents. Last reports from Cleveland are that they are running around in circles trying to do something about the impending Landon victory, but not getting far with any attempt to organize a solid front designed to bring about the Kansas governor's defeat. There may be a blow-up somewhere down the line, based on mysterious charges of some kind, the importance of which we have no way of judging at this time. Landon does have some potent opposition in Senator Borah and ex-President Hoover, but it is questionable at this time whether it can stem the tide. Twenty-four delegates from Indiana only yesterday disclosed that they were all for Landon. Unless there are some underground wires pulled, it looks as if the delegates to the convention run pretty strongly to Landon.

Oregon delegates will vote for Senator Borah on the first ballot. Borah won a default victory in Oregon, and they have no other choice. They will vote for him, however, only as long as he has a reasonable chance to win. Borah did not do so well with the default voting in Oregon as most of us expected.

If a deadlock should develop, no one knows what dark horse might come forward for the nomination. It might be Vandenberg of Michigan, an able man who has not done a great deal to advance himself as a candidate. It might be Fred Steiwer of Oregon. Incidentally, either of these men might be chosen as running mates for Landon in the event of the latter's nomination. Vandenberg would probably be Landon's first choice, but Steiwer, the convention keynoter, has considerable support.

Political interest of the country, even that of those who think that whatever the republicans do is simply preliminary to defeat in November, will center the coming week around the Cleveland convention, and right now, it looks as if that convention will see a Landon triumph, unless—

Antelopes to Gather

WORD comes from Lakeview calling the meeting of the Order of the Antelope for June 14 and 15. High on Hart mountain, in a green grove beside a sparkling stream, overlooking a great stretch of high desert off toward Steens mountains, the Order will gather for the fifth of these unforgettable "conventions."

It was four years ago this June, around a blazing campfire, that the Order of the Antelope was formed. A little group of men had been invited to the mountain by Lakeview men that they might get a better understanding of the wonders of the antelope country of Lake county. Impressed by their visit they decided that those who annually enjoyed these experiences should be joined together in some sort of organization, and the Order of the Antelope grew out of that idea.

It is a unique organization. There are no dues, no meetings except the annual trek to the fastnesses of Hart mountain. Yet every member regards his place in the Order of the Antelope as high privilege, for it identifies him with something that is grand, and inspiring, and different.

NEWS BEHIND THE NEWS

WASHINGTON, June 5.—The main heavily suspended inner animation about the Cleveland convention concerns what Senator Borah is going to do. Nearly everyone in Washington knows, but no two agree.

The most general expectation here is that he will fight to the last conventionally ditch and then be trampled by his political death in it. In fact he has told some of his intimates within the last few days that he is tired of public life; that there is nothing interesting for him to do with another senate term; that he would like nothing better than to carry his fight against the republicans old guard right up to an illogical conclusion and then retire to practice law in Boise and Washington, with the record made.

Portifying this impression, there is supposed to be a stack of letters a foot high on his desk. He has shown them to several callers.

These are said to reflect the popular reaction to his last radio broadcast, challenging the party influence of Messrs. Hillies et al.

SORE
 Then there is the personal angle. It often dominates the acts of statesmen, but rarely is mentioned publicly.

The Idahoan is said to have had unfortunate personal experiences with some of the lesser Landon leaders. These experiences are supposed to have been almost as unsatisfactory to him as the California Landon situation was to Mr. Hoover. At any rate, he left him cold, if not embittered against the Landon candidacy.

Feelers have been put out inviting him to write the platform, and he has declined. Similar overtures looking toward the possible selection of his friend, Senator Vandenberg, as vice-presidential candidate have failed to bring an encouraging response from him.

And all the while his silence and evasions have tended to build up the rumors that he may take walk, may side with President Roosevelt, and do everything except play ball. In fact, the threatening mystery of his own position is largely of his own making.

LOGIC
 Those who really know Mr. Borah, and what he is after, believe the Borah situation will not work out as threatened. Fundamentally his political interests have been two-fold; first, in his principles; second, in his

party. He has frequently let republican presidential candidates lean on him in furtherance of these two interests.

Just now the principles in which he is interested are nationalism and anti-monopoly. No other important factions of the party are against those two things. There will be no difficulty about that. His secondary interest is to defeat the Hillies crew.

The accomplishment of this is not simple. But he cannot do the job alone, nor by acting out any of the rumors now current.

His best bet obviously is to come to some agreement with people who can help him, and those who can help him most, apparently, are the Landon people.

Unless something slips, you may look forward to public indications of such a development at Cleveland before the time arrives for nominating speeches, as previously predicted.

SPLIT?
 It escaped notice at the time, but in the relief debate, the other day, Senator Borah spoke rather more harshly of Senator Vandenberg than is customary for a political foster-father addressing his adopted candidate. It happened twice.

Upon the first occasion, Mr. Borah directly challenged Vandenberg's wisdom. Somewhat sarcastically he asserted that the Michigan leader had unwittingly emasculated his own relief amendment by agreeing to a compromise with the democrats.

Later on, the Idahoan seemed to question the Michigan leader's judgment. He said a second Vandenberg amendment was opposite to the correct approach to the problem at issue.

Senators who have gone back to look at the record of the debate are convinced that this was no family quarrel. In a way it seemed to them to denote a change in the Borah-Vandenberg political relationship, a hint, perhaps, that the Idahoan is not interested in Vandenberg presidentially, or vice-presidentially.

RATING
 Standing of the vice-presidential candidates was surmised by a

most authoritative source the other day as:

1. Vandenberg. (His friends apparently agree for him in saying he will not take it, but nobody believes them.)
 2. Senator Steiwer of Oregon, the keynoter. (He has a respected following among veterans' organizations, and elsewhere.)
 3. Ex-Governor Lowden of Illinois. (He would be first if he would take it.)
 4. George Peek, Congressman Wadsworth, Senator Hastings, Former Senator Edge. (All of their chances are not considered very good.)

WORDS

Those who are talking up Lowden as the vice-presidential candidate hereabouts tell an interesting story of why he declined the vice-presidency in 1924 after being nominated by the convention. They say that Lowden was sharply irritated by the wording of the invitation he received from the chairman of the convention, Frank Mondell, who was not in favor of Lowden. They say that if the invitation had been couched in more inviting language, it would have been accepted.

FARM AID

(Great Falls Tribune)
 Lack of understanding of the farm credit system is common and current misconceptions of it hinder its development. In a news story from a Washington press service recently received here, farm relief activities were described in a confused story. The statement was made that one farmer in four depends on government aid in his efforts to derive a satisfactory living from the soil.

That proportion was reached by adding to the number of farmers on the rehabilitation rolls of the resettlement administration those who have loans from agencies of the farm credit administration. Now the FCA has several branches, intermediate credit banks, federal land banks, banks for co-operative production credit associations and the emergency seed loan agency. Farmers dealing with land banks, production credit associations and banks for co-operatives have reason to object to the statement that they are receiving government aid. Those agencies are not relief agencies. They are not loaning government funds. They are business institutions.

The farmer who borrows from a commercial bank, an insurance company or a livestock loan company on the security of his property is not thought of as receiving charity from those institutions. Just as much as if a merchant, a manufacturer or a railroad were doing the borrowing. The farmer dealing with the FCA agencies mentioned above is also securing credit on a business basis and backs the loan with his property in the same manner as the business man does when he lives money.

Moreover, the land banks, production credit associations and banks for co-operatives are co-operative institutions which in effect pool the farmers' credit and on that security obtain funds from private investors on their bonds and debentures. The FCA uses the intermediate credit banks to rediscunt livestock and crop production paper and the latter sell debentures in the private investment market for that financing.

The whole system is based on local associations, co-operative, farmer owned and farmer controlled. It is a permanent system which is democratic in its nature and based on co-operative principles which have been

If the wind changes again to the south, the timber is doomed.

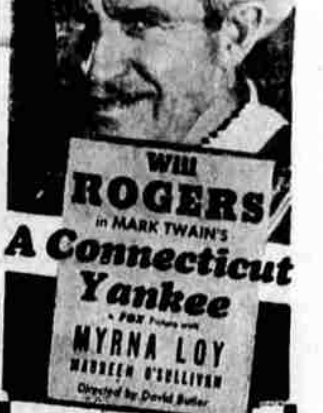
