There were no demonstrations. Caucuses of some state delegations later in the day were considered more important for the ultimate outcome than the opening session itself, if decision on whom to support should be reached. It seemed likely, however, that several of the larger delegations would keep their own counsel to the last.

Bridges A Candidate

The convention recessed at 12:33 p. m. (EST) until 8 p. m., when Steiwer will deliver the keynote speech.

Governor H. Styles Bridges of New Hampshire was added today to the growing list of republican vice-presidential possibilities.

Clarence V. Beck, Kansas attorney general, said he had accepted the 38-year-old New Englander and found him receptive.

Whether this move from the Landon camp meant the Kansas if nominated, had been upon the eastern running mate was a subject of considerable speculation. Other of Landon's friends are known to favor an all-western ticket.

Fine, Sentence Imposed Tuesday

Fine of \$100 and a jail sentence of 40 days were imposed upon Eugene Williams Tuesday morning by Police Judge Clifton Richmond, when the defendant appeared in police court to answer to charges of drunkenness and vagrancy.

PLANTS CLASSIFIED BY PARK BOTANIST

LAVA BEDS NATIONAL MONUMENT, Calif., June 9. (Special)—The classification of 30 additional species of plants and flowers in the Lava beds area was reported this week by Dr. Elmer Applegate, botanist of the Crater Lake National park organization.

This number brings up the total to nearly 200, with the probability this figure will be reached within a short time. Interesting is the fact that a number of the plants growing in the Lava beds area are far removed from their original life zone. Dr. Applegate plans to prepare some special material on the results of his work in the region and will also prepare Ryker mounts of the more prominent plants for exhibit.

Later this month he will return to Crater Lake National park to continue his research into the flora of the park area. He has already classified 90 species in the park and expects to increase the number this summer. Flower season does not arrive until July after the winter snows have melted and continues until autumn snows bring the season to an end.

or employment assistance on "a beggars basis."

He cautioned, however, that "no idealistic plan will be accepted as a rapid change."

Transaction Tax Rapped

An old age revolving pension plan "has done much to educate the people and make them conscious of this problem," he said, but pointed out the important need was "to find the best method of raising the funds that are required."

He recommended that funds for security legislation "come from income, inheritance, gift and corporation taxes, or at least from other sources than sales taxes and property taxes."

The transaction tax, he continued, "is the very worst form of the sales tax. It is the sales tax applied to each transaction, with the tax piling up on each sale as it passes along from producers, manufacturers, and jobbers, to the retail sale."

SUMMER WEATHER RETURNS TO BASIN

Sunshine and blue skies returned to the Klamath basin Tuesday, putting an end to a week of cloudy weather and heavy rains.

Rising barometric pressure was reported by the weather man Tuesday and a forecast for continued fair weather with pleasant temperatures was issued.

The maximum temperature reported for the day was 70 degrees, and the low mark was 45.

Weather predictions from the state weather bureau included fair weather for the east and cloudy in the west Tuesday night and Wednesday, unsettled in the coast and state-wide moderate temperatures.

"When you see something disorderly going on, in violation of the law, aren't you supposed to make arrests, regardless of whether you have a warrant?"

"I don't interpret the law that way," said Kimsey.

"You interpret it incorrectly," retorted Fligel.

Many of the witnesses said they had seen minors and intoxicated persons refused beer at the Little Duck Inn. All agreed that it was run in an orderly fashion, and some declared it to be one of the best operated beer establishments in Klamath Falls.

tries of the world are heading in opposite directions from democracy and freedom." He cautioned his listeners "we shall have to decide whether this retreat of civilization shall spread to our own country."

Individual Effort Wanted

He said the graduates would have to decide between two views, one which "presupposes we have reached the end of the road in our national development," and the other "held by those who insist that we have not more reached a stationary stage now than we had in the '30's."

"I do not believe that America has come to the end of the road of individual opportunity, and I would like to have you share that conviction with me."

Landon followed his first reference to monopoly and dictatorship with another specific thrust: "We, the people, must overthrow the tyranny of monopoly and economic dictatorship, in all fields of honorable endeavor, if we are to escape the shackles of bureaucracy in governmental life. And only by overthrowing the one and resisting the other shall we be able to open again and keep open the gate of equal opportunity now and in the years to come."

REGIONAL PLANK FAVORED

CLEVELAND, June 9. (AP)—Leaders of Oregon, Washington, Idaho and Montana delegations to the republican national convention caucused today and voted to join forces in furthering planks giving greater recognition to Pacific northwest problems.

The caucus was called by Walter Tooez of Portland, chairman of the Oregon delegation.

The group named a sub-committee to draw up a program of resolutions and amendments to be presented to all delegates of the four states tomorrow.

Members of the sub-committee are J. W. Emerson of Pullman, Wash., Joseph Dunne of Portland; H. Stanley Thurston of Stanford, Mont., and H. C. Baldrige of Parma, Idaho, former governor of Idaho.

Tooez said planks calling for adequate protection of domestic markets, particularly livestock and lumber, would be sought. A policy with respect to the Grand Coulee and Bonneville projects also will be considered, he said.

San Francisco Man Recalls Indian Warfare

came of the outbreak of the war. His father had gone out in the early morning with the old. It was an hour or two later that little Kenneth, who was four years old, stood with his mother in the cabin door, and saw his father driving the sheep back.

They wondered why he was coming home at that time of day. They learned when he shouted the terrifying news that the settlers on Tule lake had been massacred. A scouting party led by Captain Ivan Applegate had seen the sheepman and warned him.

Mrs. McLeod put bacon, flour and sugar in the wagon while McLeod hitched up. The cows were driven into the flock with the sheep.

Mrs. McLeod, holding on her lap Kenneth's little brother William, then three weeks old, drove the team, and McLeod saw to it that the livestock kept moving. They set off for Linkville and safety from the Indians.

Throughout the day the little caravan moved over the rough, dusty road, between veritable groves of sagebrush. Along in the afternoon a cloud of dust was noticed in the rear. The figures of horsemen could be seen.

Mrs. McLeod became frightened, believing the horsemen were Indians. Her husband watched the approaching cloud intently for a moment, then spoke assurance to his wife. He could see that the men rode straight in their stirrups. They were soldiers, for Indians never rode that way.

Reaching Klamath Falls, the little family camped for three weeks on a hillside near the town. Then McLeod, realizing that the

Indian war would continue indefinitely, moved to Pendleton.

That was the story recalled Tuesday by McLeod, who spent a short time with Captain O. C. Applegate, recalling early days in the Klamath country.

McLeod's son, Kenneth McLeod, Jr., lives here, and he is also interested in another Klamath resident—Ralph Hill. McLeod helped Hill get work when the young Klamath farmer was training for the 1932 Olympics. He ran in the 5000-metres for the Olympic club.

McLeod expressed the opinion of many another observer when he said that Hill, by his fine demonstration of sportsmanship in the incident involving Laurie Lehtinen, brought more glory to the Olympic club and to the Klamath country than he would had he won the race.

McLeod is regarded as the foremost western authority on the management of men's clubs.
