Vacations Here—Darland Terrell of Medford has gone home after a two-week vacation here with friends and relatives.

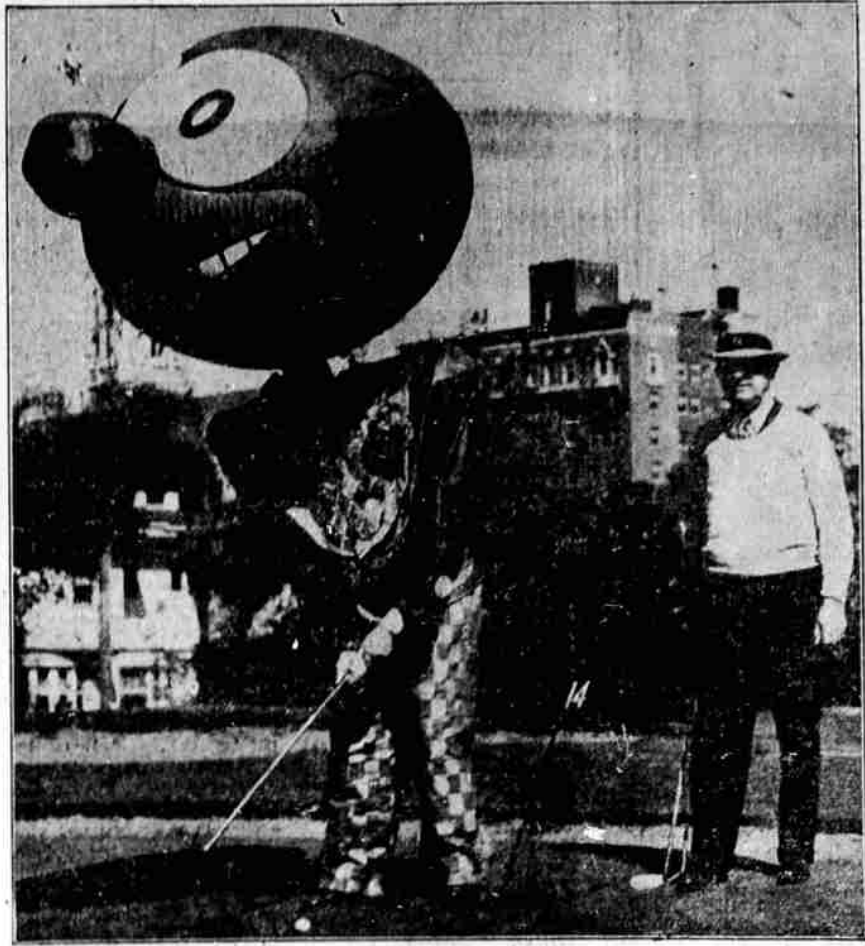

Child Falls From Tree to Pavement

SECOND KILLING LAID TO BARBER

LOS ANGELES, July 1. (UP)—The state Tuesday ploughed through the graveyard of Robert S. James' forgotten past to dig up evidence which they say will prove the cold-blooded "Bluebeard barber" murdered not only his seventh wife, but also his third, to collect her insurance.

While James' battery of defense lawyers marshaled every legal gun to keep the case off this ground, the prosecution began to inject into the record testimony concerning the death of Winona Wallace James, the barber's third wife, found drowned in a bathtub at Manitou, Col., in 1922.

Strangely the circumstances of

that case almost parallel the discovery of the last Mrs. James—Mary Busch James—face down in a fish pond last August 5. Both wives were heavily insured in James' favor.

The red-haired barber is charged with murdering his final wife after subjecting her to torturing fangs of a live rattlesnake. Five witnesses from Colorado arrived today to unfold testimony upon which the state hopes to prove James tried to kill his third wife by hitting her over the head with a hammer, then toppled her over a mile-high embankment on Pike's Peak highway, and when that didn't kill her, drowned her in a bathtub.

Expected to "inherit" This testimony, bitterly objected to by William Clark, defense spokesman, was offered to bear out the opening statement of Deputy District Attorney Eugene Williams, that "murdering a wife for insurance was no new thing for James."

Clark said he was "ready to stand, hear and argue all afternoon" citing legal authorities against introducing the Colorado evidence.

E. L. Taggart, automobile salesman, told the jury he talked with James nine months before the last Mrs. James was found dead, and at that time expressed a desire to buy "a good car later on, as I expect to inherit about \$10,000."

The state produced insurance records to show that on October 2, 1935—seven weeks after pretty Mary Busch James was assertedly slain in the rattlesnake torture plot—James applied to an insurance company for \$10,000 insurance, taken out by his wife a few weeks before she died.
