## Municipal Politics

**ANNOUNCEMENT** from Clifton Richmond that he will seek the office of mayor at the November election no doubt will start the wheels of municipal politics turning. Judge Richmond is leading off a parade of city candidates.

We have received an inquiry from a new resident as to how many offices of the city government are to be filled this year. The answer is: "All of them."

That happens every two years. Whoever it was planned the way things should go in city elections was certainly taking no chances on any official entrenching himself in office through a period of years without having to go to the people every biennium for approval.

This system has its disadvantages, particularly in connection with the city council elections. It is a generally accepted theory that on boards of this character there should be hold-over members, whose experience will be useful in the case of election of new members. Klamath's system disregards that theory, and it is not impossible that on some January 1 there will be a new mayor, new council, new police judge and new treasurer, all inexperienced in city affairs and unfamiliar with things generally over at the city hall. That is not likely to happen, but it could.

Be that as it may, a full roster of city officials is to be elected on November 3. Although none of the city jobs carries a particularly attractive salary, it is not likely any of them will go begging for candidates.

## Ram Sale Coming Up

**A** K important event at the top of the September calendar is the Southern Oregon ram sale, scheduled for Klamath Falls next Tuesday.

The fact that leading ram breeders of the west have made liberal consignments to this sale is evidence of its recognition among livestock men as an outstanding event. It gives range sheepmen of northern California, southern Oregon and northwestern Nevada an exceptional opportunity to look over choice animals and to fill their flock needs at their own price.

The California Wool Grower, one of the best read magazines of the kind in the country, this week carries a cover page advertisement of the Klamath sale, and in its news section features first of all the list of ram breeders consigning to this sale and the various pen lots. It is noteworthy that Klamath Falls is the location of an event of this magnitude and of such interest among stockmen, and it demonstrates the importance of the sheep industry in our surrounding territory.

## A Hard Worker

**I**N the untimely and unfortunate death of Secretary of War George H. Dern is a warning to those who "don't know when to quit."

They say that about Mr. Dern. For years he worked night and day, never giving himself sufficient time for rest or relaxation.

Mr. Dern was a one-time Nebraska football star. He started work as a clerk for a mining company in Utah, and fought his way to the governorship of that state, which he won in 1924.

Associates of his days as governor of the state say that Mr. Dern turned night into day at the executive offices. He put in long, hard hours for the state. It won him honor and acclaim, and a place in the cabinet. But he neglected his health for years, and death cut off his career, six years before he reached his three-score and ten.

## WASHINGTON

NEWS BEHIND THE NEWS  
 The Inside Story From  
 The Capital

**WASHINGTON, Aug. 27.**—About 70,000,000 persons were of voting age at the time of the last presidential election. Only 47,000,000 went to the trouble of registering so they could vote, and only 41,000,000 actually voted. This was 62 per cent of the eligibles, the highest percentage of all time. (Only fifty per cent voted in 1920.)

What these figures emphasize to the practical politician is the necessity of organization. Political organizations get their voters registered and deliver them at the polls on election days.

The non-organization voter may have had the coupon on registration day or may develop something like that on election day, but the organization voter will be at the polls, rain or shine, headache or not. In politics, organization counts.

**START** Chairman Farley has spent five years building what is generally believed to be the best organization in the history of American politics.

It reaches down from the White House to the policeman on the beat, just as did the old republican organizations, but it is better financed, has more direct and indirect beneficiaries on the rolls.

Chairman Hamilton took over 60 days ago, a skeleton republican organization, only partly rebuilt. This reorganized headquarters has been functioning only for about 30 days. During that time, the vastness of the problem of organization, and the importance of it, are said to have impressed all who are working on his side.

While the democratic headquarters expanded for the campaign only by taking on people at the bottom, republican expansion at the top has developed growing pains. The result is the republicans have been having a hectic time trying to catch up in technical routine. This tells the story of the current political situation better than any poll could.

Note—As an example of democratic organization progress, a certain federal official in Washington notified the national committee here the other day that he had registered in his state and was preparing to vote. Two days later he received instructions of where and how to vote, what the state laws were, how long the polls were open, what trains to catch to go there, etc.

**FRIENDLINESS** The announcements indicated that all President Roosevelt and Senator Glass did was to exchange knock-knocks, and that really was about all.

Afterward, the caustic Virginian slipped away from the question whether he would make any speeches for Mr. Roosevelt, by saying he had not been asked.

The answer is, he won't be. As everyone here knows, there is not much Glass could say on the stump. His views vary from administration policies in so many particulars that he would be willing to say might not be effective. A newsman observed that the senator had made the best speech on either side in the 1932 campaign, in defense of sound money and budget balancing.

Senator Glass murmured his thanks, whereupon the newsman then asked: "Why don't you make the same speech again?"

The Virginian's response was to the effect that he did not think they would want that speech again.

About all the new dealers can do with Glass is to promote the appearance of personal and political friendship.

The White House meeting was arranged for that purpose.

Note—All Mr. Glass would talk about later was the newsman who wrote that Glass had emphasized the word "professed" when he introduced Mr. Roosevelt as a "professed Jeffersonian democrat" at Monticello recently. Glass convinced his hearers there was nothing subtle in his choice of words, by pointing his arrowed finger outward and asking: "You wouldn't think there was anything wrong if I introduced you as a professed Christian, would you?"

**FORGERY** The democratic national committee is said to be willing to give a Roosevelt nomination but free to anyone who finds out who sent that telegram to Congressman Blanton and signed Chairman Farley's name.

One suspicion is that Blanton sent it to himself, or had a friend do it, as he is the only one who would benefit by a Farley endorsement delivered on the day of his primary.

Another story is that someone at national headquarters sent the telegram, that the great ghost Mr. Michelson discovered it next day and had Farley deny it—after most of the citizens of Blanton's Texas district had voted.

The truth seems to be that the son of a democratic congressman did it as a more or less practical joke while experimenting personally with the problem of inebriation.

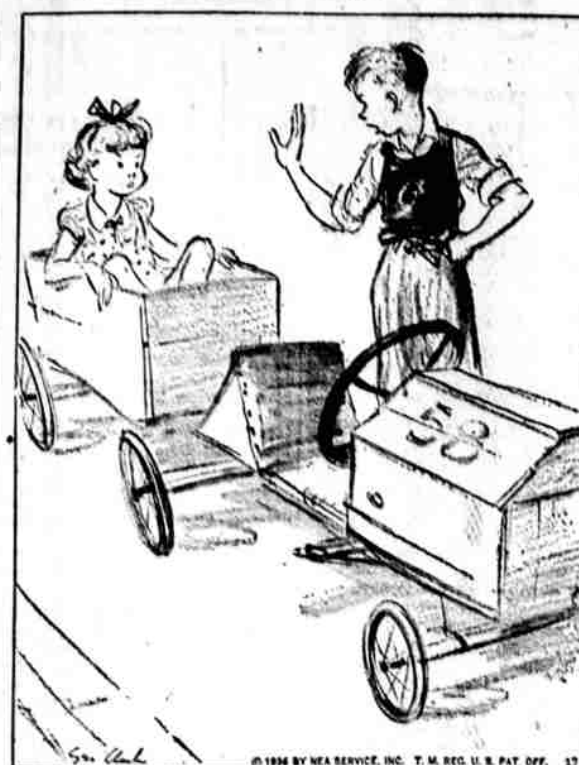
**REPUTATION** Michelson told a dinner party of friends recently that he was fortunate. He sized his situation up accurately this way:

## Ten Years Ago

In Klamath

**S**WEEPING through Klamath's underworld this morning and early afternoon, police, deputy sheriffs, state prohibition agents and federal officers combined in one of the biggest liquor raids ever staged in southern Oregon.

Carloads of alleged violators of the prohibition law were brought into the courthouse by the liquor sleuths and locked up in prohibition headquarters of the city. While officers hurried back to continue the wholesale liquor raid, which it is declared, will include every liquor dispensary within the boundaries of Klamath Falls.

Virtually every man wearing a star in Klamath Falls mobilized in the county courthouse shortly before 11 o'clock this morning. Instructions were issued to the waiting sleuths, and at a given signal the officers jumped into a number of automobiles, and armed with more than 30 search warrants, hurried to their task.

Twenty-eight men and women were taken in the raids up to 2 p. m., and the number will probably be increased to 35 before the sun sets.

Tangible evidence of the increase in population and prosperity that may be expected here as a result of the railroad activity is the statement of local railroad officials that by September 15 a total of at least 75 men, most of them with families, will arrive to take over handling of the Southern Pacific shops, trains and yards here.

**CORVALLIS, Ore., Aug. 27 (AP).**—Mrs. Clark P. Terwilliger, a cottage matron at the W. C. T. U. home three miles east of here, was instantly killed last night when struck by a car.

Mrs. Terwilliger, believed to be about 60, was hit when she stepped from behind a bus from which she had just alighted. The accident occurred in front of the home on the Albany-Corvallis highway.

**PORTLAND, Aug. 27 (AP).**—Historic Council Crest passed into the hands of the city yesterday.

The city council passed an ordinance providing for exchange of an old fire station for the property and shortly thereafter the House Investment company, owner of the property accepted the offer.

**GRANTS PASS, Aug. 27 (AP).**—Directors of the Redwood Empire association have selected Crescent City, Cal., for their 1936 convention, October 9 and 10. The association has a membership from eight California counties and Josephine county, Oregon.

**HILLSBORO, Ore., Aug. 27 (AP).**—Congressman William Lemke, presidential candidate of the union party, will be on the Oregon ballot this November.

He was nominated as an Independent by a convention here last night attended by 400 persons, 150 more than required by law. Thomas C. O'Brien, union party vice-presidential nominee, was named as his running mate.

**PORTLAND, Aug. 27 (AP).**—John F. Logan, Portland attorney, resigned as chairman of the municipal civil service board yesterday after serving in the position for 20 years. He retained his membership.

**BAKER, Aug. 27 (AP).**—A large number of cars from the mid-west bearing household goods have been spotted here this summer.

Registration of out-of-state cars at the Baker office has shown a marked increase over last year, 551 machines being registered in July as compared with 346 last July.

**GOLD BEACH, Aug. 27 (AP).**—Another flame was added to the growing list of independent candidates for the state legislature, Mrs. Rhoda Burkhardt, North Bend.

Mrs. Burkhardt, wife of Arthur Burkhardt, North Bend longshoreman, announced her senatorial candidacy at a Townsend meeting here. Her opponents are Ben H. Chandler of Marshfield, republican, and George Chaney of Coquille, democrat.

**PORTLAND, Aug. 27 (AP).**—Portland was saddened today by the death of Lawrence A. McNary, 70, member of a distinguished Oregon family and prominent Portland attorney, after a three-week illness. He died at 4:30 p. m. yesterday.

Senator Charles L. McNary and Federal Judge John McNary are cousins.

McNary was born in The Dalles. When he was 12, his father, Hugh M. McNary sold his ranch and moved his family to Salem. The boy attended the Salem public schools and Williams ette university and then came to Portland where he entered the firm of Richard and Emmett Williams and C. H. Carey. He completed his course at the University of Oregon law school in 1909 and was admitted to the bar the same year.

From 1902 to 1907, McNary served as city attorney, otherwise his law career was uninterrupted. His spare time he devoted to studying American history.

**PORTLAND, Aug. 27 (AP).**—Likelihood of the state legislature having to settle the county-state dispute over distribution of funds accruing from motor vehicle license fees and gasoline taxes loomed strong today.

State and county representatives conferred here yesterday but were unable to reach any agreement.

State representatives, headed by Chairman Henry F. Cabell of the highway commission and Lt. H. Haddock, highway engineer, asserted that efforts of the state to get federal funds would be crippled if more funds were given the counties. Federal money will be distributed on a matching basis starting next year, they pointed out.

**PORTLAND, Aug. 27 (AP).**—Three Portland Y. M. C. A. boys hiked over the southern end of the Oregon Skyline trail today, initiating the start of relay hikes which will traverse the length of the state in the Oregon section of a Y. M. C. A. hike from Mexico to Canada.

The Oregon contingent picked up the trail at Beswick, Calif., where it was carried by California boys, and will take it on to Astoria, where Washington youths will complete the three-day hike.

Eugene Farnham, John Botsford and Steve Hanson were hiking over the leg from Beswick to Four-Mile lake, Oregon, where another group of boys will pick up the trail, carrying it northward to other relay points.
