

PLANE WRECK FOUND BURNED ON MOUNTAIN

LOS ANGELES, May 19 (UP)—A theory that a new Lockheed airliner was groping through a blinding fog for an emergency landing field when it crashed into a mountain slope was advanced today after the bodies of its nine occupants were brought out of the wilderness of the Sierra Pelona mountains.

The \$30,000 plane, missing since Monday afternoon when it took off on a flight to St. Paul, was found splintered and burned against the side of Mt. Stroh, 50 miles north of here. Death apparently had come instantly to all on board—three men, four women and two children.

Hurled Into Peak

Only a few miles away is an emergency landing field, hemmed in by rugged mountains. Investigators said it was likely that Pilot Sidney Willey, with zero visibility, was seeking this haven when his big ship hurtled into the peak at 200 miles an hour and exploded.

Inspector Joe Merriott of the department of air commerce, after examining the two demolished motors, said engine trouble had not been responsible. The clock on the shattered instrument panel had stopped at 2:07 p. m., exactly 27 minutes after the plane took off from Union Air terminal.

The plane struck with such suddenness that the pilot had no chance to cut the ignition. One engine was sheared off. It rolled 150 yards down the mountain. The splintered fuselage was strewn along a 500-yard blackened path before coming to rest in a clump of yucca and cacti. All but two bodies were hurled out by the impact. Those of the pilot and a woman were still in the wreckage, the woman's body so tightly wedged in the ruins that rescuers had to saw through the framework to extricate it.

"CHRISTUS" OF OBERAMMERGAU'S PASSION PLAY DIES

OBERAMMERGAU, Bavaria, May 19 (UP)—Anton Lang, 63-year-old bearded patriarch of the Alps who for 22 years played the role of the Christus in Oberammergau's famous Passion play, died last night.

Lang, a wood carver and pottery worker whose unstudied acting ability won world-wide acclaim, gave up the role of Christ after the 1922 performance. The Passion play is scheduled once every 10 years, although the presentations have not always followed the decade.

Rejecting offers to capitalize upon his role in motion pictures, he lived in the little Bavarian town working at wood-carving and pottery making, the Lang family occupation for generations.

He was simple and devout. In 1922 he visited the United States where he was lionized. He delivered several lectures there.

The "Christ of Oberammergau" died in a hospital in nearby Munich at 11 p. m. after an operation for a stomach ailment.

He played the "Christus" in 1900, 1910, and 1922 and spoke the prologue for the outdoor performances in 1930 and 1934. He was chosen to deliver the prologue at the next performance, in 1940.

He was succeeded in the role of Christ by Alois Lang, no relation. His son, Anton, Jr., in 1934, married the "Mary Magdalen" of the play, Klara Mayr.

MARTIN 10 TO 8 BETTING FAVORITE AS ELECTION NEAR

PORTLAND, Ore., May 19 (UP)—Gov. Charles H. Martin, seeking democratic renomination in Friday's primary elections, was quoted as a 10 to 8 favorite here today to defeat his principal opponent, Henry L. Hess, La Grand attorney and a former state legislator.

The campaigns today had less than a day to go, and activity perceptibly diminished. But the air was filled with predictions in the gubernatorial battle, and it was believed by many that Martin may be narrowly defeated in Multnomah county, containing Portland and a third of the state's voters, but that he would win the nomination by virtue of strong upstate support.

In a radio address last night, Hess labeled Martin as anti-New Deal and anti-Roosevelt, and claimed that the national administration had repudiated the governor in favor of himself. The speaker denied he was labor's representative, although he admitted its support.

Both Hess and Martin will take to the other in final talks tonight.
