Keep Off Upper Klamath

TRAGEDY or near-tragedy, recurring every winter on Upper Klamath lake, is ample evidence that there is no real safety on the ice of that expansive body of water.

The two youths who drowned in the lake Thursday night were experienced skaters. They were aware of the location of potholes and warm channels. But they ran into tragedy, skating in the dark on ice that had been thawing during the previous day.

Previously, two youths had fallen into the ice, and on Wednesday of this week a high school boy was pulled from a pothole. Last year, there were several incidents of the kind, and in the winter before that there was a drowning.

This is cumulative evidence of the danger that exists. Despite claims to the contrary by devotees of upper lake skating, the lake is not safe and those who venture out on the ice are not only endangering their own lives, but the lives of others who may be called into rescue efforts.

The lake is a public place and there is no law against skating there. But common sense and consideration for those who may be called upon to attempt dangerous rescue work point to the definite advisability of keeping off.

Ice skating is a fine sport and its followers would do well to work out plans for developing an absolutely safe skating area here. Upper Klamath, under natural conditions, is not such a place.

Aberdeen Motives

UP at Aberdeen, Wash., CIO Leader Dick Law, whose wife was brutally murdered, issued a statement Thursday blaming the killing on "those forces that have been trying to destroy the labor movement, democracy and civil liberties in Aberdeen and on the Pacific coast."

He gave the names of 10 men he claims should know something about the murder, including business men and members of the American Federation of Labor.

The charge that labor strife had something to do with the murder of Mrs. Law has been bandied about since the time of the finding of her body. If there is the slightest basis for such a suspicion, the possibility should be thoroughly investigated. But even though feeling must run high in the Gray's Harbor district to justify even mention of such a theory, it seems like an improbable method of fighting a labor war.

The Family Doctor

Orthopedic surgeons have been giving a great deal of consideration to the feet, particularly since feet are being used less than they were before the coming of the automobile.

Once the small foot was admired not only by the Chinese but by American women. Now it is recognized that a foot ought to be proportionate to the rest of the body, and that a foot too small for the rest of the body is really a deformity.

Women pay much more attention to the covering of their feet than do men. In a perfectly rational world, women would wear the same type of shoe for all purposes. But, nowadays, women wear low-heeled shoes for walking, something with a slight heel for sports, and a high-heeled shoe for dancing. Dr. Emil Hauser says that it would be just as ridiculous for a woman to wear hiking shoes on a ballroom floor as it would be for her to wear high-heeled slippers for sports. Others insist, however, that high-heeled shoes are objectionable at any time.

Great changes have also come about in the kind of stockings that are worn. Women used to wear heavy cotton, hose, and occasionally silk stockings. Now there is silk for all purposes, except when rayon is used as a substitute. Wool hose have practically disappeared except for skiing and skating. There are also combinations of silk and wool. Cotton has almost disappeared as material for stockings. Most important in relationship to stockings, however, is the elimination of wrinkles and worn places, and also frequent changing.

Few people stop to consider the importance of proper hygiene in relationship to coverings for the feet worn at home. House slippers are useful, but they do not provide a substitute for regular shoes. The arches of the feet are weak, house slippers which do not provide adequate support will increase the difficulty.

Proper hygiene for the feet demands adequate rest and suitable exercise. There is a tendency, as we grow older, for the valves of the veins to break down and for the blood to become static in the legs. Elevation of the feet at frequent intervals during the day is a hygiene measure, particularly for those who lead sedentary lives.

Sale of Butte Valley Weekly Announced Here

Purchase of the Butte Valley Star, one of the few remaining newspapers printed from hand-set type, was announced here Thursday by the new publisher, Glenn A. Thomas, assistant foreman of the Klamath Falls News and Herald.

In partnership with his son-in-law, Ed DeLap of Klamath Falls, Thomas will install new machinery next week in the offices of the Dorris, Calif. weekly, and publication under the new ownership will begin February 1.

The transaction was completed Wednesday with Mrs. Little McDonald, who has operated the paper since the death of her husband five years ago. McDonald founded the Star in 1926. The newspaper, published Thursday evenings, is set up entirely by hand and printed on one of the old type country Camel presses.

Thomas and DeLap will install a linotype, a News press and a folder. They will also equip the plant with machinery for commercial printing.

Lawrence Jenson Of Tulake Dies

TULAKE — Lawrence Jenson, 53, owner of the Crater Lake Hardware company building and the Shasta Lunch, died at Tulake at 7:50 a. m. Thursday. He had been found a few hours earlier lying unconscious on the floor of the Shasta Lunch, and had been in poor health for some time. George Williams, Tulake, found him in an unconscious condition.

Jenson came to Tulake from Dorris, Calif., in 1934, where he had been in business and was well known. His only known relative is a nephew said to be living in the east.

Funeral services will be held Monday at 2 p. m. at the Nazarene church in Dorris, under direction of Deputy Sheriff Roy Dysert of Tulake.

News Behind THE NEWS

WASHINGTON, Jan. 18.—Ideas for helping South America have been falling out of the skies here as thick as Russian parachutes—especially when the wind is from the south. The largest package to arrive in this manner lately is the program for a new all-American bank. While the preparations for creating such a bank are being kept exceptionally secret for some reason or other, the federal reserve board and the treasury already are at work on by-laws for it.

Announcement of its inauguration may be made within two weeks. It seems to be strictly a latin notion of what an "all-American" bank should be. That is capital will be contributed on basis of population, and as the United States has about one-half the population of the Americas it will put up half the money (capitalization suggested is \$100,000,000).

No suggestion has yet been made that Uncle Sam get one-half the benefits of the institution, which apparently is designed primarily to finance industrialization of latin countries. If the bank furnished funds to start a mining venture in Mexico, for instance, it would be in effect financing competition with American mining industries. This is true also of proposed steel mills, and other industrial activities. The agents of FRB and treasury are trying to work out the by-laws to make sure Uncle Sam does not become Uncle Sap.

MEXICO WISTFUL

An even larger package of ideas has drifted in from Mexico—so large indeed that Mexican Minister Suarez was reported concealing inside it. This program, according to fairly trustworthy inside information here, contemplated an advancement to Mexico of \$10,000,000 to \$20,000,000, half immediately and half later, to finance completion of the Pan-American highway below Mexico City.

A second sprightly suggestion was that a loan be made by this country to build a port on the west Mexican coast, large enough to be used as a base for the American fleet in time of emergency. Beyond this Mexico would also like to have a new silver agreement whereby the United States would buy the Mexican production at the market price (some reports say 50 cents). The Mexicans also want the same preferred treatment for oil which has been granted to Venezuela.

Few if any of these recommendations are likely to be adopted. The treasury has denied insistently, for instance, that a new Mexican silver agreement is in the making. However, the incidents suggest again that the good neighbor policy is going to be expensive.

F. R. KNOWS ABOUT IT

VETERAN OFFICIAL OF STATE PASSES

SACRAMENTO, Jan. 19 (UP)—Frank C. Jordan, 79, dean of the country's secretaries of state, died yesterday in Mercy hospital of uremic poisoning. He had been in public office for more than 40 years.

The veteran state official, who took the office of secretary of state in 1910, was in a complete coma for several hours prior to his death at 3:30 p. m. PST.

His condition had been so grave Gov. Culbert L. Olson had not been allowed to see him in several visits to the hospital.

Jordan entered the hospital New Year's eve for a rest and examination and later underwent a bladder operation. His condition became steadily worse, complicated by his advanced age and a hardening of the arteries.

Funeral services will be held Saturday at 2 p. m. in the assembly chambers of the state capitol. State Sen. Herbert Slater of Santa Rosa, lifelong friend of Jordan, will deliver the official eulogy and Rev. W. H. Hermitage, Sacramento Episcopal minister, will conduct the religious services.

Governor Olson will cut short his trip to the California Newspaper Publishers association meeting at Coronado Friday night to return for the funeral. All state employees in California will take a holiday Saturday.

Attorney General Earl Warren ruled no official business could be conducted by the secretary of state's office until Jordan's successor is named. Although Jordan had been inactive for several weeks, his assistants operated in his name, and his death removed that constitutional power.

Jordan started his political career in 1900 as private secretary to State Senator Henry Vrooman. Later he became Alameda county clerk and clerk of the state supreme court.

Governor Olson, grieved at the death of the stateshouse patriarch, issued a statement which said:

"The people of California have lost one of their most outstanding and colorful citizens with the passing of Frank C. Jordan, and I have lost a true friend."

"For many years, Jordan served the people of this state honestly, faithfully and efficiently. His outstanding record during the 29 years he served as secretary of state has been one which few public officials can equal."

Governor Olson must appoint a successor to fill out the unexpired term ending December 31, 1942. There was a speculation whether he would choose either of Jordan's two sons, Assistant Secretary of State Robert V. Jordan or Deputy Secretary of State Frank M. Jordan. Both are republicans as was their father, while Olson is a democrat.
