

NAZIS PREDICT FINISH BATTLE HITLER'S PLAN

and abroad did not know even where the meeting was being held.

The cold, snowy streets of blacked-out Berlin were devoid of demonstrations.

Noises frequently interrupted reception of the speech in the United States, and some American radio engineers said they believed this was due to "deliberate jamming" from some unidentified source.

BERLIN, Jan. 31 (AP)—Germany reported today that her air force in two days' intensive raiding of shipping off Britain's coasts destroyed a total of 18 vessels, nine Monday and the same number yesterday.

Today's high command communiqué, recounting Nazi raiders' achievements yesterday—when Adolf Hitler was promising the allies the war "they wanted"—said "again seven armed commercial ships were sunk" in addition to "two British patrol ships."

It also reported another ship "damaged severely and several lightly" and told of strengthening of Germany's defenses against enemy submarine raids.

Yesterday's communiqué reported "seven armed merchant ships and two patrol boats were destroyed" by German airmen Monday.

(The British have named six ships sunk in the wave of off-shore bombing attacks and told of numerous others that escaped destruction.)

FEDERAL BUILDING REPAIRS NEARLY COMPLETE HERE

Postoffice patrons have noticed the construction work going on around the federal building. The contract to make numerous repairs to the building was let to the Brosthouse Construction company at an estimated figure of \$4500.

The work includes replacing a number of tiles on the roof, re-laying the flat roof, re-laying wooden block floor in the post-office proper, replacing some 20 squares of concrete and paving the driveway with a two-inch blacktop, and painting the outside of the building.

The driveway blacktop will not be laid until later in the spring, it was learned. Virtually all other work has been completed. The wooden block floor has been re-laid throughout the building with the exception of the financial division.

country on the reciprocal trade agreements program."

"This propaganda," he said, "is a mixture of bad economic theory and a definite misrepresentation of facts and figures."

"The sooner we admit that world peace is not to be won by means of world trade, and realize that foreign nations are going to purchase from us those products they need and can buy from us more cheaply than others, rather than the products they hope to sell because we have an excess, the better off this country will be."

After asserting that the trade program should be continued, Compton said:

"We think, however, that it should be restricted by statute to a more clearly defined range and not with such wide open administrative discretions as heretofore."

pulled the trigger. The bullet pierced the boy's heart and he died instantly. Vernon had been standing only a short distance away.

The excited little boys placed "Teddy" on a toy express wagon and went for help.

Vernon's father, coming home from work, happened by immediately after the tragedy. He and Mrs. Hunter started to the hospital with the child, who died about the time the car reached Sixth street. The car was driven by a neighbor.

The body was taken on to Hillside hospital, where Dr. George H. Adler, coroner, made an examination. He said the boy was shot through the heart and death was almost instantaneous.

Sheriff Lloyd Low, who made an investigation, said the weapon had apparently been charged only a few feet from where the Lundsten boy was standing.

Officers said that Vernon, described as an extremely bright youngster, was badly broken up over the tragedy.

"Theodore was my best friend," he told Sheriff Low. "We always played together." The Lundsten home is five houses north of the Hunter's on Ward lane.

The tragedy occurred about 5 p. m.

The body was removed from the hospital to Whitlock's funeral home, where funeral arrangements were to be announced Wednesday.

Investigators said that the families of the two boys are mutually grief-stricken and that a fully sympathetic understanding exists between them.

buy and windjammers could bring around the horn. It had a balcony on which waited 200 women to drink with a lonely logger. And art? It had the "Slave Market" which on first glance looked to be at least half an acre of very rich oils depicting sale of black chattel.

Jim O'Reilly was the bouncer at Erickson's and when opportunity and patrons permitted he recited Shakespeare.

Over this grandeur presided medium-built Gus Erickson, the founder and "the friend of man." Erickson did nothing in a small way. His free lunches were the biggest and best in the country. The soup kitchen he set up when times got bad in 1923-24 served whole beavers, deer, sheep and pigs. He went broke in the grand manner when the lure of horseracing grew too strong.

Gus lost the place in 1935 but his best days were already behind him. It wasn't much more than a "hollow shell" when prohibition converted it into a denatured card room and later when it became a 3.2 emporium.

Tom looked down the block at the array of inns and taverns with their modern fronts and neon, and snorted:

"The whole kit and kaboodle of them don't take in chicken-feed compared to Erickson's. Wasn't nothing for Erickson to bank \$15,000 of a morning."

He places and at work increased one per cent to 27,000, deaths from burns increased eight per cent to 5000 and drownings decreased 11 per cent to 6700.

The estimated economic loss from all accidents included wages lost, medical expenses, the overhead costs of insurance and property damage in motor vehicle accidents and fires.

Klamath Falls residents have not taken advantage of the "open all day Sunday" plan at the county gravel pit and in the future the gravel will be obtainable only on week days. Persons within the city of Klamath Falls must obtain permission from the city engineer in the city hall. Those outside the city limits are asked to see the county engineer in the court house, or the mayor of Merrill, Tom Card.

Arrangements were made previously at the county pit for persons desiring gravel to fix up streets and driveways, and a man was kept at the gravel pit to operate the steam shovel all day Sunday. This past Sunday the shovel was in operation throughout the day and two persons visited the pit for gravel.

FINAL 1939 REPORT OF POSTOFFICE OUT

The final figures on the year's business at the Klamath Falls postoffice were issued Wednesday by Postmaster Burt E. Hawkins.

During the entire year, 1939, receipts totaled \$132,230.93, or a gain of 6.957 per cent over 1938. Receipts for that year totaled \$123,629.49, or a gain over the previous year of 3.847 per cent.

During the last quarter of 1939 receipts totaled \$41,044.82, or a gain of 10.136 per cent; December receipts, \$18,296.57, or a gain of 7.087 per cent.

October, 1939, showed the heaviest gain of any month in the year. Receipts were \$12,409.26, or a gain of 20.829 per cent.

WOOL MARKET

BOSTON, Jan. 31 (AP-USA)—Little domestic wool was moving in the Boston market today. Quotations were somewhat irregular, tending lower. Country-packed offerings of mixed three-eighths and quarter-blood bright fleece wools were quoted at 41 to 42 cents, in the grease, delivered to users, and very little demand was being received. Some graded combing quarter-blood territory wool was being offered at prices slightly under 75 cents, scoured basis, although a few houses were not willing to accept prices that low.

CHOIR SLATED FOR CONCERT HERE TONIGHT

Some sixty students, with their director and business manager, will arrive from the north early Wednesday evening to appear in the St. Olaf choir concert in the Pelican theatre tonight at 8:15 o'clock.

The concert is being presented by the Klamath Lutheran church and ticket sellers reported an excellent response today.

Directed by Dr. Mellus Christensen of St. Olaf college, the choir will sing compositions from the old masters, and also several of Dr. Christensen's own numbers.

Dr. Christensen, composer and director, occupies a unique position among the great masters of chorale. On the many national concert tours of his choir, critics and audiences have hailed him as a wizard of the baton, and the performances of his singers have been termed the near ultimate in technical perfection and emotional appeal.

As a musical educator and rediscoverer of new paths in choral music, Dr. Christensen is known throughout this country and in Europe. A veritable renaissance of choral music in America has been started by his influence. His own compositions have taken their place as a permanent addition to the classic literature of choral art, and in the St. Olaf choir he has built up a standard of performance worthy of the high quality of its programs.

ing of shells at a rate faster than in 1914.

Of neutral countries Chamberlain said Britain had no desire "to affront a neutral country with which we want to live in peaceful and friendly relations." Giving a detailed picture of the many phases of Britain's war effort, Chamberlain declared: "Not a single non-belligerent country feels itself threatened by this enormous power."

Chamberlain asked neutrals to consider that though the exercise of belligerent rights causes them inconvenience and loss, "we have never sunk a neutral ship. And we have never wittingly sacrificed a single neutral life."
