

BROWN ENTERS GOP PRIMARY FOR SHERIFF

Ross H. Brown, former Klamath county deputy sheriff and a farmer of the Henley district, on Thursday declared his candidacy for the republican nomination for sheriff.

Brown's statement follows: In announcing my candidacy for sheriff on the republican ticket I make the following statement of my experience and qualifications.

I was born in Kansas and lived there and in Oklahoma until I joined the army in 1917. I served twenty-seven months overseas, eleven months of which were spent as sergeant with the intelligence group in the second battalion, 16th infantry of the First division.

When I returned from France I came to Klamath Falls where I have made my home. I am married and have three children. I served two years on the Klamath Falls police force and six years as criminal deputy of Klamath county under Sheriff Low. In 1934 I resigned from this position to operate my farm in the Henley district.

I am running for this office because I believe, that with my background of experience and residence here, I can effect certain benefits for the people of Klamath county.

YOU can now bring back \$5 worth per person on the same day you entered—if you don't do it too often. If you buy more than \$5 worth, you have to stay 24 hours in Mexico before you are allowed to bring it over the line.

The Mexicans aren't dumb. The better stores in Tijuana have clubbed together and subsidized a hotel down at Santa Rosarita, 15 miles down the beach, and if you buy more than \$75 worth at any of these stores you get a free night's lodging, thus enabling you to return legally to the American side.

Except for the customs, there are no restrictions and people having legitimate business (including sight-seeing) pass back and forth across the border with about the same ease and informality as they pass from one state to another.

AS a matter of fact, it's EASIER to get from Mexico into Texas than to get into California at Yuma.

Income Taxes Well Above F. R.'s Budget Estimate

WASHINGTON, March 21 (AP)—Secretary Morgenthau said today that preliminary estimates of annual income tax collections were running 31.2 per cent ahead of last year and "comfortably ahead" of President Roosevelt's budget estimate.

The treasury secretary said at a press conference that telegraphic reports from regional collection offices showed collection of \$621,000,000 of income taxes in the first 20 days of March, compared with \$473,000,000 in the same period last year.

March collections are always the biggest for income taxes because annual returns and at least first quarter installment payments are due on March 15.

Morgenthau declined to say by what margin the collections would exceed budget estimates, which are made only on an annual and not a monthly basis, but added that there was "not a chance" of the excess equalling the \$460,000,000 of additional revenue asked by the president to pay for emergency national defense costs and to help keep the treasury under its \$45,000,000,000 statutory debt limit.

Cromwell's Recall Demanded by Solon

WASHINGTON, March 21 (AP)—Recall of James H. R. Cromwell, the American minister to Canada, was demanded today by Rep. Tinkham (R-Mass.).

In a letter to Secretary Hull, Tinkham said that Cromwell, husband of the former Doris Duke, had violated President Roosevelt's neutrality proclama-

tion by recent speeches denouncing German and praising the allied cause. "Mr. Cromwell has made two offensive and disloyal speeches in Canada recently," said the Massachusetts republican, a member of the house foreign affairs committee. "The speeches were intended to incite the American people to enter the present war in Europe and were seditious utterances."

Highways Watched For Suspect in Cupboard Killing

SEATTLE, March 21 (AP)—Officers watched the highways today in the search for the accused son of Seattle's "cupboard killing" victim.

Sheriff's officers received a report a man resembling the general description of Donzel Davis, 23, slept Tuesday night in a barn near Monroe, about 30 miles northeast of here. They expressed the belief that if it were Davis, he might be

heading toward Montana. The body of his mother, Mrs. Harriett Arnold, 45, was found Tuesday nailed in a cupboard of her suburban bungalow. She had been stabbed 18 times, beaten over the head, garroted and trussed with electric cords and a dog chain.

DETROIT, March 21 (AP)—A special federal grand jury today indicted 13 organizations and 18 individuals for alleged anti-trust law violations in the electrical contracting business and charged that agents for an electrical workers' union were paid to hamper work attempted by contractors who refused to join the combination.
