

GOP MAN SAYS NEW DEAL NOT AMERICAN WAY

tured panics. The president's attacks on foreign powers have been useless and dangerous. He has courted a war for which the country is hopelessly unprepared—and which it emphatically does not want.

"Meddling" Hit
"He has secretly meddled in the affairs of Europe, and he has even unscrupulously encouraged other countries to hope for more help than we are able to give."

Willkie declared this country must face "a brutal, perhaps a terrible fact" . . . that "our way of life is in competition with Hitler's way of life." The competition, he said, is one of "energy against energy, production against production, brains against brains, salesmanship against salesmanship," not merely a contest of armaments.

"If we are to outdistance the totalitarian powers," he continued, "we must arise to a new life of adventure and discovery. We must make a wider horizon for the human race. It is to that new life that I pledge myself."

The republican nominee declared that the "promises of the present administration cannot lead you to victory against Hitler, or against anyone else."

Then he proposed that in the next two and a half months, he and Mr. Roosevelt appear together in various parts of the country to debate "the fundamental issues of this campaign."

Issues Listed
Willkie listed these issues as problems of domestic economy—agriculture, labor, industry and finance—as well as problems of national defense.

"And also I would like to debate," he said, "the question of the assumption by the president, in seeking a third term, of a greater public confidence than was accorded to our presidential giants, Washington, Jefferson, Jackson, Lincoln, Cleveland, Theodore Roosevelt, and Woodrow Wilson."

Principles Opposite
Coupled with Willkie's criticism of new deal foreign policies was a denunciation of its domestic program.

"This administration stands for principles exactly opposite to mine," he said. "It does not preach the doctrine of growth. It preaches the doctrine of division."

"We are not asked to make more for ourselves. We are asked to divide among ourselves that which we already have. The new deal doctrine does not risk, it seeks safety. Let us call it the 'I Pass' doctrine."

France Cited
He termed the new deal's viewpoint "exactly the course France followed to her destruction," and added:

"As in France, so here, we have heard talk of class distinctions and of economic groups preying upon other groups. We are told that capital hates labor and labor capital."

But Willkie asserted "there is no hate in my heart," and said he stands "for a new companionship in an industrial society."

Appearing before an audience that included not only many childhood friends from his home town but persons from all parts of the middlewest, Willkie began his address with an appeal for the "preservation of American democracy."

Party Lines Down
He recounted the fact that his ancestors were "humble people" in central Europe, his grandparents lived in Germany and having fled to the United States when "democratic revolutions" in that country failed.

Declaring that "party lines are down," he said:

"Nothing could make that clearer than the nomination by the republicans of a liberal democrat, who changed his party affiliations because he found democracy in the republican party and not in the new deal party."

Agrees With F. R.
Turning to the European situation, he said he would pledge wholehearted support to the president in whatever action he might take on two principles, quoting Mr. Roosevelt as follows:

"We will extend to the opponents of force the material resources of this nation, and at the same time we will harness the use of those resources in order that we ourselves, in the Americas, may have equipment and training equal to the task of any emergency and every defense."

He said, however, that he could not follow the president in his conduct of foreign affairs. Willkie declared that if the British fleet were lost or captured, "the Atlantic might be dominated by Germany, a power hostile to our way of life."

"This would be a calamity for us," he said. "We might be exposed to attack on the Atlantic."

Our defense would be weakened until we could build a navy and air force strong enough to defend both coasts.

"Also our foreign trade would be profoundly affected . . . We might have to change our methods to some totalitarian form."

Willkie said he would not analyze the conscription legislation now before congress or examine the administration's intentions in that regard, but he asserted that the latter should be closely watched.

Selective Service
"Nevertheless," he said, "in spite of these considerations, I cannot ask the American people to put their faith in me, without recording my conviction that some form of selective service is the only democratic way in which to secure the trained and competent manpower we need for national defense."

Fixed Principle
"No man," he continued, "can guarantee to maintain peace . . . In the foreign policy of the United States, as in its domestic policy, I would do everything to defend American democracy and I would refrain from doing anything that would injure it."

"We must not permit our emotions—our sympathies or hatreds—to move us from that fixed principle."

The first task of the United States in its international affairs, Willkie asserted, "is to become strong at home. We must regain prosperity, restore the independence of our people, and protect our defensive forces. If that is not done promptly, we are in constant danger. If that is done, no enemy on earth dare attack us. I propose to do it."

takes place within 30 days preceding the election, or in other words, during the period the registration records are closed the elector may upon application to the county clerk's office obtain a certificate authorizing him to vote in the new precinct.

"In publicizing the laws on this subject at this time I feel that you will be rendering a valuable service to many persons who would have no intention whatever of violating any law, but who should register before the November 5 election in order to avoid the possibility of being charged with a technical infraction of the election statutes."

Heavy Movement
Because of the heavy movement of local residents from one part of the city to the other, or from the city to the suburbs, it is believed the registration books contain large numbers of improper non-resident registrations.

County Clerk Mae K. Short pointed out Saturday that adjustment of registration, in this particular, can best be handled at this time of year, rather than in the last few days before registration closes prior to the November election.

Depending on Voters
"We must depend upon voters to correct their registration when they move from one precinct to another," said Mrs. Short. "It obviously is not possible for this office to keep up with such movements. We are anxious to make the corrections as fast as we are notified of change of address by voters, and this can best be done at a time when our office is not congested with pre-election business. At this time we can give the fastest service to voters, without seriously interrupting other office business."

least 180, and yesterday's to 75, while their own yesterday were 22.

The German high command, said central England and the harbors of Cardiff, Wales, Newport and Bristol had been successfully bombed and the British destroyer sunk off the Isle of Wight.

The Nazi high command said the British lost 89 planes yesterday, 59 of them in air fights during the mass attacks on Britain, 23 destroyed on the ground and 7 destroyed by anti-aircraft fire as well as 22 barrage balloons. They conceded the loss of 31 of their own.

Germany, however, said Britain had not yet been subjected to a real "large-scale attack" and that the worst was yet to come. The present attacks simply are a "strong armed reconnaissance," Germany said.

PORTLAND, Aug. 17 (AP) — Governor Sprague's interim committee to study the state workmen's compensation act will conduct a public hearing here today.

The group, consisting of three employer representatives, three labor spokesmen and a chairman not identified with either group, was instructed to "make a study of the needs of the workmen's compensation law, with particular reference to the rate structure applied to contributors to the fund, benefit payments to injured workers, accident prevention, medical costs, hospital associations, the advisability of including occupational diseases in the act, and such other changes as the committee may deem necessary or advisable."

Workers, employers, lawyers, doctors and other persons interested in the legislation were invited to present their opinions. The committee is composed of Victor P. Morris, chairman, C. W. Boardman, Roscoe Craycraft, G. O. Hunter, E. E. Lage, O. R. Miller and Carl G. Washburne.
