

SHAW ELECTION DELAY REFUSED BY NLRB RULE

Communications were received here Thursday from Washington, D. C., advising the Shaw Lumber company, the local IWA union and local officials of the AFL that the Shaw petition for postponement of the forthcoming NLRB election at Tionesta, Calif., has been denied. The lumber company petitioned the board for postponement of the election until April.

on the grounds that only about half the normal crew is now at work at the Tionesta operations. R. C. Groesbeck, attorney for the Shaw Lumber company, said the election will probably be held before February 1. The communications denying the postponement were dated in Washington January 13. The election and separation of mill workers and woods employees were ordered after a hearing conducted here.

COUNTY COURT REJECTS BIDS FOR GAS, OIL

County court members at the regular session Wednesday accepted bids on a number of materials and service items for 1941, but turned down all bids for gasoline and diesel oil. Five bids for gasoline were 13.74 cents for the regular grade, and 10 bids for diesel oil were .0775 per gallon. When bids for gas and oil are readvertised, lubricants will be included.

Bids accepted follow: Hog fuel, Heilbronner, \$2.75 a unit. Laundry, Superior Troy. Feeding of prisoners, Sheriff L. L. Low, 48 cents a day. Typewriter care, Shaw Stationery company, \$6 per year per machine. Adding machine care, C. O. Moore.

Crude oil, Peyton for six months, Heilbronner for six months, both bids at 61 cents a gallon. The Klamath News and The Evening Herald were named county official newspapers for 1941.

Umatilla, now having two, would be placed in a district with Wallowa, the district to have two. Wallowa now has one.

FORD DEDICATES TRAINING CAMP FOR MECHANICS

330 Per Month The trainees, all apprentice or second class seamen are to receive three months courses in various mechanical and technical lines in the Ford trade school or the Ford factory. When the project is fully developed it is expected to turn out 330 trained electricians, machinists' mates, diesel engine operators and others each month. The recruits will be under navy jurisdiction at all times, but all instruction will be given by Ford instructors.

(Continued From Page One) vote to be relatively proportionate to the fraction of an acre owned."

In other words, a man with a tenth of an acre of land would have a tenth of a vote, while a man with 20 acres of land would have 20 votes.

The issue is of particular interest in the Enterprise irrigation district, which embraces much of the thickly settled southeast suburbs. Here there are extensive small ownerships and comparatively few larger ownerships.

A meeting of the Suburban league was scheduled for Wednesday evening at the Shasta school for consideration of the proposal.

While the measure would affect elections in any district contracting with the federal government, there is said to be no such district in the state with so many small ownerships as the Enterprise. The general areas in the state where irrigation districts contract with the government are Vale-Owyhee, Umatilla and Klamath.

TAX PROPOSED ON CIGARETTES TO HELP AGED

(Continued From Page One) road to any defense industry or public utility.

The maximum old age pension would be increased from \$30 to \$40 a month under a bill by Rep. E. C. Allen (D-Multnomah). A companion bill would levy a tax of 10 cents on each 100 cigarettes.

Senator Douglas McKay (R-Marion) introduced the bill to repeal the non-resident registration law. He also sponsored a measure to guarantee reemployment of state employes on military service.

State Guard Governor Sprague's bill to authorize him to organize a state guard to replace the national guard, now in federal service, was introduced in the house. The governor has explained he thinks he already has the authority, but he wants to make the law definite.

The joint ways and means committee, holding its first meeting, voted to delay a proposal to give state institution employes an eight-hour day until it learns if enough revenue is available.

The committee received a budget division estimate that revenues during the 1941-43 biennium would exceed estimated expenditures by \$28,000.

Reapportionment Rep. Richard L. Neuberger of Multnomah county said last night he would introduce a bill to increase Multnomah county's house delegation from 13 to 18 and the county's senate membership from six to nine.

The reapportionment would be accomplished by consolidating districts now "over represented, mostly in eastern Oregon." He pointed out that Multnomah county has one legislator to every 22,000 persons while some sections have one to every 5000.

He charged that the state constitution which provides that population should determine the distribution of legislators has been "violated" with respect to Multnomah county "for nearly a generation."

The last apportionment of the legislature was in 1907.

Both houses are expected to recess Thursday noon until next Monday.

SALEM, Jan. 15 (AP)—Bills to require deposits by persons engaged in mining or logging operations with county clerks to guarantee wage payments were introduced today by Reps. Phil Brady and Richard L. Neuberger, both Portland democrats. The bills, sponsored by the state department of labor, provide that the collateral shall be on deposit throughout the period for which wages are paid.

HULL FAVORS SELF DEFENSE PLAN FOR U. S.

(Continued From Page One) Luther A. Johnson (D-Tex.) asked whether a section of the president's lease-lend bill providing for repair of belligerent vessels, such as those of Britain, in United States ports, violated international law.

Realistic "Nothing but a realistic view of current developments can be regarded as a sane view," the white-haired Hull replied gravely.

"The question is whether in the face of a universally recognized movement or force to invade and conquer, peaceful nations shall wait until the invaders cross their boundary lines—or whether they shall recognize that this is a world movement of conquest and invoke the law of self defense before, it is too late.

"That is the question," Hull declared emphatically. "We can take our choice."

Only One Law To set forth fully his views on the question raised by Johnson, Hull took up one by one laws that might be involved and ended his discussion with the statement:

"Only the law of self defense can be evoked from any practical view point."

Among the laws he cited were the Neutrality and Johnson acts. He said that they would be superseded by the president's proposals.

NLRB Examiner—In a news story appearing in Tuesday's Herald and Wednesday's News, Earle Shawe, NLRB examiner, was erroneously referred to as an AFL investigator. Shawe arrived Tuesday to act as NLRB trial examiner for a hearing scheduled Friday in connection with a labor dispute at the Big Lakes Box company operations at Canby, Calif. The hearing will be held at the courthouse here.

In the demurrers it was contended that the indictments were faulty because insufficient facts were given to constitute a crime. The cases were sent back to the grand jury.
