

BRITAIN NEEDS WAR MATERIALS TO HOLD LINES

of the United States' own security, the prime minister said.

Hopkins, recently arrived in England on a mission for Mr. Roosevelt, sat shyly on the platform, his face half-hidden in his hand, as Churchill whirled around to him and said:

"We do not require in 1941 large armies from overseas.

"What we do require is weapons, ships and airplanes.

"All that we can pay for we will pay for but we require far more than we shall be able to pay for."

Praises Roosevelt

Britain's armed strength, he said, is fighting the cause of world democracy.

Churchill was glowing in his praise of President Roosevelt's program of all-out aid to Britain. "I watch with deep emotion," he said, "the stirring processes whereby the democracy of the great American republic is establishing its laws and formulating decisions in order to make sure that the British commonwealth of nations are able to maintain, as they are, the present front line of civilization and progress."

Finish Fight Pledged

Churchill and Hopkins had just finished a rapid tour of Glasgow's civilian defenses.

The prime minister flatly pledged Britain will fight through to the finish to a victory over Hitlerism, whatever the dangers and hardships.

Turning to Hopkins, Churchill said to his audience:

"Mr. Hopkins has come in order to put himself into the closest relations with things here.

"He will return soon to report to his famous chief the impressions he has gathered in our islands."

"That Bad Man"

Churchill then told of Britain's urgent need of ships, planes and guns. He described Britain's powerful army and strong, well-manned defenses against any Nazi invasion.

"Nevertheless, I do not feel it would be right for any of those responsible for the people of this country to generally dismiss from their minds the possibility of invasion," he said.

He spoke bitterly of Adolf Hitler as "that bad man."

"Every day this occupation of Austria, Czechoslovakia, Poland, Norway, Denmark, Holland, Belgium and France—continues here is built up a volume of hatred for the Nazi creed and for the German name which generations and perhaps centuries will hardly efface."

Churchill referred in this statement to a growing British belief that Italy may collapse in the not distant future, and that Adolf Hitler's armies will march into the peninsula.

was cross-examined by company officials.

After the AFL rested their case, Arthur J. Voye, company president, was recalled to the witness stand to sum up the company's position. He asserted that the bargaining unit should consist of all 500 employees of the company, 300 at Klamath Falls, and 100 each at the Canby mill and logging camp.

Objection Raised

This brought a strong objection from Presley L. Gill, AFL attorney, who asserted the testimony was cumulative and repetitious.

Trial Examiner Earle K. Shawe overruled the objection, stating that the company would be granted considerable leeway, inasmuch as the AFL was given the same leeway during its testimony.

The company contends a division of the employees would result in labor strife in the future between different unions, whereas the AFL contends that each operation is separately supervised and that various subsidiaries of the AFL are organizing the workers of each group.

After a noon recess the hearing reconvened at 1:30 p. m., Saturday. It was expected to close late Saturday afternoon.

The local AFL union, No. 2824, has jurisdiction at the Canby mill operations, Boyd asserted from the witness stand, and the AFL has asked for collective bargaining for the mill unit alone "in keeping with AFL policies."

Interests of the mill workers are unique, Boyd asserted, inasmuch as they are affected to a greater degree by seasonality, seniority, and because they are governed by a different wage scale and by different methods of pay. Organizing the mill is the "first and best step" toward organizing the entire operations, he continued, and the AFL intends in time to secure a union charter for logging camp employees.

Employees of the Portland Montgomery Ward store, who are now on strike there in protest of alleged refusal to negotiate, may be brought to Klamath Falls to picket the local Ward store, it was made known Saturday at the labor temple.

The matter was discussed Friday night at a meeting of the Klamath Falls central labor council, at which time communications from the Portland strike committee were presented. The picketing of the local store, if carried out, would be at the expense of the Portland committee, it was announced.

Members of the local labor council voted "fullest support" to any picketing which might take place here.

Other business consisted of a report of the housing committee which is investigating possible revenue for a new labor temple. It was proposed to assess a one-day pay donation from each member of the AFL organizations involved. The matter is to be referred to individual organizations.
