MAN JAILED ON ASSAULT CHARGE

Robert E. Rusk, a resident of the Beatty district, is in the county jail in lieu of \$2500 bond after arraignment here on a charge of assault while armed with a dangerous weapon.

He charges that Rusk threatened and struck him with a rifle, finally standing over him as he lay on a bed. Mrs. Rusk and Effie Driscoll were said to have intervened in behalf of Brown at that time.

Two Men Ski to Lake o' Woods

John Sarginson, ranger in charge of Rogue River national forest, accompanied by Charles Schaal, Lake o' the Woods summer home owner, left Klamath Falls early Sunday morning for the lake. Sarginson reported they were able to drive their car to within one-half mile of the bottom of the hill and about five miles from the lake.

It took the two men two hours to ski to the air field and about one hour and 15 minutes to return. They found 26 inches of snow on the field, the snow "pretty wet" with a high water content and fairly well packed. Sarginson said the road from Klamath Falls to the Rocky Point junction was in fair shape on the way to the lake but during that time a shower had made the stretch quite rough on the return trip.

\$22,000,000 Spent in Last Election, Claim

WASHINGTON, March 7 (AP)—The senate campaign investigating committee, reporting that the major parties had spent almost \$22,000,000 during the 1940 presidential contest, recommended today that congress fix rigid limits on political funds and tighten up other federal election laws.

Republican groups were credited with expenditures of almost \$15,000,000 and democrats, with more than \$6,000,000.

The special committee submitted a 10-point political reform program in its 191-page final report, which included separate, sharply-worded minority statements from Senator Tobey (R-N.H.).

Tobey, in his reports, asked a congressional investigation of Mayor Frank Hague of Jersey City, N. J., powerful democratic leader; charged that Oliver A. Quayle, democratic national committee leader, had "lied brazenly and unhesitatingly" to the committee; questioned \$300,000 loaned to democrats by R. J. Reynolds; and criticized primary expenditures by Senator Radcliff (D-Md.).

MURRAY PRESENTS JUVENILE REPORT

A total of 156 juvenile cases remain open in Klamath county at this time, according to the monthly report of Gerald (Spec) Murray, county juvenile officer. New cases in February totaled 18, and 6 were re-opened.

There are 71 Klamath county juveniles in state or state-aided institutions.

Classifying cases pending, Murray said that 52 are delinquents, 32 are predelinquents, and 72 are dependent and neglected.

In the month, three juveniles appeared for circuit court hearings on delinquency, and 10 for dependency.

"The foreign press circulates rumors that the U.S.S.R. has demanded from Rumania cession of her naval bases on the Black sea. Tass is authorized to deny these reports as fabricated and absurd."

(The reports were an outgrowth of the recent Vienna conference between General Ion Antonescu, the Rumanian dictator, and Reichsmarschal Hermann Goering of Germany.)
