Three Missing

Air flights, including the Atlantic clipper's takeoff to Lisbon, were cancelled. The United States line America was delayed eight hours before visibility conditions permitted her to sail for California at dawn.

At La Guardia field, New York, a record 16-inch fall paralyzed all air traffic to and from the city.

Three boys were missing in two small boats in the Severn river in Maryland.

The nation's capital by dawn was covered with 10 inches of snow, a record for the season. Boston expected 12 inches or more snow and a forecast of strong winds caused Connecticut, Rhode Island and Massachusetts to prepare for a blizzard.

Skating Good Saturday At Crater Lake

Skating in Crater Lake national park Saturday was good on sunny slopes but poor in the shade where snow still wore an icy crust. Weather was clear and warm with visibility unlimited. The mercury stood at about 50.

All slopes are icy in the early morning and late afternoon, Ranger Jack Frost said Saturday afternoon, but the ice disappears shortly after the sun hits. Snow has not yet reached spring, or corn condition, Frost stated, but is fast approaching it.

JURY STUDIES TRUCK DRIVER CASE BRIEFLY

received instructions from the bench and retired at 11:20 a. m. with Foreman Lawrence Bertram and other jurors returning to the box at 11:40 a. m.

Witnesses for the prosecution during Thursday's trial were Herbert Gramer and Jack Bothwell, who were riding in the Johnson car at the time of the accident. They testified they had not noticed the approaching truck until the moment of the impact.

Saw Accident

Next witnesses were G. W. Martin and Clayton Sweasy, who were following the truck some distance behind and saw the accident. Martin was driving. He said he saw no car on the same side of the road ahead of the truck, a point which the defendant made. Sweasy confirmed Martin, stating that he noticed no car on the open highway ahead of the truck.

The truck is said to have crossed the yellow highway strip and crashed head-on into the Johnson vehicle. Joseph L. Cooley and Edward A. Janzen, State police officers, testified that the Johnson car left no skid marks on the pavement other than ones indicating a sidewise slide. Cooley said there was no indication Johnson had applied his brakes. Both policemen testified they had smelled the odor of liquor on the truck driver's breath. Janzen said he arrived at the crash scene after Cooley, and that Rhodes was asleep in Cooley's patrol car at the time.

Adler Testifies

Dr. George Adler, Klamath county coroner, testified he examined the bodies of Mr. and Mrs. Johnson. He said Johnson's face was battered beyond recognition. He also said he detected a strong odor of alcohol on the breath of the defendant when he examined him for injuries. Adler told the court there were no visible injuries on Rhodes either at the time he arrived at the

wreck or on the next day, Sunday, when he talked to Rhodes in the county jail. Photographer Wesley Guderian, The Herald and News photographer, took the witness stand to testify that he had taken pictures of the wreck on November 11. Three pictures, which the court accepted as Exhibits B, C and D, were three shots he had taken of the wrecked car and truck, Guderian said. He explained to the jury the positions of the vehicles and pointed out their positions on the road.

Rhodes took the stand and little by little his story unfolded. He said he noticed a car about 200 feet ahead of his truck which was either parked or moving very slowly. As he attempted to pass the car, it suddenly picked up speed, he testified, and the Johnson car came swiftly over the crest of a hill. He could not avoid the crash, he said.

One of the State police officers testified he found a pint whiskey bottle on the floor in front of the seat in the Johnson car. He said the bottle was less than half full of liquor.

ing great damage to the tax structure."

The defeat of the bill indicates there will be no new tax legislation approved this session.

Rep. Richard L. Neuberger (D-Multnomah), opening the democratic attack, said "We all want to help the old people, but let's do it now. This bill, even if the people approved it, wouldn't become law until 1943. But the people five years ago voted 6 to 1 against it."

Neuberger advocated a tax on business that would take effect immediately.

The house acted late yesterday on measures, ranging from diversion of the gasoline tax to state control of so-called "mixer clubs."

It also adopted a resolution to end the session by 11 p. m. next Tuesday. Rep. Frank Longergan (R-Multnomah), house floor leader, explained the resolution was only a "gesture," and predicted adjournment by Thursday (8th day).

The League of Oregon Cities-sponsored bill to distribute five per cent of highway revenues for street maintenance was passed, 35 to 22, and sent to the senate.

By a 47 to 9 vote, the house approved a measure to give the state liquor control commission authority to regulate clubs in which drinks are mixed.

telling the president he could "loan or sell or give away" the American navy "as you see fit."

Responding, Chairman George (D-Ga.) of the senate foreign relations committee declared that "this amendment entirely scuttles the bill," he added: "Essentially, Britain needs naval help. If she does not get it when she needs it the bill is no good at all."

Democratic Leader Barkley asked the senate whether "we are willing to make this bill an army relief bill only."

"Are we going to say," he asked, "that the navy is not to be touched?"

"The president should not be put in the position of not giving Britain naval aid if she needs it. If her navy goes down, she goes down."

Barkley declared earlier that senate opponents of the aid legislation were "cooperating to obtain a final vote today."
