Senate Decision On Argentine Beef Protested

WASHINGTON, March 22 (AP)—Democratic Leader Barkley announced today an administration effort would be made Monday to reverse the senate's decision to forbid navy purchases of Argentine canned beef.

An administration proposal to permit such purchases was defeated on a tie vote of 32 to 32 Thursday when Vice President Wallace, entertaining at a duck luncheon, failed to appear and break the tie.

NEW YORK, March 21 (AP)—Rafael Uranga, director of the Argentine Meat Producers corporation, said today there was a "profoundly disagreeable reaction in the Argentine" to a U. S. senate vote yesterday preventing the navy from purchasing Argentine beef and other foreign foods.

FOOD AGREEMENT

WASHINGTON, March 22 (AP)—An agreement that will pass two shiploads of American wheat through the British blockade for unoccupied France is expected to be announced within the next few days, it was learned today, after weeks of involved negotiations between the American, British and French governments.
