Retail Trade at Near Record Pace

NEW YORK, April 25 (AP)—Favored by good weather over a broad area, the nation's retail merchants this week moved a "near-record" volume of merchandise, the Dun and Bradstreet weekly trade survey said today.

"Sales totals again ranged sharply above the corresponding week a year ago," the review asserted.

"Except for the northwest where gains continued somewhat smaller than average, all major regions recorded increases of better than 10 per cent."

"The year-to-year improvement for the whole country was estimated between 14 and 17 per cent."

Diary Recalls Happenings in Heart Balm Case

SEATTLE, April 25 (AP)—With a 1136-page diary before her, white-haired Mrs. Margaret M. Gable related Thursday in her heart balm suit against Attorney Jay Allen, prominent lawyer, that an automobile ride she took with him in January, 1936, ended in a beating at his hands.

Her testimony, during her third day on the stand in a \$250,000 breach of promise suit, was interspersed with frequent sobbing interludes.

Allen, member of a pioneer family, ill since the first day of the trial Monday again was absent from the courtroom today.

Mrs. Gable, 58, said that she and Allen, now 72, were injured in a traffic accident in December, 1935, and on her recovery from a broken collarbone, he promised to drive her "around in the sunshine" one January day.

"But there was no ride," she testified. "Jay told me he hadn't brought his car to the hotel and had made plans to play cards instead. I said, 'Oh, dear, how could you?' and it all led to a scene. . . ."

"I started to cry, and he got angry, and struck me with his fist. Then he began to pull my arm, my sore arm. . . . After it was all over, he got a bath towel from my bathroom and bathed my face and wiped away the blood and was very sorry. . . ."

In her complaint, Mrs. Gable declared each planned years ago to divorce their respective spouses so they could marry, and that she did divorce William C. Jones. She has testified

Economic Council Finds 322 Defense Shops in Oregon

SALEM, April 25 (AP)—The Oregon economic council reported to Governor Charles A. Sprague today that the state has 322 machine, woodworking and sheetmetal shops and foundries available for defense production.

The report, along with another listing warehouse facilities available for defense needs, was made up from reports by chambers of commerce and defense committees in towns and cities over 900 population.

The production report listed 229 machine shops, 82 of which are in Portland, 13 woodworking shops, 40 sheet metal shops, 24 of which are in Portland, and 39 foundries with 27 of them in Portland.

The shops now employ 4202 men, the report said, and would need 11,670 skilled workers for capacity production. The report said 15,845 skilled workers are available.

POWER GROUP TO MAP PLAN OF MEETINGS

A special meeting of the Bonneville power committee has been called for Tuesday evening at the courthouse, when it is planned to adopt a schedule for further power education meetings and discuss proposed petitions for formation of a public utilities district in this territory, according to A. M. Thomas, secretary of the committee.

Thomas said that after petitions are prepared they will be circulated and the sponsors must obtain the signatures of persons equaling 5 per cent of the voters in the proposed district who voted for supreme court justice at the last election.

The petitions are addressed to the state hydroelectric power commission, which, in case of completed petitions, will hold a hearing and conduct an investigation. Within two years sponsors may file final petitions asking an election.

Committee members have under discussion a proposal that unincorporated areas, only, be embraced in the proposed district, and not including Klamath Falls, proper.

Wage Boost Ends San Diego Strike

SAN DIEGO, Calif., April 25 (AP)—Government-authorized wage increases went to some 3000 building craftsmen today, ending a brief and partial interruption in the navy's defense housing program here.

K. G. Bitter, secretary of the San Diego district AFL Building Trades council, said the council had accepted an offer of a 10 per cent pay boost for electricians, painters, roofers and floorlayers on the understanding it would be effective immediately.

President Approves Western Steel Plan

PORTLAND, Ore., April 25 (AP)—Establishment of a west coast high-grade steel industry evidently has presidential approval, Senator Charles L. McNary (R-Ore.) advised the Portland Oregonian today.

The newspaper said that McNary stated in a telegram: "Evidently the president is in sympathy with the undertaking on account of national defense and strategic position in the west."

McNary also quoted Gano Dunn, government steel expert with the office of production management, as saying that "the electric steel processes were in every way practicable and acceptable to the industry."

Construction of the steel plant in the Bonneville dam area was proposed several days ago by Henry F. Kaiser, California engineer, in a conference with the president and OPM officials.

GRANGE CONVENTION

NEWPORT, April 25 (AP)—State Grange Master Ray Gill predicted Thursday the state grange convention here in mid-June will draw a record crowd. Arrangements for the convocation were made at a special Pomona grange meeting.

The convention will be the second for Newport in nearly 20 years.
