

SOLDIERS GET PROTECTION ON AUTO EQUITIES

Car owners called into military service, who are making installment payments on automobiles, should carefully check provisions of the Soldiers' and Sailors' Relief act of 1940 before allowing their vehicle to be repossessed, according to Dr. E. B. McDaniel, president of the Oregon State Motor association.

The A. A. A. club executive said that the legislation was enacted by persons called into service and it applies to contracts entered into prior to October 17, 1940. Thus, he said, repossessions under contracts entered into prior to that date are a violation of the law unless the finance company has either a court order or written agreement from the car purchaser.

"With reference to these contracts," he continued, "the law provided that no automobile being purchased by a person called into service may be repossessed without either a written agreement signed by the purchaser of a court order. In the former case, the signer should know his rights. If the case goes to court, and more than half the cost of the contract has been paid, the judge has the right to stay all proceedings until after the debtor has been discharged from service. If the vehicle is less than half paid for, the judge may make any disposition he believes to be equitable, including an order for a refund to the purchaser of all or part of the amount paid, but cannot stay proceedings for the period of service."

Dr. McDaniel pointed out that some draft boards have made arrangements for those subject to the Selective Service act to get full information regarding their rights under the Soldiers' and Sailors' Relief act.

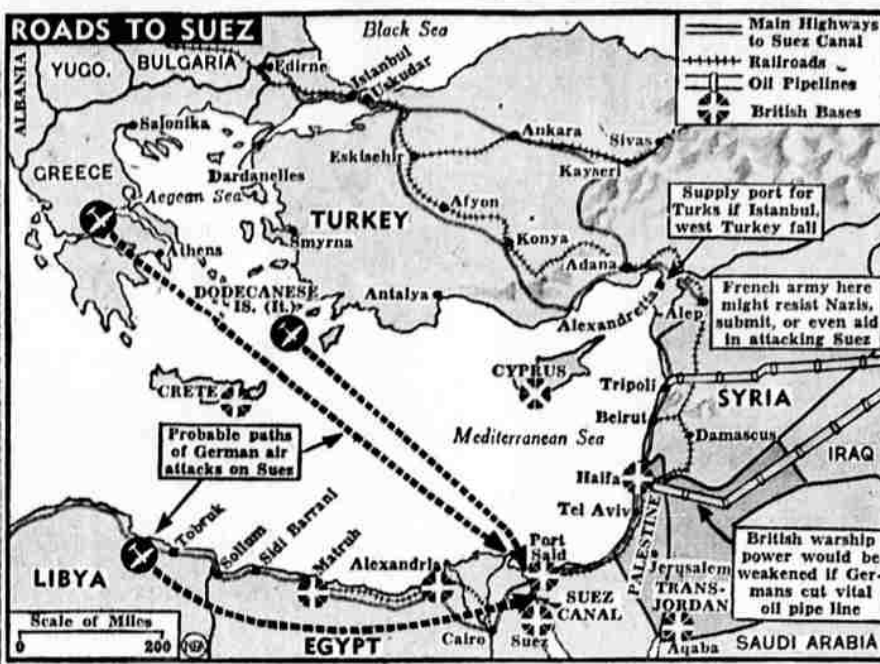

GREEK NAVY HARD HIT BY GERMANS

CANEAU, Crete, May 7 (AP)—The Greek government, recapitulating the fate of its navy in the last days of the German drive through Greece, said today that all its auxiliary vessels—more than 30—had been "savagely bombed and machine-gunned, sinking with the crews."

These ships included mine-layers, patrol and escort vessels. Greece's submarines were said to have reached Alexandria, Egypt, where they joined the British fleet.

"Of the 10 destroyers, three were sunk, firing to the last against dozens of German bombers," the statement said.

Two of Greece's 13 torpedo boats also were said to have reached Alexandria.

The hospital ships Hesperos, Policos, Attiki, Socrates and Hellenis were sunk, the statement said, "although they were unarmed and were carrying full lights and bearing signs stipulated by the International Red Cross."

"Survivors struggling in the sea were pitilessly machine-gunned. The case of one was particularly flagrant as she carried women and children."

"There were few survivors of all the Greek coasting fleet. Only six freighters which were far from ports were saved."

DuFresne said he had been unable to reach Loyal R. Rugh, Eugene, the boy's father, for positive identification. Young Rugh attended Oregon State college.

DuFresne said \$10 and a watch were found in the pockets and that there was no indication of foul play. He estimated the body had been in the water more than a month. Portland police records showed Rugh had been reported missing for 30 days.
