PULP, PAPER WORKERS GET 10-CENT RAISE

PORTLAND, Ore., May 29 (AP)—Fifteen thousand AFL men and women pulp and paper workers on the Pacific coast received a flat 10-cent hourly pay raise effective June 1, as result of negotiations completed here Wednesday.

The base wage for men will increase to 75 cents an hour, for women to 62 cents. The agreement is subject to ratification by locals of the International Brotherhood of Paper Makers, and the International Brotherhood of Pulp Sulphite and Paper Mill Workers.

The agreement also contained a no-strike clause. Employers said it lifted wages 25 cents per hour above those prevailing elsewhere.

The increase will affect workers in Longview, Camas, Vancouver, Everett, Tacoma, Port Angeles, Everett, Port Townsend, Bellingham, Anacortes, Hoquiam and Shelton, Wash.; Portland, West Linn, Oregon City, Coos Bay, Lebanon, Salem, St. Helens, Ore., and Astoria, Stockton, Los Angeles, Pomona and Vernon and Southgate, Calif.

The negotiators include high officers of both unions and employers from major mills in all three states.

TRUCK LINES REPORT APRIL REVENUE GAIN

Revenue increases from 11.1 to 21.1 per cent for the month of April, 1941, over the same month of 1940, were reported by three Klamath Falls truck line offices Wednesday. Figures from two of the firms showed tonnage jumps of from 13 to 15.4 per cent. Actual figures for both tonnage and revenue were not available.

Biggest leap was reported by the Klamath Falls-Malin line which announced a 21.1 per cent revenue increase.

Consolidated Freightways reported a 15 per cent boost in revenue despite the loss on one account which during April, 1940, had constituted 10 per cent of the firm's business. Bend-Portland truck service gained 11.1 per cent, according to John H. Robbins, Klamath agent.

Of the two lines reporting tonnage gains, Bend-Portland led with a 15.4 per cent jump. According to Orrin H. Fraley, Consolidated agent, Freightways' April tonnage figures were 13 per cent over last year.

Two Referendum Petitions Being Circulated Here

Petitions are being circulated here for referendum of two acts passed by the recent session of the legislature. Numerous petitions have been filed for checking at the county clerk's office in connection with the referendum attack on the cigarette tax bill. The other referendum which is receiving signatures here is against the act providing free textbooks for private state elementary schools.

Transportation News

NEW LAW INCLUDES SPECIAL CARRIERS

SALEM, Ore., May 29—Special carriers transporting property for compensation come under transportation rate regulations on and after June 15 this year, said Ormond R. Bean, commissioner of public utilities of Oregon, Wednesday when he called attention to the fact that the last legislature amended the motor transportation law in this regard.

The new law excludes from rate regulation those special carriers transporting sawdust, hog fuel and cordwood, or while said carriers' trucks are being used exclusively in transporting metallic ores or concentrates, or raw non-metallic products, whether from mines or otherwise, from mines, pits or quarries or in transporting machinery, equipment and supplies to or from mining, pit or quarry operations. A special carrier transporting on his own trucks property of which he is the owner, that is, performing operations which are in fact those of a private carrier, will not be subject to rate regulations.

On or before June 15, all special carriers, other than those named above as being excluded, are required to file with the commissioner a tariff or contracts to become effective June 15, and stating plainly therein the rates, charges and practices of the carrier.

FINAL TRAINS OF ARMY JAUNT STOP

The final eight trains of an approximate 25,000-man rail and truck troops movement through Klamath Falls passed through the city Wednesday en route to June maneuvers on the Hunter Liggett Reservation in California.

Each train carried over 500 men and were the last of nearly 30 rail transports which began to roll through town last Saturday.

An estimated 15,000 men were moved southward from Fort Lewis, Wash., by train and an additional 10,000 carried by army trucks, jeeps and command cars. Another 10,000 rolled in a 1600-mile convoy by way of the Pacific highway.

SP to Resume Special Tour Rate

Resumption of the around-America tour rate which the Southern Pacific railroad put into effect during last summer, has been announced by the company. As in 1940, the rates carry three-month stopover privileges. "Grand circle" tours allow the passenger to start from any place, cover the continent and return.

QUESTIONS ON SCHOOL BOARD TENURE EYED

Legal opinion on certain questions that have arisen in connection with the city elementary school district election has been asked of the attorney general's office, following a meeting of the board Wednesday evening.

Superintendent J. Percy Wells was asked by the board to propound the questions to the state superintendent's office for an opinion, probably by the attorney general. The questions arise through the fact that there are two positions to be filled at the election June 16, and that one of the elected directors will serve until 1946 and the other until 1943.

These questions are being asked:

1. Is it obligatory upon candidates to designate on their petitions which term of office they seek?

2. Or, after the election, can the two elected members draw lots to determine which shall serve until 1943 and which until 1946?

3. Or, can the board announce that the member receiving the highest number of votes in the election shall serve the long term, and the member receiving the second highest serve the short term?

At Wednesday night's meeting, steps were taken to reorganize the board in accordance with a law adopted at the last legislature. Lots were drawn to determine the expiration dates of members' terms. As a result, the following dates were shown: E. S. Robinson, term expires in 1945.

Dr. L. L. Truax, term expires in 1944.

Mrs. Burt Hawkins, term expires in 1942.

At the close of the Wednesday evening meeting, A. M. Collier presented his resignation to take effect June 8. Collier has moved outside the district.

Trains Continue Slightly Behind Schedule Here

Late morning Southern Pacific northbound trains continued to run approximately one hour behind schedule Thursday due to continued troop train movements south of Klamath Falls.

According to the railroad office, both the Beaver and the Oregonian, scheduled for 6:30 and 7 a. m., arrived shortly after 8 o'clock. The northbound Klamath, due at 11 o'clock, arrived at 12:15.

All of the 35,000 troops from Fort Lewis, Wash., which have been moved south for summer maneuvers have now arrived, it was said, and local trains are expected to resume accurate schedules Friday.
