

# \$50,000 PLAN FOR SCHOOLS UP FOR VOTE

as large as the ones at Merrill and Mallin. The facilities do not compare with those in the remainder of the school centers in Klamath county.

2. Fairhaven is an elementary school of approximately 300 children. This contains all grades including the eighth. The large number of seventh and eighth grade boys need some shop and vocational training. The girls also need work along vocational lines. The present cafeteria is entirely inadequate for the number of children who must use it. It is, therefore, proposed to add at the southeast corner of the building an addition approximately 24 feet by 60 feet, to house a shop and domestic science room.

3. Henley is a rapidly growing school and community. The high school building is somewhat old and not in keeping with the other buildings of Klamath county. However, if additional bleacher room and toilet facilities are added, the plant will undoubtedly be serviceable for some years in the future. The district, therefore, proposes to make those additions.

4. At Algoma the floor and underpinning of the present community building have entirely given away. If it is to be used in the future, a new floor and new supports for the building must be added.

5. At Sprague River it is proposed to provide additional room for the high school. The school now has an attendance of approximately 200 children, while the building is not adequate for much more than 100. There are schoolrooms and new toilet facilities to be provided.

6. The suburban area east of Klamath Falls is rapidly expanding in population and consequently in school needs. In order to properly care for the situation, it is proposed to add four classrooms above the low section of the present junior high school building.

7. The small school building at Crescent Lake is inadequate to serve the children who attend there. After the completion of the Willamette highway, the attendance has increased to such an extent that additional room is necessary at this place.

8. The vocational shops at Keno, Merrill, and Mallin are in need of improvements and additions. These are included in the building amount asked for in the budget.

Members of the budget board which prepared the schedule for the new year were Harvey Muskrat, Jack Gallagher, M. A. Bowman, A. Protsman and Will Blackman, and the following school board members: Harry Wilson, Rex High, Louis Botens, Fred Hagelstein and Percy Dixon.

The budget and election call will be published in full as legal notices in The Herald and News.

## CITY FILES SUIT IN CONDEMNATION

The city moved in circuit court Thursday to condemn 38.7 acres of land wanted for the airport expansion.

"injurious to the state," which DNB said came from a responsible source, included charges that:

1. The consul at Frankfurt-Am-Main, Sidney Reeder, in the fall of 1939, "delivered addresses in support of propaganda unfriendly to Germany" and "passed on information concerning military secretives war and economy problems."

2. That Consul Orsen Nielson and Consul Roy Bower in Munich "during the course of the year 1940 were active in hostility toward Germany in that they in the presence of German personalities made disapproving observations about Germany and the German government."

3. The consul general in Cologne, Alfred W. Klieforth, "in the autumn of 1939 and in the spring of 1940 carried on espionage against Germany by using key words under arrangement with the Belgian consul general in Cologne for reports intended to concern themselves with Germans marching into Belgium, Holland and Luxembourg."

4. Vice Consul Ralph C. Getzinger of the American consulate general in Hamburg in the spring of 1941 carried on espionage against the German reich in that he prepared sketches of railroads of Hamburg as well as writing a report on military facilities in the Hamburg vicinity and tried to pass on this material."

AFL machinists on strike at 11 San Francisco bay shipyards failed to yield today to a suggestion from the president of their international union that they return to work and mediate their differences with the management.

Harvey W. Brown, the machinists' president, addressed several hundred strikers during a four-hour closed meeting which ended after midnight. Before the session, Brown had expressed belief the men would end their walkout after the issues were explained. But when the strikers filed out, local officials of the union were non-committal, declining to say even whether a vote to end the strike had been taken.

Funeral services for the late George J. Walton, who succumbed Tuesday following a heart attack, will be held Saturday morning at 10 o'clock from the First Methodist church with the Rev. Victor Phillips officiating. Final rites will be held in Yreka, Calif., at 2:30 p. m., with interment in the family plot under auspices of the Yreka Masonic lodge. Arrangements are being made by Ward's.

Since regret was expressed among the businessmen of Klamath Falls Thursday over the passing of one of their number. Mayor John H. Houston, when advised of Mr. Walton's death, made the following statement:

"The city administration keenly feels the loss of one of its finest citizens in the passing of George J. Walton. He was, in our estimation, an ideal citizen and the fine qualities of his character and the warmth of his friendly smile will always remain with us."

Said E. M. Chilcote, for many years intimately acquainted with Mr. Walton: "I have known George since he first came to Klamath Falls in 1911. He served on the board of trustees of the Methodist church for many, many years, and was faithful and dependable. My sincerest regret is that his untimely passing prevented him from filling the office of grand commander of the Knights Templar of the state, an office in which he was next in line and on which he had long set his heart. His absence will be a great loss to the Masonic order of the state."

Rogers, with whom Mr. Walton served on the Klamath county Red Cross chapter board for a good many years, expressed his sorrow: "I knew George for many years and worked with him in the Red Cross. Evidently Hitler was impatient to get any kind of an understanding so he could proceed to quick action elsewhere, evidently believing he would be free at some later date really to make Turkey come to terms."

ANKARA, Turkey, June 18 (Delayed) (AP)—John V. A. MacMurray, American ambassador, was reported in informed quarters tonight to have discussed the new Turkish-German treaty with Foreign Minister Sukru Saracoglu before its signature and to have "expressed doubt" as to American reaction to the accord.

Crestfallen British diplomats expressed fear of the effect of the Turkish-German rapprochement in Moslem countries which are deeply affected by Turkish policy.
