Crucial Period

THE next fortnight may tell the whole story of the Russian-Nazi war. Germans, who are bending every effort toward a conclusion of the issue before winter forces a stalemate, already claim the Russians are crushed. They may be right, but we have learned to take German claims with suspicion since this eastern front struggle began.

If the Russians hold, or even if they give up Moscow but still fight on into the winter, the whole prospect of the world war will take on a darker hue for the Germans. Their high-gear military machine and the morale situation at home are not conditioned for waiting. The Germans need action. They have become accustomed to victory, and to a great inpouring of goods and food from conquered countries. A winter lull would give them time to gather force for new struggles, but it is doubtful if that would offset the unfavorable effects of delay.

Meanwhile, a winter stalemate will give time for American aid to come to the side of the Russians on the eastern front, and the British forces in the isles and in Africa. It will give both Russians and Britains an opportunity for recovering and gathering strength. They have thus far been on the defensive, and delay offers welcome relief and opportunity to hard-pressed defensive forces. So the period just ahead may prove the most crucial of the struggle. It may write the destiny of Europe.

"Night Shift University"

KLAMATH people who are interested in first aid, child welfare work, community organizations and youth recreation should not overlook the "night shift university" which opened here this week.

These classes are sponsored by the extension division of the state system of higher education. They not only offer opportunity to learn, but to earn university or college credit here at home. The instructors are competent and the subjects interesting. It's worth investigating.

"Protector's" Qualifications

OF all possible titles for the man chosen to hold the Czechs in subjection, the Nazis would have to choose "protector." It is their "protector" who is marching the cream of Czech patriots before the muzzles of Nazi firing squads.

Well qualified for establishing such "protection" is Reinhard Heydrich, newest appointee to the title. As a boy of 15 he learned brawling as a member of the Free Corps in his native Halle, in the days when rival bands of Communist and Nationalist roughs fought each other for possession of the streets. At 23 he was an efficient operative in the navy intelligence branch. An original Nazi, he quickly understood Hitler, and now vies with him for the chance to become the Fouché of the Nazi Revolution. It is an epic of Nazi success to be entrusted at 37 with the effort to outblot the terror of the French Revolution.

Johnson's Comment On The News

WASHINGTON, D. C., Oct. 10

"If you put a ceiling over prices, especially if you put one over wages and farm prices, you will have to put a ceiling over profits of business." This is one great bugaboo that is holding up anti-inflation legislation — notwithstanding that every important authority, new dealer, old dealer or middle-of-the-roader has testified that inflation is the most dreadful danger that now confronts our people.

In furtherance of that threat we hear "in war there shall be no profits." We see bills introduced limiting business profits to 6 per cent on capital investment and other similar balmy lunacies.

Look at them more closely and you will find that they are largely a confusion of terms, uttered mostly by politicians who either don't know or don't want to know what they are talking about.

What is a "ceiling" over prices, including wages or farm prices? It is no cast-iron restriction. It doesn't reach back and reduce any price. It simply says: "These increases have gone high enough. They shall not go any further upward without a showing, in the case of wages, that increases in the cost of living justify it or, in the case of farm prices, that they have not reached the long-promised goal of 'parity'—fair exchange value in terms of the prices of the things the farmer buys."

FLEXIBLE RULE

That in itself is a flexible rule. For, just as labor wages will go up as fast as the cost of living goes up, so also will the price of the things the farmer sells go up as fast as the price of what he buys. That is the "ceiling" plan as it applies to labor and agriculture. As it applies to business, prices can go up, but only where for some special reason and for its own purposes government permits them to go up, in a certain degree—but no further.

But that is not what the opponents of price ceilings propose when they say there must also be a ceiling over profits—say six per cent on invested capital. That doesn't propose a ceiling over profits as of a certain day. It proposes to reach back indefinitely on an arbitrary rule or no rule at all and, for most new and small enterprises, to a point that would bankrupt most of them and on most old and highly capitalized and powerful monopolies or great corporations to set a limit higher than most of them have enjoyed for a long, long time.

Wages have been going up, prices have been going up to a point where the beginning of a robust inflation is already here. But generally speaking net profits, whether figured as a percentage either on investment or sales, and regardless of multiplied businesses, haven't been going up. Mounting state, local and federal taxes have taken so large a portion of them that net advances in profits have been prevented.

"TAKE ALL PROFITS"

The new tax legislation will actually reduce them. Government hasn't taken 40 to 80 per cent out of wages and farm prices, but it has or shortly will take as much as that out of profits.

There is hardly a voice in this country raised against the slogan "Take by taxes all profits due to war." We are doing that and we are going to do it further.

But, that is a very different thing from this new slogan: "In war, take all profits."

That simply ruins the capitalistic system and our plan of free enterprise. It is creeping communism or nazism.

It would be as sensible as to say: "Don't put a reasonable limit on high wages and farm prices due to war to prevent inflation, but in war take all wages and confiscate all farm products."

It is high time to get quick and common sense action on the price-control bill.

RELATIVE COST COMPARED FOR SCHOOL, CRIME

TULELAKE — E. R. Deering, general supervisor of elementary schools in Siskiyou county, was guest speaker at the Rotary club luncheon and offered some interesting figures on the relative cost of student education and of crime in Siskiyou county.

Per capita cost of education in the grade schools stands at \$19 — \$13 of the total being paid by the taxpayer. This amounts to \$3 for every man, woman and child in the county. The remainder is taken care of by the state.

In the high school the total reaches \$177 with \$45 paid by the taxpayer. Here, too, the state makes up the difference. Crime costs every man, woman and child in the county \$15, Deering stated. The speaker was introduced by Fred E. Murphy, program chairman.

George Reiben, principal of the high school, received his badge of membership from Floyd A. Boyd, who read the four objects of Rotary and presented the membership certificate. Reiben was classified as educator in secondary schools.
