Weekend Roundup

HOME Town Topics: The traffic signal at South Sixth and East Main streets is working satisfactorily, according to City Engineer E. A. Thomas. Motorists are quickly catching on. Strangers are more likely to take note of a new signal than people accustomed to driving on the street without it. The downtown signals will be hung in the middle of the street from those high poles now being put up. Pedestrian signals will hang on the poles. Oh yes — the poles are to be painted . . .

Indications are now that it will be a long time before the Main street underpass signals are used. Remember them? When first installed, these signals gave motorists a case of confused jitters. They were then turned off, except for the intermittent warning flashing. If traffic ever gets heavy enough to require their use, the signals can be operated again. They may come in handy if a main thoroughfare from the southeast is ever connected to Main street at the Main street bridge, as has been considered.

Here's good news from the tax collectors: Klamath county's 1941 tax collections now total \$139,732 more than the total levy for the year, which was \$1,372,000. The collected taxes are for the current year as well as back years. This year's collections on the current roll are within \$412,000 of the current levy. These are real estate and personal property taxes.

Klamath people will know before long the tax rate they are going to have to pay for local purposes in 1942. Assessed valuations have been established and most budgets completed.

No, there's no particular significance to the fact that the four principals in two major criminal cases developing in the local courts come from Medford. It was an apparent coincidence, and there's no particular reason to expect a continued march of trouble across the Greensprings.

However, it is a noteworthy fact that a great deal of the business done in the criminal courts of Klamath county involves persons who are not settled residents of this community. And that proves that you can't judge the citizens of a community by the statistics from its criminal courts. They may be imposed upon by outsiders.

Chairman Andy Collier of the county defense savings committee is enthusiastic about the response of school children to the defense savings stamp buying program. The youngsters are buying generously and with a fine show of spirit. Patriotism and thrift are good things for youngsters; Klamath's boys and girls seem to have a lot of both.

Ashland's defeat of Medford in a Friday night football game is in line with the crazy pattern of this year's gridiron situation. This unexpected development throws Klamath Falls, Ashland and Medford into a three-way tie for the Southern Oregon conference title. It's the sort of thing that makes high school football in these parts interesting. Oh yes, are you going to Bend Tuesday?

An honest confession from The Medford News in item on the blackout: "Only an occasional light was left here and there throughout the city, and those were quickly reported by the air raid wardens. (Among those left on, we must shamefully admit, was one in the back shop of The Medford News.)"

NEWS BEHIND THE NEWS

WASHINGTON, Nov. 8—Mr. Roosevelt was just not throwing out an off-hand suggestion when he mentioned longer working hours. His defense force has been working on that idea quietly for some several weeks and for a definite plan. His remarks were the beginning of a build-up for revision of defense contracts and an extended working week.

The average work week domestically runs 40 to 44 hours, but in Britain the average is 70 hours (10 hours seven days a week), and in Germany 60 hours. To throw more force into the defense program this way, the government will either have to re-write all its defense contracts to pay for the additional overtime, or have the wages and hours act changed to do away with the 40-hour week. Mr. Roosevelt and his defense officials are willing to go to that length in their campaign to double production.

The phase of war upon which this government is starting will call for men as well as ships. Army preparations are bent towards a spring campaign where-ever the commander-in-chief designates. The betting within the army indicates it will be Dakar or Spain, and that supposition is prevalent in the senate.

SUPPLY PROBLEM

The general staff here still clings to the expectation that Hitler will find himself vastly over-committed in Russia during the winter. You may read of towns conquered but the important part of Der Fuehrer's warfare is supplying material and replacements to the advance guard. The deeper in conquest, the greater the problem of supply.

There are many in this government who believe this problem will defeat the Nazi leader before spring comes.

TAX AND SPEND

Not many congressmen like Mr. Morgenthau's glib talk about increasing taxation. His argument is that heavy taxes will stop inflation but the argument would go bigger in congressional quarters if the administration had taken hold of the chief threat of inflation, rising prices.

The congressmen have reached the conclusion that Mr. Morgenthau's real motive is "to tax and spend," a motive with which they are not in sympathy. Treasury tax proposals therefore will have to be modified sharply when the legislation is considered.

O. K. The fact that Stalin took Litvinoff out of the moth balls to be ambassador to the United States was greatly encouraging to officials here. Litvinoff was an old league of nations advocate with more friends in Geneva and Washington than in Moscow. No more acceptable person could have been chosen.

Odds are dropping on the Langer case. Certain republican leaders who know what is coming are laying 2 to 1 that the new deal will get its selected man.
