

JAP DIET IN SESSION ON WAR CRISIS

(Continued from Page One)

TOKYO, Nov. 15 (AP)—The special "crisis session" of the diet assembled today with a two-fold job—to feed more men and money to the Japanese war machine and levy new taxes to help pay the bill—amid increasing tension in the Pacific.

As a setting, United States marines in Shanghai, Peiping and Tientsin began packing up to leave on President Roosevelt's order and Saburo Kurosu neared Washington as a special envoy with a mission of understanding which many Japanese regarded with pessimism.

The decision to withdraw the marines was published in Japanese newspapers under Washington datelines without comment. Government spokesmen were silent but it was believed that Japan's attitude would parallel her stand on President Roosevelt's original announcement that the step was contemplated—that it was welcomed as freeing China of foreign influences and that the marines' presence was unnecessary as the Chinese were fully able to maintain order.

(A Domei broadcast heard in New York said leading Japanese newspapers heralded the diet meeting with expressions of hope that it would live up to its name as a war diet and act accordingly.)

(Parliament, it said, was assured by the press of the nation's full support, no matter where its decisions might lead. It quoted the newspaper Hochi as saying public determination was fixed, "material burdens are nothing and the people are resigned to any suffering.")

SNOW AND RAIN IN NORTH REPORTED

Crater lake national park was unreachable by telephone. Fort Klamath reports, however, estimated there was about six inches of snow at Government Camp. It was still snowing late in the day.

MAIN RUNWAY AT AIRPORT FINISHED

Paving the main runway at the Klamath municipal airport has been completed with the exception of the intersection area, and work is now going forward on the second runway.

O. H. Schrader of the army engineers said Saturday it is planned to pave the intersection area of the main runway next week. A heavier, tougher paving is required for that section, as well as the extreme ends, because of the punishment these areas receive.

The paving work on the second runway continued through Saturday morning until 11 o'clock, when it was called off for the weekend because of wet weather. A strip, 68 feet by 2000 feet, has been paved on the second runway's south end. A fine coat of rock has been placed on the north end in preparation for the surfacing job.

unanimous in the belief that a billion dollars a year can be cut from non-defense spending.

Asked to specify ways and means, Treasury Secretary Morgenthau, a member of the committee, suggests sharp curtailment in HIGHWAY and farm appropriations.

This suggests, in its turn, that Secretary Morgenthau is not in sympathy with curtailment of non-defense spending, and so proposes to start the cutting with the two items most certain to meet with opposition.

It is doubtless futile to mention it, but it is UNAVOIDABLY TRUE that every dollar of needless spending adds to the gravity of the financial problem that will face the nation as soon as the war ends.

CORNETT COOL TO PROPOSAL FOR SESSION

State Senator Marshall Cornett believes with Governor Sprague that the legislature should not be called into special session unless a definite program has been prepared which would meet with the majority of both houses, he revealed Saturday.

Cornett wrote his views in a letter to Gerard Macnamara, Portland attorney who is beating the drum for a special session. Macnamara asked Cornett for a statement of his views and sent various questions to him. Said Senator Cornett in his letter:

"I am heartily in accord with the statement which Governor Sprague publicly made, that 'it would be rather dangerous to call a special session of the legislature unless some definite program has been prepared which would meet with the approval of the majority of both the upper and lower house.'"

"In my opinion the tax structure of our state is too complicated and far reaching in its effects for legislators to be able, within the constitutional 20-day special session, to thoroughly study its many ramifications and apply such corrective measures as would be for the best interests of all sections of the state."

"I have no doubt that, inasmuch as next year is election year, the attendant publicity in connection with the introduction of such bills as milk control, old age pensions, state industrial and unemployment compensation, as well as numerous measures emanating from our various boards and commissions, would be too great a temptation for politically ambitious members to confine their efforts to the issues for which the special session would be called."

"In this time of national unrest and irrational thinking, I am opposed to a special session unless some solution can be presented which would gain the approval of the majority of both houses. Since Governor Sprague seemed to have the confidence of the last legislature, he should be the best judge as to what is a workable program and as to the necessity for a special session."

Sentences, Pleas Vacated by Judge In Holdup Case

The case of three Medford youths accused in a South Sixth street service station hold-up was opened up again Saturday after Circuit Judge David R. Vandenberg vacated pleas and sentences in the same case Friday.

Judge Vandenberg on Friday gave the three youths—Jimmy Morton, Joseph Lee Holt and Walter J. Phipps—10 years each, the minimum under the charge read in court. Later, he vacated the sentences, stating that after the sentencing the district attorney's office notified him that the prosecution was based on another statute which carries a minimum penalty of 1 year.

On Saturday, Judge Vandenberg appointed F. O. Small, attorney for the three youths and they will be arraigned next week.

LONDON, Nov. 15 (AP)—Gen. Charles DeGaulle, leader of the Free French forces, today outlined these three war aims:

1. "Make war . . . give the greatest possible extension and the greatest possible power to the French effort in the conflict."

2. "Let the people speak for themselves as soon as events once more allow them to make known freely 'what they want'."

3. "Bring about the conditions in post-war France which will permit 'every Frenchman to live, think, work and act in dignity and security.'"

Still earlier today the admiralty had said only 18 men out of the full crew of 1600 officers and men aboard the big carrier were missing after she was torpedoed and sunk in the Mediterranean. She sank yesterday within sight of Gibraltar, having "toppled over like a tired child," in the words of one observer.

The Ark Royal, the victim of a submarine which blasted a huge hole in her side, went down 25 miles from Gibraltar.

An officer on a destroyer which stood by until the end said the carrier listed 35 degrees to starboard just before she sank.

"We realized she was finished," he said.

"She toppled over like a tired child; her stern reared up for a moment, then gently slid beneath the waves."

Schools Closed After Earthquake—LOS ANGELES, Nov. 15 (AP)—School inspectors announced today four buildings would be closed at least until Tuesday as a result of yesterday's earthquake, while municipal officials continued a detailed survey of business buildings.

Schools listed by Superintendent Vierling Kersey as unable to reopen Monday are Torrance high, Narbonne high in Lomita, and the Gardena elementary school and the Carson street elementary school near Torrance. Plans were being made to house students in temporary buildings.

Union Feels S. F. Case Not Applicable to Dispute Here

The AFL Teamsters' union law, restraining trade in his case. Edsall said that he would seek an interpretation from attorneys of the State Federation of Labor but that he felt sure the San Francisco ruling did not apply inasmuch as the Klamath Falls wholesale merchants had no voice in the current matter.

The ruling, made by Federal Judge A. F. St. Sure in denying a motion to dismiss an indictment against several Bay area mills and unions, said that "unions which conspire with employers or other non-union groups to restrain trade may be prosecuted for violation of anti-trust laws."

In the local case the Teamsters union has notified all wholesalers employing union men that their members will not handle merchandise destined for Bratton use. The squabble stems from an unfair to labor charge against P. L. Kemp, builder of a second Bratton development south of this city.

Willard T. Mann, manager of Bratton's, has said that his attorneys are of the opinion that the union and the wholesalers are, in the eyes of the law, restraining trade in his case.

and one-half quarts of milk a week.

Such a minimum for this nation, he said, would mean "increase of at least 40 per cent in our present consumption of milk and milk products alone. It would mean a doubling of our present consumption of leafy vegetables and of the fruits that are rich in vitamins."

Farmers were also told by a national grange leader that they lack sufficient representation in Washington to assure them of a fair deal on agricultural prices.

Albert S. Goss, special research adviser for the grange and former federal land bank commissioner and former master of the Washington state grange, asserted that "unless something is done, agriculture will lose out in the price control legislation now pending before congress."
