PORTLAND, Ore., June 11 (AP)—Portland's rose festival went into its second day today with Queen Shirley I wearing the crown received at last night's opening program. Moved to the Municipal auditorium from the Civic stadium because of the ban on large crowds, a part of the opening program was devoted to a broadcast for war bonds. Lana Turner, film star, participated and was given citizenship in the realm of Rosaria by Queen Shirley. The traditional parade of floats will not be held this year.

Financial assistance to students returning to campuses after the war is provided in a plan introduced by the University of Iowa. A fund of \$10,000 is being raised, through volun-

ary contributions of 10 cents a week from students still at school. The fund, invested in Defense Bonds, calls for gifts of not over \$200 to each returning student in need of assistance.
