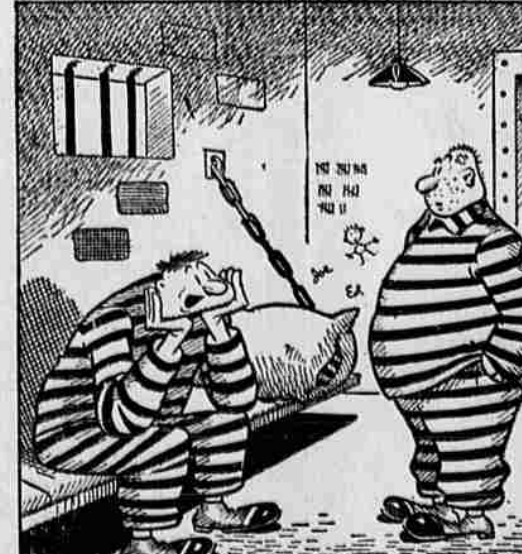

LEGAL NOTICES: IN THE DISTRICT COURT OF THE UNITED STATES FOR THE DISTRICT OF OREGON, UNITED STATES OF AMERICA, vs. 36 Cases, more or less, each containing 15 packages of 2 one-pound prints, of misbranded oleomargarine, PUBLIC NOTICE IS HEREBY GIVEN that on the 10th day of July, 1942, 36 Cases, each containing 15 packages of 2 one-pound prints, of misbranded oleomargarine, were arrested and taken into the possession of and now are in the possession of the United States Marshal for the District of Oregon, pursuant to a warrant and process duly issued by the Clerk of the United States District Court for the District of Oregon, in a suit for condemnation and forfeiture entitled, "United States of America, Libellant, vs. 36 Cases, more or less, each containing 15 packages of 2 one-pound prints, of misbranded oleomargarine," brought under the provisions of Section 334, Title 21, U.S.C.A., wherein it is sought to have the above-described articles of food condemned and forfeited for the following reasons: That on or about the 29th day of May, 1942, the said article of food was shipped in interstate commerce from Los Angeles, California to Klamath Falls, Oregon; that the said article of food is misbranded within the purview of Section 343 (a), Title 21, U.S.C.A. in that the statement "Vegetable Fat 81%" is false and misleading as applied to an article that contains less than 81% fat, namely, from 74.10 to 78.02 per cent; that the said article of food is further misbranded within the purview of Section 343 (g) (1), Title 21, U.S.C.A. in that it purports to be oleomargarine, a food for which a definition and standard of identity has been prescribed by regulations as provided by Section 341 and it fails to conform to such definition and standard since it contains less than 80 per cent fat, namely, from 74.10 to 78.02 per cent; that all persons claiming any right, title or interest in and to the said articles of food aforesaid are hereby notified to appear on or before the 3d day of August, 1942, in the Federal Court at Portland, Oregon, to show cause, if any there be, why the same should not be decreed against and forfeited to the United States as misbranded food.
