## Famous "Cholly Knickerbocker" Dies in New York

NEW YORK, July 17 (AP)—Maury H. B. Paul, 52, who as "Cholly Knickerbocker" recorded for years the activities of New York's first families as society editor for the New York Journal-American, died early today after a 10-week illness caused by a heart ailment.

Paul, whose full name was Maury Henry Biddle Paul, was a native of Philadelphia. After attending Episcopal academy there and the University of Pennsylvania, he began newspaper work as a reporter on the Philadelphia Times in 1914.

## US CAN RECOUP AT WAR'S END TILLOTSON SAYS

America may and probably will be broke after the war, but it will have the means of recouping and going on to greater things than ever, Mitchell Tillotson, manager of the First National bank, told the Kiwanis club at its noon meeting Thursday.

"We will have the greatest supply of skilled labor in history," said Tillotson. "We will have the natural resources.

"If we can get the markets, we will stage a tremendous recovery. I believe we can do it, because I believe in the spirit of the American people."

He added that getting the markets will require complete abandonment of isolationist theories. Tillotson analyzed the struggle against inflation, and emphasized the part that war bonds can play in carrying the nation through the economic and financial problems of the war and post-war periods.

The banker was introduced by Chet Bunnell, who was Kiwanis chairman of the day.

An incident of Thursday's meeting was the presentation of an honorary membership in the Kiwanis club to Chief Gunners Mate F. R. Duncan, local navy recruiting officer. The 55-year-old concert singer, who maintains a farm near this north Georgia community, said the incident occurred last Saturday and that both he and his wife were placed in a cell after he returned to the store "to rectify any trouble."

Chief of Police Charles I. Harris denied that Hayes was beaten by police and added that a \$50 bond posted by the singer for his release had been returned. Harris said no case had been made against Hayes.

The slightly-built negro said his wife went into a Rome shoe store Saturday to buy a pair of shoes for their daughter, Africa. He said a clerk asked her to

## V-Mail Service Started For Armed Forces Abroad

A special "V-Mail" service for use by relatives and friends of men in the armed forces stationed abroad has been inaugurated by postal authorities, according to Burt E. Hawkins, local postmaster.

V-mail letters will be written on a distinctive combination envelope and letter paper which may be obtained by request at the postoffice. When folded, the face of the "envelope" will bear in large red capital letters "V . . . MAIL" and a place for the sender's and recipient's addresses.

On the opposite side is ample room for a written message and space provided for postal information and the censor's stamp.

Unique feature of the service is the photographic reproduction of such letters in special filming stations in this country, from which the micro-film negatives are forwarded to their destination. There they are developed and 4 by 5 1/2 inch prints made of all letters, which are then delivered individually to the addressees in the usual manner.

The V-mail forms will later be available through regular stations. Hawkins said, since the government is offering them through the postoffice only while the service is being established.

V-mail requires a three-cent stamp for regular service and six cents for delivery by air. Letters written on these forms will be assured of the most expeditious handling, Hawkins said, but he cautioned people to use them only when writing to men in foreign service.

Chief purpose of the V-mail, in addition to assuring individuals faster service, is to conserve shipping space for vital military supplies, he said. For example, the V-mail letters will require only a little over half of the space required by ordinary single-sheet correspondence and will weigh only a little over half as much. It is obvious, he pointed out, that the space and tonnage so conserved will mean that much more devoted to supplies of a nature critical to the war effort.

## CONSERVATION OF TRANSPORT PLANNED HERE

Impetus toward conservation of transportation facilities in for-hire trucking, milk and cream delivery and among the county's farmers resulted from meetings of representatives of these groups on Thursday afternoon and evening with state leaders led by Herman O. Sites, ODT chief for Oregon.

Truck operators were given a detailed interpretation of new ODT orders which were made necessary by the fact that only 60,000 new trucks are available at present as against a normal consumption of about 750,000. These few must be made to last for the duration, whether it be one year or five. Compliance with the new orders, it was said, will practically eliminate competition in the interest of non-duplication of routes, but will make little noticeable difference to the public in service obtainable, at least for some months to come.

The state men were surprised and the local dairy representatives pleased at a report that all Klamath Falls dairies had already cut down the required 25 per cent of their mileage by every-other-day delivery and had consolidated cream pick-up routes among farmers. Each company has also rearranged its delivery routes so as to eliminate duplication of territory.

Duplication in a given area by different companies will continue, however, it was said, for the government has no desire to dictate to the public as to what firm it must patronize. Only drastic need will bring a consolidation along that line, although all local dairies are cooperating in every other way possible. The farm transportation group was represented at the meetings and discussed means of using each truck to its maximum capacity and other related problems.

## PALATIAL CURRIER HOME DESTROYED

MARSHFIELD, Ore., July 17 (AP)—The palatial home of Roy G. Currier, former Los Angeles and Portland medicine manufacturer and founder of Currier's village resort at Lakeside, Ore., was destroyed by fire here last night.

The home was located on an island in Ten Mile lake and could be reached only by boat. Built on lavish proportions, it contained a master bedroom finished entirely in Myrtlewood—a species of wood found only in this section of Oregon and in the Holy Land. The surrounding estate included an aviary, big greenhouses, and large kennels where Currier kept several Great Danes. The kennels had their own kitchen, equipped particularly to barbecue goats.

Reached only by motorboat,

the home was the frequent visiting place of motion picture stars and celebrities of other walks of life. Currier estimated the loss at \$75,000, said he would rebuild when he could. He said the fire apparently started in the basement but the cause was unknown.

## 'HERO' HELD AS ARMY DESERTER

PORTLAND, Ore., July 17 (AP)—A handsome youth who recounted his glowing heroism as an Australian flying officer was held in jail here today under his real name, William J. Smith, 20-year-old U. S. army private from Canton, Ill.

Chief of Detectives John J. Keegan said that Smith, who posed as Flight Officer Thomas Causon, Royal Australian air force, a hero in every United Nations' major engagement from Dunkerque to the Coral sea, was a three-time deserter from the American armed forces.

Additionally, Keegan said, Smith was charged with unauthorized use of American and Australian uniforms and with misrepresenting himself as an officer. Keegan said the youth admitted stealing various uniforms found in his possession.

Smith has been under investigation since July 7 when an interview in a local newspaper described his thrilling war exploits. Keegan said. He said Smith had told his stories at a service men's center here.
