V-MAIL SERVICE WELL ESTABLISHED

V-mail service, inaugurated on June 15, is now past the experimental stage, with each week showing large increases in the number of letters sent in this manner to American soldiers overseas, the post office department has announced.

Stations for microfilming and dispatching messages written on the V-mail forms, obtainable free of charge at the post office, are now in operation for sending letters to the British Isles, Australia, India and Hawaii and soon will be extended to Iceland and other points where volume may warrant it.

V-mail service provides for the use by patrons of a special letter sheet form which is a combination letter and envelope of uniform size and design. The inner or letter side of the forms are photographed on microfilm and dispatched to their destination, where they are reproduced and delivered to the addressee in individual sealed window envelopes. The service has been developed chiefly to decrease the volume and weight of mail so that cargo space on ships and planes may be devoted to vital war materials, as well as to expedite service to the soldiers.

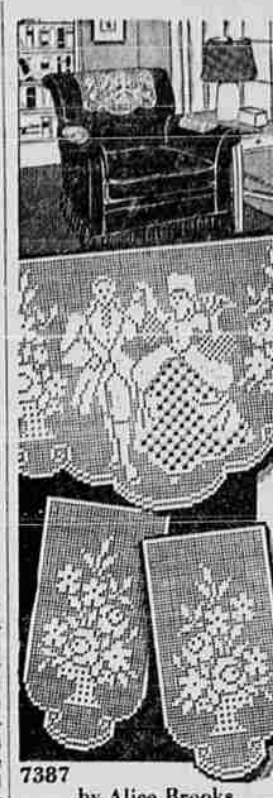
