NOTICE OF CITY ELECTION November 3, 1942

Pursuant to resolution of the Common Council duly adopted by the Common Council on the 1st day of September, 1942, and Ordinance No. 2082 of the city of Klamath Falls, Oregon, duly adopted by the Common Council on the 19th day of May, 1930, and pursuant to the provisions of Section 48 of the charter of said city...

SAME BEING ENTITLED "AN ACT ENACTING A CHARTER FOR THE CITY OF KLAMATH FALLS, OREGON; AND REPEALING ALL FORMER CHARTERS OF THE CITY"; AND REPEALING IN PARTICULAR "A BILL PROPOSED BY INITIATIVE PETITION FOR AN ACT TO ENACT, PROVIDE AND ADOPT A CHARTER FOR THE CITY OF KLAMATH FALLS, OREGON, TO BE SUBMITTED TO THE LEGAL VOTERS OF THE CITY OF KLAMATH FALLS, OREGON, FOR THEIR APPROVAL OR REJECTION AT A SPECIAL ELECTION TO BE HELD IN SAID CITY ON THE 10TH DAY OF MARCH, 1913" AND WHICH WAS DULY ADOPTED BY THE PEOPLE OF SAID CITY AT AN ELECTION THEREIN HELD MARCH 10, 1913; AUTHORIZING AND DIRECTING THE POLICE JUDGE TO PUBLISH NOTICES OF SAID ELECTION, DESIGNATING THE POLLING PLACES AND THE CHAIRMEN, JUDGES AND CLERKS OF SAID ELECTION AND APPROPRIATING MONEY THEREFOR; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE, AND DECLARING AN EMERGENCY.

AT AN ELECTION THEREIN HELD MARCH 10, 1913, PARK BOARD RESOLUTION RESOLUTION NO. 143 A RESOLUTION PROVIDING FOR THE SUBMISSION TO THE LEGAL VOTERS OF KLAMATH FALLS, OREGON, OF THE QUESTION WHETHER OR NOT THE PARK BOARD AS NOW CONSTITUTED SHALL BE ABOLISHED AND THE POWERS, FUNCTIONS AND DUTIES THEREOF TRANSFERRED TO AND BE EXERCISED AND PERFORMED BY THE MAYOR AND THE COMMON COUNCIL OF KLAMATH FALLS, OREGON, PURSUANT TO SECTION 95-1710, OREGON COMPILLED LAWS ANNOTATED, 1940.
