PHYSICAL ED PLAN VOTED AT BOARD MEETING

A physical education program, to embrace boys of the elementary schools and junior high school, was adopted at an adjourned meeting of the board, District No. 1, held Thursday night in the office of Superintendent Arnold Gralapp. The program was presented by Joe Peak, supervisor of physical education. Present plans provide for three nights a week, following school, and Saturday participation in inter-school contests. This program is open to all boys in grades five, six and seven in elementary schools, and grade eight in junior high. During the winter period basketball will be stressed.

Teachers assigned in the city system included Buena Stone, half day at Pelican and departmentalized work, Ora Reading, first grade Riverside, and Mrs. Don Fisher, departmentalized work at Pelican.

Members of the board agreed to send Paul Angstead, junior high principal, to the war emergency conference for school administrators to be held in Salem October 26 and 27. Also planning to attend the high school principals session is Stanley Woodruff of Klamath Union high school. Gralapp will attend the city school superintendents association meeting, to be held with the other three sessions at that time.

CONGRESSMEN HOME FOR CAMPAIGNING

WASHINGTON, Oct. 23 (AP)—Passage of the tax bill has made it possible for some members of the Washington and Oregon delegations to return home to participate in the November election campaigns, while others are remaining on in the capital on account of other pressing legislation. A few are already in their home states.

Of the Oregon delegation, Senator McNary, republican minority leader, said he did not expect to be able to leave the capital and Representative Mott, republican, said he would not go home unless the house recessed. Representative Pierce (D.) and Angell (R.) already are in Oregon. Senator Holman (R.) is out of town on work of the senate military affairs committee.

GROWERS' APPEAL FOR TIRES PROBED

WASHINGTON, Oct. 23 (AP)—The office of defense transportation has scanned appeals of Klamath county, Ore., potato growers for more tires and ordered regional representatives to investigate immediately. This was announced today by Sen. McNary (R-Ore.) who told the ODT that Klamath growers were afraid of heavy crop losses through inability to obtain truck tires. They asked McNary to intercede for them.

Companies to Buy Elk, Deer Hides

PORTLAND, Oct. 23 (AP)—The state game commission headquarters announced today it had authorized five Portland companies to purchase elk and deer hides for conversion to the use of the armed services.

The commission said that anyone wishing to sell a hide should contact one of the firms, most of which have up-state agents. The five are Blessinger & Co., Lee Bros., Hide and Wool Co., Blue Mountain Hide & Wool, Kahn Bros., and William A. Denley Co.

NAZIS RESIST SHACKLING IN PRISON CAMP

OTTAWA, Oct. 23 (AP)—German war prisoners at Bowmanville, Ont., attempted to resist reprisal shacklings on October 10 and submitted only after serious disorders in which both prisoners and guards were injured, the Canadian government announced last night.

Some of the prisoners, a statement by Defense Minister J. L. Ralston disclosed, barricaded themselves in their barracks and refused to obey orders until guards chopped a hole in the roof and sprayed them with a fire hose.

Mild Resistance. One prisoner was wounded in the leg by a rifle bullet and two suffered light bayonet wounds, Ralston said. He described other injuries as mostly of a minor character.

"Mild resistance" to the shackling order was shown at one other camp, but no trouble was encountered at any of the remaining 15 prison camps in Canada, Ralston added.

The shackling order was issued by the Canadian government as a reprisal measure after they had fettered 1375 British officers and men captured in the Dieppe raid August 19. As Canadians made up five-sixths of the army force participating in that action it was assumed that most of those chained by the Germans were Canadians.

No Gas Used. The story of the disorders at the Bowmanville camp was withheld from publication until last night with the object, it was declared, of preventing garbled reports from reaching Germany and giving the nazis an excuse for further reprisals against Canadian soldiers now being held as prisoners of war.

GOVERNMENT OF CITY EXPLAINS PARK MEASURE

A statement relative to the park board measure, to be on the November 3 ballot, has been prepared by the city administration at the request of The Herald and News.

It follows: "There appears to be some misunderstanding as to what the park measure which will appear on the November 3 ballot is attempting to do. At the present time the members of the park board are appointed for life by the circuit judge. This is done through a law which was passed in the state in 1899, and as far as can be learned Klamath Falls remains the only city in the state of Oregon that has continued with this practice of city park control.

"At a meeting of the charter revision committee, that committee recommended to the common council the changing of this park board system and the common council approved this change, and directed the bringing of the matter to the voters at the general election. It was felt that as the matter of the park system is city business that should be controlled in the same manner by the mayor and common council as the matters of the airport, recreation committee or any other city department should be controlled. The manner of appointing members of this board for life is impractical as it would be on any other city committee.

"There is no criticism in the way the present members of the park board have taken care of their duties, as they have really performed a wonderful job in the management of the city park board system. There is no criticism of the present circuit judge as he has complied with the state law in appointing these members for life.

"If the people approve of this change November 3, it is the plan of the council to pass an ordinance which will set up a park board committee through the appointment by the mayor and approval of the council. This committee will function as the various other city committees function. The members of this committee would serve a staggered term of office so as to carry on a continuity of experience and they would be responsible directly to the council and mayor of this city as any city committee should be.

"It is believed the change from the old system is a good one as the presently used plan is outmoded."

NAVY COMMENDS SAILOR'S BRAVERY

WASHINGTON, Oct. 23 (AP)—Le Ray Wilson of Cove, Ore., who helped save his ship from destruction before he was killed, had the commendation of Navy Secretary Knox today.

Wilson, a metalsmith, second class, was a member of a detachment assigned to close watertight doors of the ship during an air attack. The citation read: When the bombers attacked, Wilson and his companions went below, despite the dangers of entrapment, completed their task, and returned to the deck.

PINE ORDERS TOTAL 85 MILLION FEET

PORTLAND, Ore., Oct. 23 (AP)—Orders for Idaho White, Ponderosa, Sugar and associated species of pine for the week ending Oct. 17 came to 85,383,000 board feet, the Western Pine association announced today.

This compared with 85,705,000 for the previous week, 70,771,000 for the same week last year. Similar comparisons of shipments: 79,720,000 board feet, 83,233,000 and 85,037,000. Production: 84,683,000 board feet, 86,015,000 and 82,949,000.

WHEAT

CHICAGO, Oct. 23 (AP)—Liquidating sales caused wheat prices to fall almost 2 cents a bushel at the opening today as the market responded to announcement of a new program whereby ever-normal granary stocks will be released, if necessary, in sufficient volume to keep prices to levels compatible with the ceiling on flour.

Thereafter, the market steadied and rallied at times. Grain men were not certain what ultimate effect this program will have on the futures or spot wheat markets as far as private trading is concerned but there was agreement that strict government control of prices is now a reality.

Wheat closed 1-13 cents lower than yesterday, December \$1.24-1.24 1/2, May \$1.26 1/2-1; corn 1-1/2c higher, December 80 1/2c, May 85 1/2c; oats unchanged to 1c up; rye 1-1/2c lower; soybeans unchanged to 13 cents higher.

STOCK MARKET TURNS TIMID AFTER RISE

By VICTOR EUBANK. NEW YORK, Oct. 23 (AP)—The stock market turned a bit hesitant in today's late dealings after an early swing had landed selected Rails and Industrials in new high ground for the year or longer.

The fact the Associated Press 60-stock average, for the third time in the past two weeks, established a triple-top Thursday at a new peak since last November, and was unable to keep going, served to chill technical forces to some extent. To many chartists this was a signal for caution. Sales were around 700,000 shares.

Erie directors voted another 50-cent dividend on the certificates and common but quick profit taking shoved both issues into the minus column.

Resistant stocks included N. Y. Central, Union Pacific, Canadian Pacific, Northern Pacific, Southern Pacific, Southern Railway, Sears Roebuck, U. S. Gypsum, Douglas Aircraft, Goodyear, Homestake Mining, McIntyre Porcupine, Du Pont and Johns-Manville.

Bonds were steady, Secondary Rails maintaining popularity.
