When the fight was over the bombers—without a single loss—had knocked down 10 of the enemy planes and so greatly damaged four others that they probably were unable to reach base.

Crittenden, who as director of the rent control office in this district was made the direct target of the dissident landlords' complaints, brushed off the suggestion there was any concerted support behind the Vallejo movement. "A few are disgracing that fine city by following an apparently well-organized campaign to discredit the law," he said in a statement. "They say they will refuse to abide by the rules adopted by congress. They will rise above the law. Such action would be reprehensible in peacetime. In time of war it is, to use plain language, 'subversive conduct.' It should be regarded as such."

British military sources in London said it did not mean that the westward offensive again was under way. Allied Mastery In Tunisia, the allies and Germans both were reported probing cautiously for weak spots and speeding preparations for the decisive battle. Reports of allied air blows, both destructive offensive smashes and successful defensive air fighting with evidently plentiful and well-varied warplanes, indicated that air mastery was swinging back to the allies. Nazi Convoy Hit When the British and Americans closed virtually to the thresholds of Tunis and Bizerte, their drive was handicapped by the lack of adequate air bases close to the front. Now, however, Associated Press reports tell of ground commanders telephoning for air coverage as casually as calling for a taxi. Again, British headquarters reported that allied twin-engine fighters—probably American P-38 Lightnings—had pounced on an enemy air convoy northbound from Africa and had shot down two German transport planes near Lampedusa island, between Sicily and Tunisia.

Meat Packers Case Settled

PORTLAND, Dec. 10 (AP)—The OPA's case against four Oregon meat packers was settled before Federal Judge Claude McCulloch today by stipulation. All beef and veal must be graded by inspectors of the agricultural marketing administration, the judge held. It was explained that such grading had been in effect in the four plants—Swift's, Singer Bros., Herman Kowals, Portland, and Pauley Packing, Klamath Falls, for several weeks. The stipulation, from which the judge will write the decree, is made specifically for Swift's but will cover the other three. It further restrains the company from slaughtering at the Portland plant any beef or veal subject to the maximum price regulations, unless approved by AMA inspectors.

A circuit court jury late Wednesday returned a verdict which denied damages to both parties in the accident case of E. A. Vanderhoef and Clive Brandon against Lewis Hornsby. The case grew out of a crash on the Weed highway near the Kaipine turn-off on October 6, 1941, involving two cars and a big truck loaded with apples and operated by Vanderhoef and Brandon. They sued Hornsby, driver of one of the cars, for \$2800, the value of the truck. Hornsby counter-claimed with a claim for \$15,000 plus medical expenses. The jury, after hearing evidence all day Wednesday, returned a verdict finding in favor of the defendant upon the plaintiff's complaint and in favor of the plaintiff on the defendant's counter-claim. Japs Building Army in Malaya, Charge Chinese

CHUNGKING, Dec. 10 (AP)—A Chinese military spokesman charged today that Japan was building a native army of 150,000 men in French Indo-China with the cooperation of the Vichy French governor-general, Rear Admiral Jean Decoux. Trained and commanded by Japanese officers, the Indo-China native force might be employed by the enemy in a campaign against China's vital "back door" province, Yunnan, the spokesman indicated. He said Admiral Decoux, yielding to Japanese pressure, agreed to authorize the conscription of 150,000 natives, and the Japanese were carrying out the project.

Nazis Reveal Shake-Up in General Staff

BERLIN (FROM GERMAN BROADCASTS), Dec. 10 (AP)—The Berlin radio broadcast a Transocean agency dispatch today which said that "for the first time the public has learned that Infantry General Zeltzer is chief of the general staff of the army." (The Nazi regime apparently took this unusual means of making the first authorized announcement of an important change in the German high command, reports of which have been reaching the outside but never with Berlin's confirmation. (The post given Zeltzer formerly was held by General Franz Halder, who has been mentioned as one of several army leaders who are believed to have fallen under Hitler's displeasure and been marked for a "purge.")
