## STOCK MARKET FALTERS AFTER EARLY ADVANCE

NEW YORK, Jan. 12 (AP)—The stock market faltered today after a moderate early advance confined principally to selected issues.

Prices and activity were the best at the opening when blocks of 1000 to 6000 shares changed hands with gains of fractions to a point or so. Transfers were around 700,000 shares.

A break in major commodities when the OPA froze corn prices at yesterday's highest levels tended to cloud the bullish stock picture. Wheat and cotton futures recovered part of their forenoon losses.

Boardrooms saw a constructive indicator in the fact that virtually all of a special offering of 56,724 shares of Texas Co. at 43 was almost immediately sold. It was the largest "special" in dollar value since such transactions were inaugurated on the stock exchange last February.

CHICAGO, Jan. 12 (AP)—All grain prices recorded substantial losses today following an office of price administration announcement placing ceilings on corn futures, effective tomorrow, at the highest point reached yesterday.

Trading during the early part of the session was highly confused, corn breaking more than 2 cents and wheat more than 4 cents. At times actual prices in the pits were well out of line with quotations posted on the blackboard.

During the latter part of the session, however, prices stabilized and trading quieted as grain men showed an inclination to await further developments.

Corn finished 21-21c lower, May 97-97c, July 97-97c. Wheat was off 21-21c, May \$1.381-1, July \$1.381-1, oats dropped 11-11c, rye declined 11-11c, and soybeans were 11c lower.

## WEST COAST LUMBER PRODUCTION TOLD

SEATTLE, Jan. 12—The West Coast Lumbermen's association today reported the weekly average production of west coast lumber for the 52 weeks of last year was 166,327,000 board feet compared with 166,232,000 in 1941. The 1942 cumulative production was 8,752,998,000 board feet, virtually the same as 1941's 83-week work year.

The December weekly average was 118,316,000 board feet, or 61.3 per cent of the estimated capacity.

Orders for 1942 aggregated 9,647,734 board feet; shipments were 9,359,175, and the unfilled order pile stood at 1,056,769,000 board feet at the end of December; gross stocks at 497,172,000.

## DELINQUENCY IN PAYMENT OF TAX CHARGED

Judgments against 43 local people who failed to pay their 1942 state income tax or to file a return will automatically become effective immediately, according to L. R. Schoettler, adjutant for the state tax commission.

Many of the warrants which have been issued include men in service, who believe that they are automatically deferred upon entering the armed forces. This, however, is not the case, according to Schoettler. It is necessary for the individual or his representative to file notice of his intention, and to ask for deferment which will then be granted.

## Names Listed

According to the state law, if the tax is not paid within 30 days after it becomes due, the commission may issue a warrant directed to the county sheriff, who in turn files it with the county clerk. It then becomes a judgment, and a lien against the title to any interest in real property or personal property that the taxpayer may have. By paying the tax and an additional penalty plus costs, the individual may remove the judgment. The following names are included:

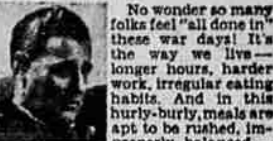
## Klamath Looks Ahead to Victory Garden Planting
