SCREEN STAR TO BE SENT TO REST HOME

LOS ANGELES, Jan. 20 (AP)—Instead of six months in the county jail, Screen Actress Frances Farmer will be placed in a sanitarium to rest and receive medical care.

This was decreed today by Superior Judge Dudley S. Valentine after a brief sanity hearing.

The blonde actress was calm and smiling graciously. "She's a sick girl and needs quiet and rest," testified Mrs. Genevieve Dodge, chief probation officer of the county psychopathic ward, the only witness. "She has great talent."

Miss Farmer was released in the custody of the probation officer, Mrs. Dodge said she has been informed the motion picture relief agency will pay for the actress' stay in a sanitarium, if necessary.

Before the hearing the actress had been under sentence of six months in the county jail for violating probation in a drunk driving case. Police charged that, during a 24-hour rampage last week, she punched a hairdresser, resisted arrest and denounced various authorities in strong language.

RATION BOARD EXPLAINS TIRE CHECK-UP RULE

The war price and rationing board here called the public's attention to rules concerning tire inspection, with the comment that there has been some misunderstanding of this matter.

Following was the rules cited: Thorough inspection required. No inspector may certify any fact concerning the condition of a tire or tube without a personal and adequate inspection to determine such fact, and no inspector shall certify that a tire can be recapped unless he removes the tire from the wheel or rim. The board may in its discretion require an additional inspection and certification by an inspector named by the board.

Schedule of fees for removing and replacing tires—
Type of tire:
(1) Passenger car, tires, each, 50 cents.
(2) Small truck tires (750-20 or smaller) each, 75 cents.
(3) Large truck tires (larger than 750-20) each, \$1.00.
(4) Additional charge for removing inside deal truck tires (larger than 750-20) 50 cents.

Madge Bellamy of Silent Films Admits Firing Three Shots at Lumber Executive

SAN FRANCISCO, Jan. 20 (AP)—Once famed Madge Bellamy of the silent films went free for the time being on \$500 bail today after solemnly promising a municipal court judge she would not again shoot at or molest the man she says jilted her for another, A. Stanwood Murphy, 54-year-old lumber company executive.

Judge Chester Morris granted continuance of a week before arraignment on the charge of assault with a deadly weapon.

Freely the brown-eyed actress admitted she had waited for Murphy last night behind the exclusive Pacific Union club on Nob Hill, and fired at his car "to scare him."

TEACHERS ASK BILLS TO CLEAR CERTIFICATION

SALEM, Jan. 20 (AP)—The State Teachers association asked the house education committee today to introduce bills to make simpler the certification of teachers to meet the teacher shortage, boost minimum salaries of teachers from \$750 to \$1332 a year, and provide a social security plan for teachers.

The committee agreed to introduce amendments to clarify mechanics of the bill approved by the people last November to distribute income tax surplus to schools in order to reduce property taxes of school districts. It was estimated that \$4,500,000 would be available this year.

SALEM, Jan. 20 (AP)—More than 20 church and private school leaders arrived here yesterday to fight a bill by Rep. Giles French, Moro, which would force private schools and churches to pay property taxes. They contended that the bill would force some small colleges to close and work a hardship on churches.

SALEM, Jan. 20 (AP)—State headquarters of the Women's Christian Temperance Union wrote all legislators today it would oppose any move to use liquor revenues to support education.

DAUGHTER BORN TO RULERS OF NETHERLANDS

OTTAWA, Jan. 20 (AP)—Crown Princess Juliana of the Netherlands gave birth to her third daughter last night, a seven pound 12 ounce princess for whom a little bit of Canada was proclaimed a little bit of Holland so that she need not be born on foreign soil.

The four-room hospital suite was declared by the dominion government extra-territorial for the confinement period. For all that, the little princess was the first member of the Royal House of Orange to be born outside The Netherlands and she is the first member of any European royal family to be born in North America.

Afternoon Ceremony
Her father, Prince Bernhard, announced that "she looks splendid." He came from London last week to be here at the child's birth.

Today the little princess was to be given her name and registered with The Netherlands consul general, J. P. Luden, as a Netherlands citizen, in an afternoon ceremony.

Queen Wilhelmina in London, was expected to travel to Canada for the child's christening at some future date. She was notified by the father after the child's birth.

A son to the 33-year-old crown princess would have become automatically her heir to the throne. With the birth of a third daughter, the succession remains unchanged. The Princess Beatrix, who will be 5 on January 31, is next to her mother in the throne succession. The second princess is Irene, aged 3.
