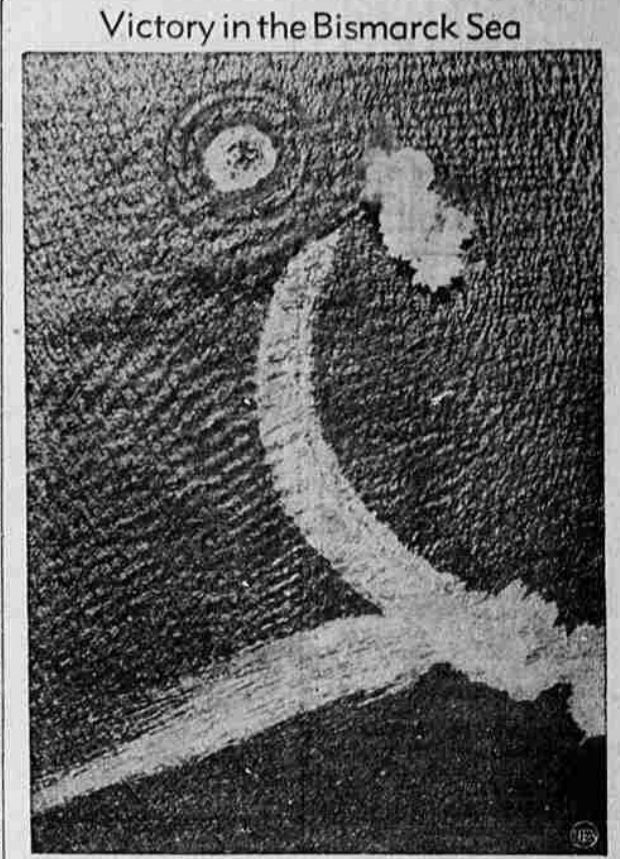

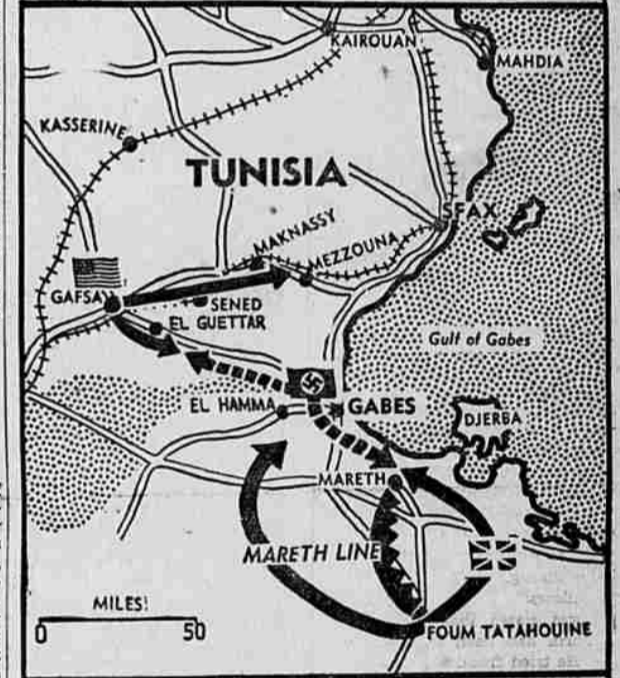

Where Tunisia Battle Rages



Swiftly moving forces are attacking and counter-attacking in a climactic battle for southern Tunisia. Along the Nazi-held Mareth Line, Axis counter-blows have beaten back the British Eighth Army, which had made a break-through between Mareth and the Gulf of Gabes, while at the lower end a sweeping British movement threatened to encircle the enemy as it turned toward Gabes, south of El Hamma. In the central sector two American drives continued against Mezouna and Gabes despite increasing pressure of German and Italian units.
