## Today's Roundup

**K**LAMATH'S surgical dressing program made a new local record in May, but the county still has not attained the quota assigned to it for any one month. There has been a steady increase in bandage production since last December, until the May total hit 50,491. That is good, but not good enough.

We've harped quite a bit on this subject for two reasons. The first is that surgical dressings are badly needed by the Red Cross for treating the wounds of our fighting men. That production such as has been going on here is necessary has been conclusively shown in information sent here by Red Cross authorities.

Another reason we plead for the surgical dressing cause is that we are sure those who give wholeheartedly time and effort to this project are going to be well repaid in the satisfaction it brings to them.

It is good war work. When you have finished a well-made dressing, you feel as if you had done something real and worthwhile. And that, in turn, is good for the morale of the people.

## News Behind the News

**W**ASHINGTON, June 11—Criss-cross currents of politics are running behind the Bailey resolution designed to limit presidents hereafter to two terms.

It grew out of a strange situation. Republican Senator Wherry (Nebraska) was talking about such a resolution when along came Anti-New Deal Democratic Senator Bailey (North Carolina) with a proposal that they get together.

Polls have been taken, indicating that they now have more than 55 votes in favor of submitting a constitutional amendment to the states. Even some of the new deal senators indicate favor.

It would have no effect on the fourth term campaign, as it could not be enacted in time. Only a few state legislatures (some say three) meet next January.

Therefore, the issue wholly concerns a fifth term, or some future republican or democratic president getting a third one.

Consequently not much interest has been aroused, and it is not likely that the matter will be seriously considered before fall.

## Big Banner

**T**HE old Fort Klamath flag was found to be too big to be flown from the Elks lodge flagpole for the Flag Day services Monday evening, and instead will be hung from the front of the building.

This banner is 20x10 feet in dimensions. Whipped by a southeast wind, it could conceivably strike the top of the Elks temple, and it was decided not to take such a chance.

That is just as well, because the flag would not be so well displayed from the flagpole as from the front of the building where it will be draped directly over the steps where the ceremonies are to be held.

It was a stroke of good fortune that brought this interesting old flag back to the Klamath country after 50 years or more in storage somewhere else. It was presented to Chamber of Commerce Secretary Earl Reynolds by the Misses Laura and Elizabeth Carpenter of Verona, N. J., daughters of Captain Gilbert Carpenter, last commanding officer of the fort in 1889.

First modern display of the flag to the public is most appropriate for the Flag Day ceremonies Monday evening.

Mr. Reynolds no doubt will be willing to lend the old fort flag for a permanent place in the Klamath county museum, or elsewhere where it can be displayed to keep alive the memory of Klamath's pioneer army post.

## Reber Decoration

**G**ENERAL S. M. CONNELL, who will come here to present the Air Medal to Mrs. John Reber in honor of her son, Captain Ehle Reber, came on a similar mission last year when he presented a decoration to the parents of Sergeant William Dieter at Tulelake.

The Reber presentation will be made immediately before the ritualistic ceremonies at the Elks public Flag Day exercises under the old fort flag.

General Connell is commanding officer of the fourth bomber command, San Francisco. He will probably fly to Klamath Falls.

Captain Reber is one of Klamath's valiant sons who has fought the good fight for this country over Europe. He was reported missing some months ago. It is our hope that Captain Reber, like many others who have been reported missing, will turn up one of these days. Meanwhile, his mother will receive and keep the decoration of honor he earned.

## Rail-Sitters

**R**AIL-SITTING congressmen, closely watching the writhing of OPA's Prentiss Brown to reorganize his administration, judge he will not make the grade for one insurmountable reason.

Much of the personnel in OPA claims to have the personal backing of either Supreme Court Justice Frankfurter, Mrs. Roosevelt, or Harry Hopkins. Any administrator attempting to clean such a house is apt to get himself cleaned first.

## Willkie Folk Active

**A** REPUBLICAN political scout (Wherry of Nebraska) is back from a six-state midwestern off-the-record, trip. His associates learn he found the Willkie people already working very actively for '48. Few state or city organizations are for Willkie, and his workers are mostly independents. (An anti-Willkie congressman estimates 25 per cent of the republican party is pro-Willkie today.)

Ohio's Governor Bricker has failed to attract much party attention, Wherry found. Bricker does not make startling statements or present the photogenic personality appeal usually associated with political candidates by the experts. New York's Governor Dewey is supposed to have this appeal, but faces other intra-party drawbacks.

The party is discussing Senator Taft and others it calls "good men," but obviously there is no beginning of agreement on a candidate. A year of developments, including the primaries, will settle the dust before nominations are made.

## Appeasement

**T**HE administration is energetically trying to appease dissident southern elements and, at the same time, pursuing its negro development policies.

The Louisiana senators have heard directly from the White House that they have won their fight against a Texas appointee to the circuit court, and that a Louisianian will be named. A Mississippi democrat also has been appointed to the secretaryship of the democratic national committee.

At the same time, the Liberia president and staff have been entertained auspiciously at the White House, and a Catholic priest has been appointed by Mr. Roosevelt to head the fair employment practices committee, through which negro political organizations have been working to attain what they call equal working opportunities.

This will probably be sufficient to keep the southern politicians in line for the fourth term.

**KLAMATH FALLS, Ore. (To the Editor)**—Have been waiting for quite some time for some man or woman to make a reply to the remark made by a high school student in the Japanese internment camp at Newell, Calif., just out of Tulelake. But it seems no one is interested enough or does not have the time to make a reply, so a poor, ignorant old logger will say what he thinks about it.

It seems to me that if he, or they (the Japanese) are as good citizens as he intimates they are that they would obey the law as the balance of us are doing, without protest, for if they were prisoners of war or enemy aliens in any other country in the world they would be behind barbed wire and every ounce of food and clothing strictly rationed, if they were not taken out and shot, as a lot of them deserve to be.

To be able to belong to one of our secret societies, one must swear to "subscribe to and abide by the laws of the country in which we live," and an alien should be more than careful, and circumspect in both his language and his actions when he is in an enemy country, especially with the feeling against all Japanese what it is in this country today, for a lot of people are sore and critical because the people of that nation are better treated than are people of our own country.
