

Flag Unlawfully Displayed, Reported

WASHINGTON, Jan. 24 (AP)—The White House referred to the war department today a complaint that a flag was displayed in an unlawful manner at the inauguration last Saturday.

The protest was made by Gridley Adams, chairman of the national flag code committee. He wrote Mr. Roosevelt that the flag was "disgraced" when it was placed below the speaker's stand.

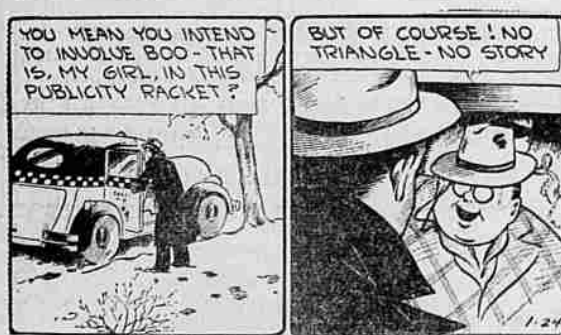
