FOOTPRINTERS WORK REVIEWED BY PRESIDENT

Work of the International Footprinters association in promoting good will and understanding between peace officers and laymen was reviewed last night by the international president, Michael Strazzo of Sacramento, at the northern California-southern Oregon post-war conference of the association held at Cal-Ore tavern. More than 200 were present.

Strazzo said that individual chapters had done a great deal of work in behalf of war veterans, service men, juveniles, and peace officers whose families had met with misfortune.

Gordon Garland, former California legislator and head of the department of motor vehicles of California, paid tribute to private enterprise as a basic principle of the American system, and said that it had a key part in the winning of the war. Gordon brought official greetings from California to Oregon.

Several Klamath Falls men spoke, including Colonel George O. Van Orden of the Marine Barracks, Major John Hazlett of Camp Tulelake, Lieutenant John Lynch of the air station, Circuit Judge David R. Vandenberg, and Sheriff Lloyd L. Low. The Klamathites were introduced by Sgt. Earl Tichenor, president of the Klamath Footprinters chapter.

Judge Vandenberg said that Klamath's experience had shown a minimum of civil law violation by men of the armed services, and that the court had had excellent cooperation from the camp administrations.

and better post-war world will be to STAMP OUT indoctrination to the last ember.

THERE is nothing significantly new in the Pacific, where we're still burning out holed-up Japs in STRATEGIC islands. MacArthur reports today that in the past week we've killed 10,000 of them at a cost of 584 American lives.

THERE is an interesting slant in the European news today. The Germans appear to be releasing PROMINENT hostages. Old Pelain enters Switzerland from Germany, and says he's headed for FRANCE to stand trial as a collaborator. His trial is due to begin May 17. Adherents of the French De Gaulle government are quoted today as thinking he'll be convicted and SHOT, as otherwise the war gull trials of his Vichy subordinates will collapse on the wholly-human basis of "why shoot the little guy when the big one got off?"

Laval showed up this morning at the borders of Liechtenstein (another of these little European Graustarks), but was refused entrance. King Leopold of Belgium is expected to arrive in Switzerland before nightfall.

THE French admit candidly that if Pelain arrives in France for trial it will be embarrassing—as about all they can do with him is to shoot him,

and there are still quite a few Frenchmen who remember him as the hero of World War I and think of him now as a misguided old man who meant well.

Still guessing, one suspects that the nazis may be releasing these hostages to create JUST SUCH SITUATIONS throughout Europe. The more ruckuses they can inspire, the better off they'll be—or think they'll be.

PLEASE remember that this column today is guesswork from start to finish. It has no standing whatever in FACT. When we aren't told, we Americans just have to guess. It may be miles from the truth. The nazis bigwigs might even SURRENDER at the last moment, thus simplifying the whole end-of-the-European-war business. Anything could happen.

\$30 MILLION FOR RECLAMATION ASKED

WASHINGTON, April 24 (AP)—The reclamation bureau should be given more than \$30,000,000 to increase the productivity of western lands, the house appropriations committee said today.

The amount, recommended in the 1946 interior department budget, is \$6,000,000 more than was given the bureau last year.

Projects, with the 1945 appropriation in parentheses: Boise, Idaho, \$100,000 (\$50,000); Minidoka, Idaho, \$70,500 (\$77,000); Owyhee, Oregon, \$200,000 (\$189,000); Klamath, Oregon-California, \$118,000 (\$126,000).
