WHEAT

CHICAGO, Sept. 7 (AP)—Grain futures sagged in late transactions today, with wheat more than 1 cent a bushel in some cases and other grains falling fractionally. Trade was very light.

Government purchasing tended to restrict selling in wheat and oats, but liquidation apparently was heaviest. Nearby deliveries were up in early trade on short-covering, but prices later fell with the distant contracts.

Data shipping sales were estimated at 100,000 bushels.

Wheat closed unchanged to 1/2 cent lower than the previous finish, September \$1.67 1/2, corn was off 1/2 to 1/4 cent, December \$1.14 1/2, oats were 1/4 to 1/2 cent down, September \$1.00 1/2, and barley was 1/4 cent down to 1/2 cent, September \$1.00 1/2.

ESKIMO HANGED AT STATE PEN FOR MURDER

WALLA WALLA, Sept. 7 (AP)—Joe Bill, Alaska Eskimo convicted for the murder of five-year-old Irma Irene McGough of Seattle April 12, calmly entered the scaffold room at the state penitentiary at 1:00 a. m. this morning and was hanged at 1:08. He was pronounced dead at 1:25 p. m.

"All I wish is that most of the young men I am leaving behind will benefit by my mistakes that I made all through my life and especially this one," he said in his last statement. "I hope to God that He forgives me."

Bill was convicted in June for the slaying. The McGough girl was returning from a neighborhood grocery when he attacked her and left her body in a storage bin at the temporary family home where it was found later. After hiding several days, Bill surrendered himself to Seattle police. At no time did he claim innocence of the sex slaying.

Though at times he displayed signs of nervousness, Bill remained calm until he was hanged, spending most of his last few days reading the Bible and consulting the Very Rev. John J. Callahan. His wife visited him the last time Thursday morning and made a final appeal to the governor for stay of execution and commutation of sentence during the day.
