All applications must be mailed in to the war price and rationing board, and not presented in person.
PROCESSED FOODS
BLUE STAMPS—No longer rationed.
RED S-T-A-M-P—Ration book 4—Stamps U-2 through U-22 are valid through August 31. Stamps V-2 through V-22 are valid through September 30. Stamps A-1 through A-12 are valid through October 31. Stamps F-1 through F-12 are valid through November 30. After these, green stamps will be used. There will be no Ration Book 5.
SUGAR—Ration book 4—Stamps U-2 through U-22 are valid through August 31. Stamps V-2 through V-22 are valid through September 30. Stamps A-1 through A-12 are valid through October 31. Stamps F-1 through F-12 are valid through November 30. After these, green stamps will be used. There will be no Ration Book 5.
SHOES—Book 3—Airplane stamps 1-2-3-4 are valid through August 31. Stamps 5-6-7-8 are valid through September 30. Stamps 9-10-11-12 are valid through October 31. Stamps 13-14-15-16 are valid through November 30. After these, green stamps will be used. There will be no Ration Book 5.
STOVES—No longer rationed.
FUEL OIL—No longer rationed.
GASOLINE—No longer rationed. Keep mileage rationing record and gasoline book to use in making tire applications.
