CITY FATHERS DECREE DEATH FOR POPLARS

City councilmen last night decreed death by the axe for poplar trees on Pine street between Fourth and Fifth.

They approved a letter sent by City Engineer E. A. Thomas to the California Oregon Power company ordering removal of the trees. Copco owns the adjoining property, and was told that if it does not remove the trees, the city will do it and charge it to the property.

The company can have a hearing on the matter any time within the next 30 days. City official policy is to frown on poplar trees as a threat to sidewalks, sewer mains and other installations.

Elks Offer Ambulance
The Klamath Falls Elks lodge, which owns an ambulance, offered it to the city for use as an emergency car again last night. E. B. Hall, trustee of the lodge, said that the ambulance is available as a result of the dissolution of the Oregon Women's Ambulance corps. The Elks, he said, had been informed that a garage for an emergency ambulance is planned in connection with the new city-county jail, and perhaps the Elks ambulance will be used for that purpose. In the meantime, he added, the Elks would be willing to turn it over to the city as a police ambulance.

Hall pointed out the city had turned down such an offer once before. "I'm just suggesting it this time," he said. "We don't want another rebuff."

It was recalled that the city turned down the previous offer because of lack of manpower to operate the ambulance. Councilmen last night referred the matter to the police committee.

Signal Repaired
City Engineer Thomas told the council that the traffic signal system on South Sixth and East Main streets has undergone repair and should be operating properly soon. The city has received complaints that the traffic-motivated signal system was not working.

Mayor Ostendorf said that the dog commission wants to move a house owned by the city in the Veterans Memorial park area from there to the dog pound on Cumberland road. He said it will cost about \$1000 to move the house, which will have to be cut in two.

It was brought out that the dog commission has already spent \$300 in moving another house to the same property, but now finds it inadvisable to use this house.

Councilman Cantrall suggested the matter be turned over to the street committee for consideration to be sure that the dog commission has its plans matured before it spends more money.

DEFENSE COUNCIL TO BE ABOLISHED

SALEM, Oct. 23 (AP)—Oregon's State Defense Council, created June 1, 1941, will be abolished December 31. Governor Earl Snell announced today.

Created by former Gov. Charles A. Sprague, the council directed and coordinated the efforts of the 36 counties in many of the most important home-front efforts of the war, the governor said.

"Throughout the past four years," the governor said, "outstanding records have been established in the fields of defense, nutrition, salvage, child health, children's care and welfare, victory gardens and young peoples' participation in wartime activities."

There is strong sentiment in favor of bringing all our armed forces under one command—and the sooner that command is "go on home" the better the boys will like it.
