LONDON, Dec. 3—Another monarch will have joined the swelling ranks of the royal unemployed if Albania's general election of yesterday bears out its promise...

I've spent considerable time in the Balkans and my observation has been that most—not all—of the thrones were superimposed on a feudal system which has survived through the centuries.

Sins of Omission
This isn't necessarily a reproach to the king, excepting that he might have used his power to change an evil system of serfdom.

So if the upsetting of the Balkan thrones means that the feudal system is on its way out, and that a real democracy may in due course be found...
