News Behind The News

WASHINGTON, Dec. 12—The defense of the British loan deal is that there are only three things which can be done with the British: A—Prop them up.

Again, they agree to discuss a new, de luxe, super Bretton Woods arrangement to create a world trading and monetary system; they agree to work with us for this "international trade organization" at a world conference next year.

Again they promise to pay perhaps \$750,000,000 in settlement of the "lend-lease" (how ironical those two words sound now) but only \$50,000,000 is to be cash within five years, and we will not take this money, but will use it to build educational or other institutions in the British Empire.

Legal Escape

THERE is hardly a line in this agreement which is not hedged thus with a legal escape. For this, we are to throw \$3,750,000,000 more after the \$25,000,000,000 of "lend-lease" we are cancelling off—thus giving them title to remaining planes, guns, trucks, typewriters and what not, without trying to get the materials back for scrap or use.

They have no raw materials on their island except coal. They cannot produce without raw materials, and they cannot pay for the materials except by production.

What Could We Do?

BUT what could we do? The Byrnes people are already asking the senators in private. The senators are saying we could have taken title to the equipment we have given them and used it for storage against the future or scrap; we could have taken payment in materials of which our own stock piles are low; we could have acquired territories needed for raw materials and for civilian and military world air bases.

In short, we could have reached a fair and good business settlement "in kind," and closed the books on this endless dumping of the product of our toil into Britain these last 30 years. We could have reached a final settlement.

As it is, we have left the books open, to furnish more money when this "loan" is gone and cannot be repaid—money which really represents the sweat of our workmen, because our treasury has no "money" except as it drains that source.

We could wisely have prepared ourselves with territory, stock piles and power for a new barter world of trade (which is coming as surely as borrowed international money is never repaid). We could have won the peace with this deal.

The Byrnes people come back and say: We have thrown \$250,000,000,000 into this war, without taking anything but world's headaches. What is \$3,750,000,000 more? The deal is done now. Take it or leave it.

As I say, I think congress may take it, but not enthusiastically.

The World Today

LONDON, Dec. 12—The heavy increase in divorce in England represents in large degree the opening of the floodgates to the accumulation of grievances between the soldier overseas and his missus back home.

We don't need to mince words. There's been a lot of unfaithfulness on both sides. The majority of the petitioners are soldiers but this certainly doesn't mean that the wives have been more unfaithful than their men.

Tommy Atkins sometimes has a naive outlook on this sort of thing. For instance, many married soldiers don't consider that they've committed adultery by associating with an unmarried lady of professionally easy virtue. You get that slant on the young man in the divorce court.

Before his case comes up for trial, Tommy likely will swear to his attorney with great fervor that he hasn't committed adultery. This is an important point in English law, because if a petitioner is guilty of misconduct, and doesn't make it known to the court in advance, the case is thrown out. Well, Tommy gets on the stand and his wife's lawyer demands:

"Do you mean to swear that you haven't had any relations with a woman since you've been overseas?"

To this the astonished young man retorts: "Of course I've had relations with women. Who hasn't? But that isn't adultery so long as they aren't married."

It then takes a powerful lot of explaining to make Tommy understand that he has violated the law just as much as has his wife whom he is suing. This means that his case will be dismissed unless the court gives leave to amend the petition.

Mrs. Mac and I have dug deep into the reasons for the increase in divorces, and the chief cause probably has been the protracted separation necessitated by the husband's duty overseas.

This has been a long war, and the soldiers have been away from their wives in most cases

between 40 and 48 months without leave at home. And there have been more men in foreign service than ever before in British history.

Naturally this has contributed to immorality. It has given more chance for playing about. Probably if there had been no separation there would have been no divorce.
